NICOMEN DYKE GIVES WAY INUNDATING FRASER VALLEY FRUIT LANDS

Four Sections Rich Agricultural Land Completely Flooded

VICTORIA, June 13.—Two thousand five hundred acres of the richest agricultural land in the Fraser Valley, planted in berries, small fruits and other crops, was inundated yesterday afternoon when the Nicomen Island dykes gave away just as the torrent of high water on the Fraser River was about to ebb. Thirty-five settlers, mostly returned men, who suffered to a smaller extent last year through the same cause, have been driven off their farms by the floods.

GETTING READY FOR FISHING TO THE SOUTH

Inspector J. T. C. Williams returned yesterday from a trip to the southern portion of the district. The inspector reports everything in readiness for the sockeye season which opens on June 29. In the Rivers Inlet and Bella Coola divisions large numbers of fishermen are applying for gill net licenses. In Bella Coola district the spring salmon fishing commenced early in May. Large quantities of this variety of fish have been taken and this year's pack will almost double that of last year.

FISHERIES COMMITTEE SENDS INFORMATION LONDON PUBLICATION

Ald. Dybhavn Prepares Set of Data and Photographs for "The Graphic." Ald. John Dybhavn, as chairman of the fisheries committee of the Board of Trade, has submitted an interesting set of data accompanied by photographs, on the local fish industry to the London illustrated weekly, "Graphic." This action was taken in view of a recent highly illuminated article which appeared in that publication describing the halibut fishing of British Columbia and giving prominence to Vancouver, Victoria and New Westminster therewith but not making a single mention of Prince Rupert, the port which has now become the headquarters for the halibut fisheries of the entire Pacific coast from the Aleutian Peninsula to the Columbia River.

HIGH WATER DAMAGE TO P. G. E. RAILWAY

Section of Wharf at Squamish Again Succumbs to River. VICTORIA, June 13.—High water and swift currents have again attacked property of the Pacific Great Eastern Railway. This time piles and part of the terminal wharf at Squamish, southern end of the line, have been washed away by the Squamish River. A large amount of repair work will be necessary, according to information which reached the Parliament Buildings here. This is the second time that the river has washed away part of the wharf. "We will simply have to divert the channel of the river," said Premier Oliver. Being forced to this step did not please the Premier, as it will mean an increase of the Government's heavy outlay on this railway.

FOREST FIRES SO FAR THIS SEASON

There Have Been 158 in Entire Province—Thirty in Prince Rupert District. VICTORIA, June 13.—Forest fires in British Columbia so far this season number 158. They are distributed as follows: Vancouver Island, 37; Nelson, 19; Vernon, 2; Kamloops, 28; Cranbrook, 11; Cariboo, 11; Prince George, 20; Prince Rupert, 30.

RIOTING AND FIRING TAKES PLACE BELFAST

Renewed Attempts Being Made to Hinder Visit of King Next Week. BELFAST, June 13.—Rioting, accompanied by heavy revolver and rifle firing, was renewed in the Clifford Street area today. It is believed that the rioting was organized by the Republicans with the purpose of preventing the visit of King George to Belfast on June 22 to attend the state opening of the Ulster Parliament.

ARAB RULER MESOPOTAMIA

Announcement Made in British Commons for Government of Asia Minor Country. LONDON, June 13.—The British Government intends to replace the administration in Mesopotamia with an Arabian assembly and Arabian ruler during the coming summer, according to an announcement by the Right Hon. Winston Churchill in the House of Commons. The ruler will be elected by a popular vote of the people.

UNION HEAD BIG ROBBERY

Timothy D. Murphy, President Chicago Gas Workers, Put Under Arrest. CHICAGO, June 13.—Timothy D. ("Big Tim") Murphy, president of the Gas House Workers Union, is under arrest today charged by the postal inspectors with having planned a \$350,000 mail robbery at the Dearborn Street Station several months ago. There was found in his father-in-law's home \$98,600 in Liberty Bonds and \$14,000 in cash. It is understood that Murphy has confessed.

SEVEN PERSONS ARE DEAD IN CLOUDBURST

Torrents Still Continue to Fall in South Central States. SAYRE, Oklahoma, June 13.—Seven persons were drowned in a flood following a cloudburst here. The same heavy rains that caused the recent Colorado catastrophe are still continuing.

AUSTRALIA BEATS ENGLAND.

Postponement of the opening of the conference until next week has been made necessary because the doctors have advised Premier Lloyd George that he may not resume work this week.

ASCOT RACES RAN TODAY

Three Big Events Pulled Off—List of Winners. ASCOT, June 13.—The Ascot Stakes for two thousand sovereigns run over a two mile course was won today by H. Gunliffe Owen's "Spearwort," 100 to 7; the second horse in this race was T. J. Shepherd's "King's Idler," 8 to 1; and W. G. Singer's "Chatter," 6 to 1. Thirteen horses ran.

Plans Well in Hand for Street-Surfacing Work; Various Tenders Called

Another step in the advancement of the plans for the hard surfacing of the downtown streets was taken last night when the city council, sitting in committee for two hours, arranged the final details for the calling of tenders for the crushing of the rock at Smith Island, the towing of it to the city and the hauling of it from Gow Bay to the various streets when it arrives here. The specifications for these three sections of the work have been prepared by the city engineer and now tenders are to be called for. These tenders are required to be submitted by June 27 and on the evening of that day they will be opened by the council. Outside firms as well as local ones are to be given the opportunity of tendering on the work.

BARROW SAYS GOVERNMENT SHOULD AID

Reservoir of Farms for Livestock Cultivation Along G.T.P. Likely. VICTORIA, June 13.—Hon. E. D. Barrow, minister of agriculture, states that the government will probably establish a reservoir of farms to cultivate livestock for the aid of settlers in the new farm lands along the line of the Grand Trunk Pacific Railway. He believes that the government of the province should give material aid to the settlers in the territory which he visited on his present trip to the Dairymen's Convention at Vanderhoof.

GRAIN INQUIRY IS ULTRA VIRES

Grain Dealers of Manitoba Secure Injunction Against Its Operations. WINNIPEG, June 13.—The grain dealers have obtained a legal injunction against the sittings of the Royal Grain Enquiry in the province of Manitoba. The sessions are now proceeding in other prairie provinces. It is claimed that the legislation appointing the committee, which is to investigate negotiations in the handling of wheat and other grains, is ultra vires.

MARINE STRIKE IS NOT SETTLED

Washington Representative Signed Settlement—Resignation Demanded. NEW YORK, June 13.—The headquarters of the Marine Engineers Beneficial Association has refused to accept the terms of settlement of the marine strike, which, it is said, was signed by their representative at Washington today. The resignation of the precarious representative has been demanded.

NO MONEY FOR UNIVERSITY AT PRESENT TIME

Premier Oliver Tells Delegation from Vancouver. VICTORIA, June 13.—Premier Oliver has informed a Vancouver delegation that no action is to be taken by the government on the request that the province contribute \$1,200,000 towards the construction of the new University at Point Grey. The Premier pointed out that this would be impossible at the present time on account of the many difficult financial problems that were already facing the government.

Women do Great Deal of Buying.

It has been estimated that Canadian women purchase almost ninety per cent of the commodities used in the domestic life of the country. Without their co-operation no effort towards home market development and increased support for Canadian or British-Columbian industry can meet with any large measure of success. It is important that Canadian women should realize the great importance of buying at home at the present time in order to avoid unemployment and business depression in this country as much as possible. These two conditions bear most heavily on them. This country does not need to have unemployment for it could keep its workers employed, even in time of serious world readjustment and depression, by using Canadian instead of imported goods and thus stimulating activities on the farms and in the factories. Unfortunately, many women have not supported the "Made in Canada" and "Made in B.C." movements because of misunderstanding about profits and prices of home products. Most of the criticism is based on misinformation, misunderstanding and prejudice. Therefore the women can do a great work for their country if they just realize their duty and consider Canada first in the purchase of even the simplest household requirements.

"Made in Prince Rupert District."

In Prince Rupert this made at home campaign may be narrowed down even to a closer margin. Northern B. C. is quickly becoming a great producer of foodstuffs. The preference should be given to the production of the immediate vicinity in all buying for Prince Rupert tables. The smaller fruits are now produced in sufficient quantities along the line of the Grand Trunk Pacific to supply the local market. Vegetables of many varieties are also to be obtained in the city stores. Butter, eggs and meat from the districts immediately adjacent to Prince Rupert may also be purchased here. President Williams of the Board of Trade recently came back from the Bulkley Valley with the motto, "Buy Bulkley Beef," coined. A motto like this need not apply to beef only, but it can pertain to many other household requirements such as potatoes, turnips, butter, eggs, strawberries, milk and many other lines of produce which are produced near Prince Rupert and not only in the Bulkley Valley. The buying of this local produce will help to make the north self sufficient at least in the line of foodstuffs. There is no reason why southern produce should be used here when the goods from the interior are obtainable. Prince Rupert depends a good deal for her prosperity on the agricultural areas adjacent to the city. Therefore they should be supported in this simple way.

Soon Street Surfacing Will be Under Way.

After having been the storm center for general criticism and the object of "before adjournment" thrusts since the beginning of the year, the city board of works has now pretty well evolved its plans for the down town street surfacing scheme. In the past couple of weeks, and especially since the arrival here of Harold Thackeray, new road superintendent, matters in this connection have been progressing well and now an early commencement on the actual work in the city may be expected. The Smith Island quarry will in a fortnight's time be ready to send rock to the city, this being indicated by the fact that the rock crusher has been sent for. The scarifier and the grader, which will be needed as soon as the work commences, have been ordered by telegraph and will likely be here in three or four weeks. The council has decided to call for tenders for the crushing and transportation of the rock to the streets which are to be surfaced. Therefore, it seems that arrangements are well in hand and by this time next month the actual work in the city should be well under way. Everyone will certainly be gratified to see it going, too, for it is certainly badly enough needed.

POLL TAX IS TURNED OVER TO THE CITY

Government Will Not Collect It If Municipality Does—By-law Passes.

A Poll Tax by-law providing for the assessment of Five Dollars per year from every male person resident in the city who does not already pay that amount in municipal taxes, outside of trade licenses and dog taxes, was last night passed through its first and second readings, by the city council.
 This levy is authorized by the provincial government which decided at a recent session to stay its collection of such tax when the city had adopted it. It is due by July 2 of each year. The money collected through this tax is to be used solely for hospital and school purposes.

TOO EXPENSIVE TO CONNECT WITH TANK AT HAYS COVE SCHOOL

Likely Another Septic Tank Will Be Put in for King Edward.

A letter from the secretary of the school board asking that the necessary steps be taken by the city council to have the King Edward School connected to the septic tank at Hays Creek was received at last night's meeting and was referred to the Board of Works for report.
 The original plan to have the King Edward School connected with the Hays Cove School septic tank, it was reported would be a very expensive undertaking on account of some deep cuts that would have to be made. Another proposal to have the pipes run across Eighth Avenue into the park behind the King Edward School where a separate tank will be installed has advanced and will likely be adopted by the council instead.

GOVERNMENT WANTS INFORMATION ABOUT FINANCIAL AFFAIRS

The city treasurer has been instructed by the council to prepare data for the provincial minister of finance for use in the revision of municipal and provincial tax matters that is to be taken at the special session of the legislature this fall. A questionnaire dealing with assessment, indebtedness, public utilities, local taxation, revenue and expenditure and other departments of the city's financing has been returned to Victoria with the information required by June 30. The information, before being sent on to Victoria, will go to the Finance Committee for approval.

LONDON, June 14.—When the Duke of Devonshire returns to England from Canada, after laying down his duties as Governor-General, he will, according to today's press, retire entirely from public life and pass much of his time at Chatsworth, which is now being prepared for his reception. It is understood that the Duchess will resume her former appointment of mistress of the robes to Queen Mary.

HUMAN SACRIFICES OFFERED IN INDIA

SIMLA, India, June 13.—A government report tells of a riot at the village of Sirichir caused by the offering of human sacrifices during disorders. Seven persons were killed and ten wounded.

RETURN TO PENNY POSTAGE WAS URGED

Salaries and contingencies of the post office department which amount to approximately \$1,400,000 were taken up in the House of Commons just before prorogation last week. Hon. R. Lemieux emphasized the point that the postmaster general should have a seat in the House of Commons. Mr. Lemieux said that from 1902 to 1911 the department had a surplus. It was true also that there had been a surplus for some years after 1911 until 1915, when there was a deficit. Much of the revenue in war time was because of the additional one cent postage. He feared the ever-increasing expenditure. He declared that if the department had a responsible minister, that the success of the department would be greater. The minister, he said, does not care for his department.

"He is not often seen in the upper chamber, and he does not attend council meetings. I think he should resign," said Mr. Lemieux.

Mr. Lemieux said he believed there should be a return to penny postage. The lower the postage rates, the higher the revenue obtained. He criticized the granting of increases to the railway companies for carrying the mails and blamed the present minister for permitting the increases.

NEW BROKERAGE FIRM HAS STARTED HERE

Philpott and Evitt Have Many Agencies—Both Well Known Citizens.

A new firm has just started up business in the city under the name of H. A. Philpott and C. V. Evitt, general agents, insurance brokers, auctioneers and coal dealers. The office is in the McLean Building next door to the post office. For the present Mr. Philpott will be the active member of the firm, Mr. Evitt being engaged with his work as secretary of the Board of Trade.

The new firm has secured a number of first class agencies both in Canada and the Old Country. They will carry a big stock of wire, manila and hemp ropes, as well as certain builders' supplies. A special feature of their business will be supplying coal, the firms being the local agents of the Mountain Park and Great West Coal companies. Trackage is in and covered bunkers are already erected near the Imperial Oil Company's wharf. Among the insurance companies they represent are the Employers Liability, the British Empire Fire and Underwriters Agency, and the Eagle Star and British Dominions Fire Insurance Company. It is the intention of the new firm to have a bonded warehouse in the near future.

Both Mr. Philpott and Mr. Evitt are old timers in Prince Rupert and are well and favorably known. Both were overseas most of the time during the war, returning to Prince Rupert the first opportunity that offered after being demobilized. All their interests are in this city and its future development, in which they have the greatest faith. There is no doubt that the new firm will be accorded a welcome into the business life of the city, now they have decided to permanently cast their lot here.

STATION PLANS ARE TOO SMALL

Mayor Rochester Approved Them to Allow for Early Construction, —Made Suggestion.

The city council last night endorsed the action of the mayor in approving by wire of the railway station plans that were recently submitted. Incorporated with the approval, however, is the suggestion that the plans provide for too small a waiting room for the city's future needs, and also the detail regarding awnings.

Speaking of his action last night, Mayor Rochester stated that he had discussed the plans with responsible parties and it had been felt generally that they were too small, especially the waiting room. They were much smaller, in fact, than had been expected. However, to put no stumbling block in the way of an early start of actual construction it had been decided to reply to a telegram from F. B. Garvell, chairman of the railway commission, giving the city's approval with the criticisms embodied as suggestions. The telegram from Mr. Garvell had stated that the railway company was anxious to proceed with the construction at once but it was not customary for the commission to give its sanction until the municipality had been heard from. An immediate reply had been asked for and this had been sent the next day by the mayor.

ROWE GETS CONTRACT FOR SHEET IRON SUPPLY

Will be Used in Lining Bunkers at Smith Island Quarry.

The Rowe Sheet Metal Works was last night granted the contract by the city council for the supplying of 644 square feet or 1830 pounds of 3-16 inch, punched sheet iron for the lining of the rock bin at the Smith Island rock bunkers. The successful quotation was \$385.

Other bids were as follows: Prince Rupert Supply Co., \$402; James Hunter, \$424.20; Akerberg & Thompson, \$579.60; Steen & Longwill, \$496.

WAS CHASING "LADY MINE" IN AIRPLANE

Power Schooner Said to Be Running Liquor to Mexico Being Closely Watched.

VICTORIA, June 14.—The power schooner Lady Mine, suspected of liquor running activities, is having a hard time of it. The accident that befell the Government flying boat bearing Col. Carey, Collector of Customs at the Mainland city, in the Straits last week, is said to have occurred when the machine was hot on the trail of the small vessel, while American revenue cutters are also supposed to be following her down the coast to pick up any loose bottles of liquor she might launch in the direction of the shore.

SHANE IS RUNNING NEW BUSINESS HERE

Associated with Gavigan, Henning and Benguel in Universal Trading Co.

S. K. Shane, until recently purchasing agent for the Prince Rupert Dry Dock and Engineering Co., has severed his connection with that company and has entered into business as managing director of the new company which has opened up business in the Helgerson Block under the firm name of "The Universal Trading Company."

Mr. Shane, who left Prince Rupert on May 2 last, has just returned from an extensive business tour of the eastern cities of Canada and the United States. Leaving here by steamer, he began his trip by a visit to the Pacific Coast cities. He stopped off at Winnipeg, Toronto, Montreal, Ottawa, Hamilton, New York and Buffalo. On the return journey Mr. Shane went to Edmonton and thence to Prince George where he got once more onto the home stretch. At the latter city he met H. F. Pullen of the Daily News and his son who were likewise touring the country, only going in a different direction.

Mr. Shane's trip was from start to finish of a purely business character, with a view to obtaining first hand information as to general business conditions in the big eastern centers. He reports a very satisfactory visit from a business standpoint and found that conditions generally are improving. While merchants in the east are not buying large quantities of goods ahead, they are making constant purchases as they require them, and the big wholesale firms are keeping their travellers constantly on the go.

In New York Mr. Shane managed to get time to see a ball game between the Giants and the Cubs, which the latter won. In Edmonton great preparations are going on for the coming Elks' convention, there being 1059 members of that organization in the city. Mr. Shane's visit to the big eastern centers has enabled him to arrange his purchases so that his firm will be able to give the people of Prince Rupert a maximum of value in goods sold for a minimum cost. The firm is aiming only at securing a fair and reasonable profit. Associated with Mr. Shane in the new enterprise are Messrs. F. Henning, J. C. Gavigan and Gaston Benguel.

CRIPPLE BEFORE MAGISTRATE WAS CHARGED BEGGING

A man named D. McKenzie, who appeared to be a cripple walking with a stick, was charged before Magistrate McMorde this morning in the police court with begging. He pleaded not guilty.

Chief Vickers testified that the accused had letters from his parish priest in Vancouver as well as from a Doctor McNutt of that city stating that he was a respectable person endeavoring to collect enough money to start up a little business.

Magistrate McMorde was very emphatic in denouncing the practice of indigents coming from the southern coast cities soliciting alms in this northern district. He let the accused go, however, on suspended sentence on the understanding he leave again for the south at the earliest opportunity.



Raids have been carried out by Scotland Yard detectives on alleged Bolshevik meeting places and offices and it is reported that sensational discoveries have been made.

While searching one building the detectives found a small casket containing ashes which are declared to be those of Rose Luxemburg ("Red Rosa") the German socialist who was killed in 1919 about the same time as Karl Liebknecht, the Communist agitator.

PEACE BETWEEN SOVIET RUSSIA AND RUMANIA NOW

BUCHAREST, June 14.—Peace between Rumania and Soviet Russia seems assured, says Take Joneco, Rumanian Minister of Foreign Affairs.

"We do not meddle in internal Russian affairs," he said, "any more than we would permit any meddling in ours. The Soviets reiterate that they they they have no intention of attacking us. I am bound to believe them and I know that we shall not attack."

"According to our information there are fewer Bolshevik troops on our frontier than there were during the winter."

"Likewise we have truly friendly, fraternal relations with Poland, Czechoslovakia, Jugoslavia and Greece. With Poland we are in agreement to maintain peace on our eastern frontiers. We are opposed to the return of the Hapsburgs which would be a great danger for the peace of Europe."

Economic conditions in Rumania, he said, were improving, the finances were in good condition and the future seemed favorable.

ROMANS MAY NOW GO TO THE BEACHES

Rapid Transit Line Between Ancient City and Nero's Old Seashore Resort.

ROME, June 14.—The Roman people will soon enjoy a pleasure of the Caesars. The seashore is to be brought so near the city that a Roman can live on the seashore and commute to Rome.

A new electric rapid transit line between Rome and Anzio, where Nero had his seashore palace, will soon be put in operation. The journey is expected to take but 45 minutes while trains will be run every half hour. The undertaking will be effected by electrifying the present State railroad which runs to Anzio.
