LONDON, April 5.—Although the British Government has not received the full text of the note sent by the United States to Germany regarding reparations, the official British opinion is that Germany has failed finally in an attempt of a new appeal of solving the reparations problem by approaching the United States for assistance. It is believed that Germany's next move will be a direct appeal to the allies.

WASHINGTON, April 5.—It is stated today that President Wilson has not yet committed to any definite program in regard to a Congressional declaration that the state of war with Germany is at an end.

STILL ASKING A CASH BONUS

United Veterans Lay Claims Before Parliamentary Committee at Ottawa.

OTTAWA, April 5.—The principle of a \$2,000 cash bonus to veterans was recommended to the parliamentary committee on re-establishment by the United Veterans yesterday.

Other recommendations made include free medical treatment for five years, Government employment for the disabled, compensation for deserted wives, a loan system and pay and allowances for unemployed veterans.

ARRESTED WRONG MAN

Frank H. Annak of Prince George Released at Ashcroft.

VANCOUVER, April 5.—The American consul has been advised that Frank H. Annak, who was arrested at Prince George for burglary in Montana and taken to Ashcroft under an extradition warrant, has been released. The arrest was due to mistaken identity.

NO NEGOTIATIONS IN REGARD REPARATIONS

LONDON, April 5.—Britain has not reopened negotiations with Germany on the subject of reparations, Premier Lloyd George announced in the House of Commons today.

GERMANY PAID HALF BILLION FOR REPARATION

LONDON, April 5.—The net amount of reparation money so far received from Germany amounts to about £100,000,000 (approximately \$500,000,000). Lloyd George informed the House of Commons last night.

FIRST BIDDING NEW EXCHANGE

Fish Buyers Moved to Government Wharf This Morning and 82,000 lbs. Handled.

The Fish Exchange was moved this morning from its old location on the G.P.P. dock near No. 3 street to the Government wharf and this morning the fish buyers bought 86,000 pounds of halibut constituting the first day's business in the new quarters.

The new exchange, which was originally the harbor master's office, and latterly the office of the National Independent Fisheries, is a much more commodious place than the old exchange. It is about double the size and instead of the old benches around the walls a long desk has been provided for the fish buyers, who were busy measuring it off this morning with the result that each buyer has 23 inches of desk space.

The Allied Fisheries have finished the work of moving their plant to the Government wharf and the Booth Fisheries Canadian Co. are now going. The Pacific Fisheries will be the last to leave the G.P.P. dock.

Four refrigerators in the yards are being filled today with the fish bought up at the sale this morning. More are reported for arrival by tonight's passenger train.



Negotiating Settlement of British Coal Strike; Transport Men May Join.

LONDON, April 4.—The coal strike is serious tonight. The railwaymen seem to favor joining the miners.

Lloyd George told the House of Commons today the Government was doing its utmost to relieve the situation.

It is rumored that the Government has decided on certain military steps which has inflamed the labor men. The House of Commons will discuss the situation.

The vote of the railway transport workers will be taken on Wednesday.

NEW YORK, April 5.—John L. Jones, representative of the British labor triple alliance, asks the support of American labor for the British miners, who are striking, he says, to nationalize the mines. He suggests a boycott of British shipping.

LONDON, April 5.—For three hours this morning delegates of the National Transport Workers considered the attitude they would take in regard to the strike of British miners. They did not reach a decision.

Informal and private negotiations between the Government and leaders of the Miners Union regarding a settlement of the coal strike began last night, it is reported.

CHARLES MUST LEAVE HUNGARY

Slav Alliance Threatens Unless Crown Claimant Returns to Switzerland.

PRAGUE, April 5.—The alliance of Jugos-Slavians (Czechs-Slovaks) and Rumania threatens severance of friendly relations with Hungary unless Charles leaves Hungary within 72 hours.

Charles is believed to be physically fit to travel and Hungary declares her intention of returning him to Switzerland immediately.

The Hungarian cabinet and military men renewed their oath of allegiance to the republic yesterday.

BUDAPEST, April 5.—Former Emperor Charles left Steinmannanger this morning on his way out of Hungary.

WASHINGTON, April 5.—M. Viviani has been informed by the state department that the United States cannot consider entry into the League of Nations.

Ottawa Hockey Team is Champion; Retains Trophy

VANCOUVER, April 5.—Ottawa Senators retain possession of the Stanley Cup, emblematic of the world's hockey championship, as a result of having defeated Vancouver last night in the fifth and deciding game of the series. The score was Ottawa 2, Vancouver 1.

It was a wonderful scene. Twelve thousand people watched the play in the great arena. They expected to see a good exhibition of the great ice game and they were not disappointed. It was fast all the time.

Vancouver scored the first goal at 16:26, the first period ending in a lead for the local team 1-0. Vancouver fans were wild with excitement and cheer followed cheer at every good point made. The visitors also had their supporters and the audience was not niggardly in its recognition of exceptional skill.

In the second period Ottawa scored the two goals which placed them in the lead and kept them there until the end. The first goal was at 1:27 and the second at 2:51. There was no scoring in the third period.

The Vancouver men did their best playing in the first period, but when it dawned on the visitors that they were to lose the championship of the world and all the honors that go with it, they made a wonderful comeback. No such hockey has been played here for many a day.

A good deal of money changed hands on the result.

NOT GUILTY OF MURDER

John Huntley, alias Allan Coleman, Serving Time in Westminster is Acquitted.

MONTREAL, April 4.—John Huntley, alias Allan Coleman, a Toronto man now serving a term in New Westminster penitentiary for forgery, was found not guilty of murder of Constable Chicotte of Montreal in which he was implicated. He returns to Westminster to complete his jail term.

VICTORIA, April 5.—Premier Oliver stated yesterday that he did not know just when the members of the liquor board would be appointed. He intimated, however, that it might be very soon.

The premier is leaving at the end of the month for Ottawa and New York on business.

UNEMPLOYED BECOME MORE THREATENING

Told by Mayor Gale at Vancouver City Cannot Help Them.

VANCOUVER, April 5.—A demonstration of unemployed at the city hall, yesterday was informed by Mayor Gale that the city cannot relieve them.

The unemployed are assuming a threatening attitude. There are, however, no disorders yet.

BAD YEAR FOR UNEMPLOYMENT

Despite This Canada Does Not Know Stringent Poverty of States and Europe.

MONTREAL, April 5.—Premier Meighen told a meeting of women here on Saturday that this was the worst year in history for the unemployed in Canada. There were now 180,000 out of work as against 100,000 in normal times. Despite the condition here Canada escapes the stringent poverty that is known in the United States and Europe, said the premier.

Physical Prowess Excites Attention.
 Almost anyone likes to see any feat of skill or physical prowess. The development of the brain and body both are desirable and for that reason anyone excelling in either form of development becomes more or less of a national figure.
 Sometimes we think that brain is much greater than muscle, and yet we find a hundred thousand people willing to pay large sums to watch the physical prowess of a negro and millions crazy for news as to the outcome of the struggle for mastery in the fishing ring.
 Most people are interested in watching gymnastic stunts. On the variety theatre platform, seldom a week passes without a gymnastic exhibition of some kind. Sometimes it is purely an exhibition of strength, but more often of muscular control and skill in physical exercise. We are interested in the development of the human body but most of us prefer it to be the development of some other human body than our own. We take our sport by proxy and while we admire physical excellence few of us think of practising on ourselves.

Sport by Proxy Few Advantages.
 There are few advantages to be gained in getting our sport by proxy. The larger our own waist becomes the more we admire the man who has a small one. At last we die from fatty heart while waiting for news of the winner of a "big fight." It is a curious anomaly.
 There are not many opportunities for sport in Prince Rupert. Our playgrounds are few. Yet it is noticed that the few open spaces there are usually lack players. Few athletes nowadays care to enjoy a game unless there is an audience. Everything is done for the gallery. And the gallery pays for its fun.

Whole City Watches Hockey.
 Practically the whole of Prince Rupert watched the hockey game between Ottawa and Vancouver. It has been for days one of the chief topics of conversation. Newspaper telephones have been busy from those wishing to know the result. Newspapers have been carefully scanned for particulars of the game. Although most people here have never seen any of the players and some have never even watched a hockey match, they are keen over the outcome. It is an odd condition. Physically we are deteriorating and yet we take more interest than ever before was taken in the physical prowess of our teams and individual players.

Days When All Would Get Away.
 These are the days when everyone would like to get beyond the city limits. The outdoors is calling. Getting away is difficult. It brings once more to notice the fact that there is no road leading out of the city, not even a trail except the railway track. The only method of getting away is to take to the water.
 The local public works department of the provincial government have been making reconnaissances but it is hoped there will be further action taken this year so that construction may start early next season if not before. Without making our action political and yet with firmness and emphasis we should press upon the authorities at Victoria that Prince Rupert needs a road leading out of the city and needs it badly.



PRINCE GEORGE NOT IN FAVOR PROVINCE CUT

Generally Felt that the North is Neglected but Few See Remedy in Secession.

TWO HUNDRED ATTEND MEETING LAST WEEK

There will be no secession movement in British Columbia long the line of Colonel Peck's resolution in the House of Commons, if the public meeting held in the Rex Theatre on Wednesday evening is any index of public feeling, says The Prince George Citizen. There were upwards of two hundred persons in attendance, including a number of ladies, but there were no fire works. All of the speakers were in accord that the district has never received justice at the hands of the various governments at Victoria, but there was not one of three who was prepared to take the hazard of the die, and win or lose it all. This was the line of Clement P. Deykin. He was for cutting loose from the south and taking a chance. He argued the north would get nothing the way it was hunted, and it could scarcely get less under any other arrangement.

John Melnis and Hiram A. Carney divided the rest of the talking between them. They were in agreement in the view that the electors in Fort George riding were shabbily treated, and while a change might be desirable, neither of them was prepared to subscribe to the separation idea of the Colonel Peck resolution. There would be difficulties in the way, and the independence to be secured might cost more than it would ultimately be found to be worth, and taken all in all they would sooner hang on and continue to receive a scanty hand-out for the district than take the chance of striking out for themselves.

Among those on the platform when J. H. Johnson, president of the Board of Trade, took the chair, were: Acting Mayor Barclay Keegan, H. A. Carney, Geo. Fenwick, A. McE. Young and Frank Whitmore.

Pattullo's Success.
Clement P. Deykin was the first to speak to the resolution. He said he had lived in the district for the past eight years, and there had been boards of trade, chambers of commerce, Liberal and Conservative, and workmen's organizations. They had all passed resolutions or sent delegates to the coast, but when they reached Victoria their various expressions of opinion had fallen on deaf ears and thick skins. Only recently the people of this community had elected Mr. Perry to represent them in Victoria. He was sure he was working hard for them. He had been trying hard to get the assessor's office moved to Prince George, but he had been refused. He had also tried to get a court house which would be in keeping with the dignity of the city, but he had been again refused. On the other hand they all know that Mr. Pattullo was able to go back to Prince Rupert with a cool \$200,000 for a court house in his city, and this in spite of the fact that the people of his constituency had previously received very substantial grants for various public undertakings. Prince George could count upon receiving its usual grant of nothing. It was plain to him that the north country was looked upon simply as an appendage, a convenient place in which to collect taxes and nothing more.

Would be Expensive.
John Melnis, while agreeing that the north was not getting all it should, said the cost of administering so large a territory with so small a population would be very great. It had potential wealth but that was all. It was not developed. To build a railway into the Peace River country would require all the resources of the country back of it. If a new province was created it could safely be assumed the taxation would be higher than it is today. If they decided on a change they must assure themselves first that they would better their condition by making it. He was not apologizing for Premier Oliver and was not an adherent of his but he thought they should take

YOUNG MAN WENT BLIND

Otto Rosenholme Stricken on Southbound Steamer—Painless in Vancouver

Otto Rosenholme, a young returned soldier from this city who last summer was employed as cook on the trawler, Andrew Kelly, and later was employed in a similar capacity at the cold storage plant, became totally blind while on his way south a fortnight ago en route to the home of his parents at Bellingham. Having been refused entry at the United States border line he is now in Vancouver, blind and penniless.

For some time before Mr. Rosenholme left here, it was seen that his sight was failing and just before he left it became particularly bad, so bad, in fact, that he could not see to pick up change from a counter or to walk down steps. He had included having treatment by specialists in Washington.

Arriving at the border after having been stricken blind, Rosenholme was refused entry to the United States on the grounds that he would be a ward of the state being blind and without money. His parents are reported to be well off.

Rosenholme is but 33 years of age and was well known here, being a big, good hearted and popular man. There are a number of persons in town who owe him money, which he had loaned, but in the time of need, none of these would pay back. The case is being looked after in the meantime by the Rebekah and Odd-fellows lodges here and in Vancouver.


