SLUTCHBURY SAYS BUNKERS TO BE BUILT SOON

DOLLY VARDEN MINE TO OPERATE ON LARGER SCALE THAN EVER SOON

Making Final Arrangements for New Coal Bunkers to be Erected Here Next Month

Edward Slutchbury, trade commissioner for the province, reached the city from Edmonton last evening bringing him the plans of the coal bunkers that he says will be the course of erection at this port by July 1. Mr. Slutchbury's final details for the erection of the bunkers and, on being interviewed this morning, he had little to say on the subject. He will be here probably a fortnight, during which he plans to visit Juneau and Anyox. The announcement made, however, that the bunkers are to be erected on the local waterfront and that within the very near future.

Germans Must Live Up to the Treaty in Respect to Army

BERLIN, May 18.—The allies fix June 30 as the time limit for German disarmament in a note received here today demanding that the German army be brought into conformity with the peace treaty. This applies to superfluous munitions and fortress equipment which must be surrendered as well as arms in the possession of civilians. Germany must further conform to the demands of the allies in regard to munitions factories and reduce all classes of police to 150,000.

Children of Treaty Can Not Be Allowed to Break Any Crockery in Europe

LONDON, May 18.—In a statement here this morning, Lloyd George reiterated the British attitude towards the Upper Silesia question as expressed by him in a recent speech in the House of Commons. He disclaimed responsibility for the "distorted reports in French newspapers" and says that the fate of Upper Silesia must be decided by the Supreme Council and not by Korfanty. "The children of the Treaty of Versailles cannot be allowed to break crockery in Europe with impunity," he remarked.

ANOTHER DROP IN LOGGERS' WAGES AT PORTLAND, OREGON

PORTLAND, Ore., May 18.—Wages has been reduced 7 1/2¢ an hour by the directors of the Loyal Legion of Loggers and Lumbermen in order to meet the competition of non-union men. The new basis of common labor is three dollars a day flat in the east and west. Robert S. Gill, executive secretary of the Legion, has resigned to accept a position with the Baltimore Typothetae.

MINERS JOIN FORCES ON WAGE AGREEMENTS

NEW YORK, May 18.—Anthracite and bituminous miners have joined forces to formulate new policies in the wages agreements for next year. The union heads decided on this action in order to consolidate half a million workers.

RENT CONCESSION

First Sign of Improvement in Chicago Housing Situation

CHICAGO, May 18.—Rent concessions as an inducement to prospective tenants to rent apartments, were offered here today for the first time in several years.

Dolly Varden Mine Will Operate on Large Scale When It Again Opens Up

"Development work may shortly commence at the Alice Arm mines and when shipping recommences it will be on a larger scale than ever before.

This statement was made today by Major G. B. North, manager of the mine at Alice Arm, who arrived on the Prince George on his way north to make a survey of the properties. He has spent the winter in the south.

Major North was not in a position to make a definite statement but he said that work might shortly be resumed. He pointed out that he was going to make a survey and report. Anything that might be done in the near future would be along development lines. Major North admitted that when shipping was again resumed it would be done on a scale surpassing all past records for the Alice Arm properties.

What success A. J. T. Taylor, president of the company, had on his recent trip to the Old Country with a view to interesting capital, Major North would not state.

The Alice Arm mines closed down about Christmas of last year.

RAILWAYMEN LESS WAGES

Cut to be Made on July 1, U. S. Railway Labor Board Says.

CHICAGO, May 18.—The United States Railway Labor Board has decided to revise downward the railway wages on July 1, the amount of reduction to be announced on June 1 following a close hearing of the appeal of the workers against the proposed revision of 20 per cent in their wages.

BIG BAILS ARE FORFEITED BY LABOR CONVICTS

Big Bill Haywood and Others Do Not Return to Leavenworth Prison

CHICAGO, May 17.—The failure of nine members of the Industrial Workers of the World, including William D. (Big Bill) Haywood, to return to the Leavenworth Penitentiary to complete their sentences for violating the Espionage Act has resulted in the forfeiture of \$89,000 in bail moneys.

BOMBERS ARE DISPERSED

Many Attacks on Police in Ireland; Castle Burned

BELFAST, May 18.—The election campaign in northern Ireland is becoming interesting. Last night a Sinn Fein meeting was called here, but shipyard workers occupied the hall and prevented the meeting being held.

The first bombing attack in Belfast came yesterday and proved unsuccessful. The police fired and dispersed the bombers.

DUBLIN, May 18.—A soldier was killed and another wounded in an ambush at Chicoree.

Attacked Footballers
Soldiers playing football at Bandon were attacked with a machine gun and several spectators were wounded. A fight ensued in which one soldier was killed and three of the attacking party were wounded.

Two civilians were killed in an attack on the police at Ballymena. A former soldier was killed and later one was wounded at Kilkenny, having been taken from their beds to die.

Aughrane Castle, Galway, was destroyed by fire on Sunday and the naval wireless stations at Kingston were attacked on Monday. Naval firing from torpedo boats dispersed attackers.

LAWYER MUST RETURN MONEY

Isaac Greenizen Must Disgorge \$30,000 in Connection With Nechaco Lands.

VICTORIA, May 18.—Nearly \$30,000 and interest at five per cent must be returned by Isaac Greenizen, a lawyer of Petrolia, Ontario, to members of a syndicate of British Columbians in connection with a 600 acre town-site property at Nechaco, B. C., according to a judgment of Mr. Justice Clements in the action of Greenizen vs. Twigg and others. The action of plaintiff was dismissed and a return of the money ordered.

CANADA MAY GET REPARATIONS CASH

Army of Occupation to be Paid For Out of the First Instalment.

OTTAWA, May 18.—A small proportion of the first German payment on reparations may come to Canada. The payment of 150,000,000 gold marks is to be applied to the allied army of occupation and as Canada contributed a small number of men for a short time, this country may be the recipient of an amount to partly cover the expenditure.

SUPREME COURT FORBIDS VIOLENCE AND UNION PICKETING

SEATTLE, May 18.—A court injunction forbids local branches of the six maritime unions picketing or trespassing on Shipping Board vessels or committing further acts of violence.

UNITED STATES WILL NOT INTERVENE ON SILESIAN QUESTION

WASHINGTON, May 18.—Poland appealed to the United States for support in consideration of the Upper Silesian question. The United States Government will reply that it cannot intervene, the question being essentially a European one.

COAST TRADERS OUT OF RUPERT

Recent Search for Escaped Prisoners Gives Local Police Some Ideas.

As a result of the recent close watch that has been made of craft passing in and out of the harbor in the search for E. Michelson, who escaped from the city lock-up on Saturday evening, the local police are evolving some theories as to the way "coast trading" of liquor between this port and Alaska is carried on.

The larger boats, it is believed, do not clear with liquor at all from this port. Instead they come here and place their orders and then, leaving the harbor, lie near some of the islands nearby and await delivery by smaller boats which are not required to clear.

There are several high powered boats in the trade, it is believed, and these develop a speed that make them nigh impossible to overtake. To successfully combat this illicit trade it would require patrol boats of high speed and fully armed.

DOING MORE WORK AT SWIMMING POOL

Volunteer Workers to Give Another Day to Improving Bathing Facilities for Children.

At a meeting of the swimming club held last night in the police court room at the city hall, it was decided to hold another working bee next Sunday morning to complete the work of cleaning out the swimming pool at the Salt Lakes where the children bathe so that when the sand is put in it will be in better condition than last year.

The Oh Baby will take the workers over at 9:30 Sunday morning and those willing to go are asked to notify E. R. Tabrum or Cyril Westaway beforehand so that provisions may be made for them.

More work is to be done to the approach to the float, and it is also proposed to blast out the stumps at the entrance to the lake below the dam, so that scow loads of sand may be taken right up to the dam on the high tide. ALBERT HAD PREMIER ORE

Left for South This Morning with Ore, Lumber and Salmon

The steamer Prince Albert, which arrived from Stewart yesterday afternoon at 2:30 and left again this morning for the south, had on board 200 tons of ore from the Premier gold mine. This was loaded on the steamer by half a dozen men who have not joined in the strike which has now become almost general as far as the Premier is concerned. The steamer also brought south about 80 fly passengers, many of whom were strikers leaving the place. During the night before she left for the south the Albert loaded salmon at the Tucks Inlet cannery and also 60,000 feet of lumber from the Georgetown mill consigned for England.

In the Letter Box

TOURIST'S PARADISE.

Editor Daily News:—When thousands of people are looking around for a place in which to spend their summer holidays, the opportunity is afforded for rest, recreation and profit, with the accompanying pleasure of visiting some of the beauty spots in this northern country.

Innumerable islands are scattered along the Pacific within a few miles of Prince Rupert. There camping parties troll for the king salmon during the 24 hours of daylight, while their families may camp alongside some pleasant stream where the fresh and salt water bathing facilities are of the best.

Salmon Trolling. For some years hundreds of trollers have been making a good living for some months, disposing of their catches to the packing boats sent out from Prince Rupert. All that is needed is a camping outfit, a supply of provisions and a boat. It matters little whether the boat is driven by man-power or by gasoline. With no wild animals on these islands and the fact that the beaches are of sand without danger from depth of water, the idea of giving children the advantage of an outing will be apparent.

On Graham Island. The months of June and July are long and the weather pleasant. There is no doubt about the catching of the huge salmon, which disport off the north end of Graham Island in large numbers. Wood and water for culinary purposes is in abundance. Why people will travel to Alaska to view glaciers and snow-clad hills is a mystery when we have so many attractive spots endowed by nature right at our own doors. Our inlets are almost land locked and extend many miles, almost cutting through the largest of the islands. We have sandy beaches on the sea coast that compare with Florida.

Hotels Needed. Should some large corporation erect hotels for summer visitors they will attract many seeking places where people may enjoy all that is lacking in the cities and towns. These comparatively unknown islands will be the future northern resort of the people of the Pacific, offering inducements that cannot be obtained in any other part of the world.
