Situation In Irish Affairs Very Tense

GREAT CELEBRATION YESTERDAY AT TELKWA; 1000 PRESENT

Porter Is In Danger of Capsizing if Heavy Weather Should Come

FRANCISCO, Sept. 6.—The eleven men who were in the lifeboat not far from this port have rejoined the importer, which has begun her slow journey to port in the tug Sea Lion and conveyed by the freighter Canadian and the salvage vessel Algerine. The tug Sea Monarch went to assist in the tow. The importer is said to be in danger of capsizing if heavy weather should be encountered. The decks are awash, with a list to starboard.

Workers Took Possession Following Minimum Wage Refusal.

WILLIAM HALE WAS DROWNED

Well Known Taxi Man of City Met Death at Cannery Near Ketchikan.

News of the death by drowning of William Hale at Ketchikan on Saturday reached the city by wire yesterday. Details are lacking, but it seems that the deceased had been working at Clawac Cannery and was drowned at a creek mouth from a small boat.

Mr. Hale was very well known in the city and formerly carried on a taxi business in partnership with Huntley Tate. He took a great interest in athletics and was an accomplished boxer of the heavyweight class. He appeared last at a Sons of Canada smoker and was to have been here for Labor Day. He left here about three months ago and went to Stewart and then to Ketchikan. He was about 22 years of age and was the son of Mrs. Ben Stone, whose husband was drowned while fishing off the mouth of the Skeena River several months ago. Mrs. Stone and family sailed for Vancouver on Sunday night.

Crisis Reached In Irish Affairs Following Failure to Agree to a Settlement on Dominion Status

LONDON, Sept. 6.—Sinn Fein's reply to Lloyd George rejects the British terms on the ground that they are not based on Dominion status for Ireland. It leaves the way open for further negotiations by offering to appoint immediately plenipotentiaries to negotiate on the basis of government by consent of the governed.

LONDON, Sept. 6.—While Premier Lloyd George held conversations with cabinet members and the civil and military authorities today, there were indications that the Irish controversy had virtually reached a crisis and that tomorrow's meeting of the British ministry might prove to be historic.

Some people believe that De Valera and his colleagues will be given a limited time in which to accept or reject the British Government's offer of Dominion status as a basis of settlement.

ARMS GIVEN TO UNIONISTS

Sequel to Speech of Armagh in Which Threat Was Made.

BELFAST, Sept. 6.—Unionists employed by a large concern near the scene of the recent rioting were given arms with which to protect themselves if attacked. They declared this was a sequel to the speech of O'Duffy at Armagh declaring that if the boycott was unsuccessful in bringing Ulster into Ireland they "will bring lead against them."

FAMILY OF SEVEN ARE SHOT TO DEATH

ORMSBY, Minn., Sept. 6.—A family of seven, a father, mother and five children have been found shot to death in their home here. They were apparently the victims of the father, Frank Klocow, a businessman. All were shot as they lay in bed.

POLAR BEAR TO STAY FOR FAIR

Negotiations in Progress Between Fair Board and Visiting Aviators.

The biplane "Polar Bear," with Aviators C. O. Prest and L. M. Bach from Mexico to Siberia, will likely remain in Prince Rupert until after the exhibition next week if negotiations that are now pending between the Agricultural Association and the flyers are brought to a successful conclusion. An offer has been made Mr. Prest, which he will probably accept. In the meantime, a delegation will meet the city council tonight to ask for assistance in financing the attraction.

JAPANESE CHARGED WITH STABBING IS FINALLY CAPTURED

Y. Toura, a Japanese, who is alleged to have stabbed a countryman named M. Ehara at Inverness Cannery on August 13 and who escaped from the scene at that time, was finally captured by the provincial police at Oceanic Cannery on Sunday. He appeared for preliminary trial before Stipendiary Magistrate McMullin this morning and was remanded until September 14.

BOMBING PLANE CREW FOUND WITH FOUR DEAD

CHARLESTOWN, W. Va., Sept. 6.—The bodies of four members of the crew of the wrecked bombing plane have been found. The fifth aviator was so seriously injured that he is not expected to live.

Wonderful Time at Telkwa Barbecue

Thousand People Visited Town and Saw Baseball, Football, Races, and Other Events then Danced Till Late Morning

TELKWA, Sept. 6.—The Barbecue yesterday was a huge success. The weather was fine on Sunday, with the result that on Monday morning everyone set out for the hub of the Bulkley Valley, the visitors numbering approximately one thousand people. People came from Prince George, Prince Rupert and intermediate points, arriving on horseback, wagons, automobiles, handcarts and on the trains.

The event was held on the new grounds, which had been specially prepared for the occasion, and at the track, which was in fine condition.

The barbecue proper consisted in the roasting of the best steer from Frank Dockrill's herd and hot beef sandwiches were served free to everybody by Master of Ceremonies Beck and his staff of assistants.

The town and grounds were decorated for the occasion with evergreen trees and flags. Refreshment booths were conducted on the grounds by the ladies of the Anglican Church and the ladies of the Union Church. In addition there were wheels of fortune and all the sideshows which bring joy to the hearts of the young people.

Several Games. Great interest was taken in the baseball game, in which Hazelton beat Telkwa by a score of 14 to 12.

Races and broncho busting were followed by a football match, in which the home team again lost, this time to Smithers, the score being Smithers, 8; Telkwa, 0.

Nor were the Telkwa lads any more successful in the baseball game on Sunday, in which Smithers beat Telkwa by 11 to 3.

Last evening there was a grand dance in the Community Hall at which 250 people attended. T. J. Thorp managed this affair and there was first rate music by a local orchestra consisting of Mrs. Douglas Campbell at the piano; Miss Fairbairn, violin; Clarence Burns, drums. Confetti and balloons gave the event a carnival touch. Mr. Spouce had charge of the ice cream and general refreshments which were served at midnight and the event closed this morning at 3.30. Over \$200 was cleared from the dance.

GIVENCHY WENT ASHORE NEAR BELLA COOLA

VANCOUVER, Sept. 6.—The naval patrol boat Givenchy piled on the rocks at Chaffield Island on Saturday afternoon and all the members of the crew were taken aboard the C. P. R. steamer Princess Alice. They are being brought to Vancouver on the Salvor.

The Skookum left for the scene of the accident on Sunday and it is believed the Givenchy can be taken off without serious damage.

The local fisheries office says the boat grounded at Raven Cove ten miles north of Bella Bella.

POPLAR AGAIN IN LIMELIGHT

District of London Notorious for Suffragettes Finds Another Pastime.

LONDON, Sept. 6.—There are now 24 members of the Poplar Council in prison for defying the High Court order to levy rates in accordance with the ruling of the London County Council. Five women councillors were arrested yesterday to the accompaniment of stirring scenes. The women invited the sheriff to arrest them and set an hour for the ceremony. Great crowds gathered and bands played.

The Poplar Council had refused to levy taxes to carry on the business of the district under the London County Council.

**Bank Reports
Very Hopeful.**

Bank reports are becoming very hopeful. Usually the banks foresee any coming depression and warn their customers of it. They also foresee a trade revival and, while not so keen in telling about it for fear of rousing false expectations and encouraging speculation, the reports they issue are optimistic in tone.

We have now reached the period when the banks are issuing more or less optimistic reports, but with caution. The Royal Bank has just sent out to its customers a report in which it shows that it was necessary there should be a dull period following the war and that, with a fairly good harvest and with adjustments of the currency, conditions should very much improve.

Owing to the fact that merchants have generally rather small stocks on hand, manufacturers look for a slight improvement of business during the autumn. Following the wise method of building up reserves, most of the old established Canadian companies have been able to withstand the shock of falling prices, and failures have not been as numerous as was expected for such a time. In the first six months of this year there were slightly over a thousand failures in business. While that was twice as many as during the corresponding period a year ago, it is not unduly high for a period of falling prices.

**Pessimistic View
Is Not Justified.**

"There is no standpoint from which a pessimistic view of the future of Canadian business is justified; and no inference of that sort should be drawn from these columns," says the Royal Bank report. "But caution certainly is required until the process of adjustment to new conditions is completed. Already prices, after declining some 32 per cent. from their high point, are beginning to show signs of greater stability. As Europe gradually clears away the commercial debris of the war, monetary conditions will become more favorable on both sides of the water, and London and New York will again supply the funds necessary for the development of this young and growing country. Immigration will commence to rise to the figures of pre-war days. The proceeds of loans and the funds brought in by settlers should then, as in the past, more than offset our adverse balance of trade in merchandise, making feasible the replacement of the Canadian dollar on a gold basis. And in the sane exploitation of our unexcelled natural resources all Canadian business will find real prosperity."

**Anti-Spy League
Busy in Victoria.**

There is an organization in Victoria formed to offset any law and order movement in that place which is becoming particularly active. It was formed following the election to office of two members of the police commission who were pledged to reform. The representatives of that organization commenced its public career by laying informations against the police commissioners and the chief of police for allowing Chinese gambling places to continue to operate, the idea of the commissioners being to make a big raid and catch them all, just as was done in liquor cases here by ex-Mayor McClymont.

The next move of the league was to sue two policemen for unlawfully purchasing liquor, the act having been committed at a time when they obtained a conviction against a bootlegger. The Attorney-General sent a letter of protest against the trial of this case by the magistrate.

The leader of the organization was one Albert Tisdale, who now has been arrested and is out on bail after spending a night in jail on a charge of immorality.

The series of charges affect very seriously the powers of the police commissioners and the police force in every organized community, including Prince Rupert. The question whether a constable may break the law himself in order to trap a law-breaker is one that has often been challenged but never settled. It is done continually, but consideration is always given to the object in view and no charges are laid against the offender. The Attorney-General protested against the prosecution at Victoria on the ground that the men were special constables acting in performance of their duty.

Wilkinson of the Bank of Montreal took their canoes to the interior point by train on Saturday and transferring them to the river by truck started immediately to paddle down the river, leaving at 3:15.

The party made about thirty miles the first evening and that night slept in a vacant Indian shack on the shore. Leaving at ten o'clock Sunday morning they paddled all day with the exception of a stop for lunch, reaching the Northern B. C. Cannery that night at 10 o'clock. They were entertained by the manager, A. Kipp, who treated them most hospitably.

At seven o'clock Monday morning they were off again and arrived home yesterday after a fine trip which they all enjoyed.

NEARLY 200,000 LBS. HALIBUT WAS SOLD AUCTION YESTERDAY

At the fish auction here yesterday there was very nearly 200,000 pounds of halibut sold to local buyers for shipment from this port to the Eastern market. Ocean Falls' contention that her baseball players are to be considered as serious rivals in any Northern British Columbia baseball series makes the entry of the fourth town for the honor which is now become quite coveted and over which fans are becoming very interested. The Ocean Falls team has made it quite plain that they are a mighty strong aggregation and are not going to let Prince Rupert, Prince George or Anyox get away with any such title without a battle with them. As the old saying goes "the more the merrier" and, even if the season is getting late, it is quite possible that these four towns may yet be able to play off for this envied distinction.

If Ocean Falls can come here during Fair Week it would simplify matters considerably. Two teams could meet early in the week for elimination. The second pair could play about the middle of the week and then on the last two days the play-off could be staged. If it were decided to play one game each for the elimination and one game for the final three games would be necessary. If the series system were adopted then there would be nine games. While the latter would be by far the best from the gate receipt standpoint, it is doubtful if all or any of the teams would be able to spare the time. In any case, good weather would be required for they could not be all afternoon games. The expense would be large and a lot of money would be lost should weather conditions prove unfavorable.

The Papermakers seem to have the idea that Prince Rupert has refused their challenge. This, however, is not the case. The trip to Ocean Falls has been planned for some time and even before the Vancouver tour was mooted. Since it was found that the latter would be impossible this season and the proposition for a Fair series has been brought forward, it looked almost as if the trip south to Ocean Falls would not materialize. But there is still reason to hope that Ocean Falls and Prince Rupert will meet. The best time for all concerned would be Fair Week with all four teams here but, failing that, the locals might yet be able to go south towards the end of the month. In any case, Ocean Falls has not been forgotten and her challenge has not been refused. Difficulties in making arrangements for the trip have been responsible for the temporary delay and there is no doubt that the games will be played some time.

Many speakers at the Sons of Canada banquet on Friday night referred to the actions of certain spectators at baseball and football games this season which, to say the least of it, were objectionable. The two main points that were drawn attention to and which were condemned were the "ragging" of the referees or umpires and the use of bad language. It is certainly poor sportsmanship to do either
