GREECE HURRIED WITHDRAWS PROTESTING LOS ANGELES CRIMINAL WAS FORMERLY A LONDON, ONTARIO, PREACHER

Master Criminal Makes Escape from County Jail was Formerly Clergyman

LOS ANGELES, Oct. 17.—Herbert Wilson, known by the police and federal operatives as "The Master Criminal," and who had been convicted of the murder of his pal, escaped from the county jail here today with another convicted murderer, Adam Ward, and a man held in connection with recent robberies. They beat up a turnkey and held up two inside guards.

Wilson was formerly pastor of the Richmond Street city mission at London, Ontario, where he was born. At one time he was employed in a stove factory there. Charges against him led to his release from the pastorate and he went to Texas where he became pastor of the Brownsville Congregational church. He left to engage in the oil business in Texas.

In January of this year Wilson was arrested as head bandit of a gang. During the trial he shot and killed a pal in an effort to escape from prison.

BOHLER HOUSE IS DESTROYED

Well Known Resident of Kitsumatum Is Burned Out of Home

FAULTY CONNECTION CAUSE OF TROUBLE

TERRACE, Oct. 17.—At five o'clock Wednesday afternoon, Fred H. Bohler's house caught on fire and in less than half an hour it was burned to the ground. A neighbor arrived in time to pull the kitchen range out and some things upstairs were saved but with these exceptions everything was destroyed.

The fire is supposed to have originated from a faulty connection between the pipe and chimney. Mr. Bohler was in town at the time. It was a large well built log house, two storeys high and is a heavy loss.

Mr. and Mrs. Bohler and family are living temporarily in Tom Lever's house. Jimmy Lever who is working in town did not learn of the fire till the next morning. He lost a trunk containing a number of valuable papers and two guns.

Mr. Bohler was one of the first homesteaders here and was about the first to make a living from his ranch. He is well known both here and in Prince Rupert through his fine exhibits at the fairs.

CANADA TO NEGOTIATE OWN TREATY

Act Independently of British Embassy Regard to Great Lakes

WASHINGTON, Oct. 17.—Britain has approved the proposal that Canada negotiate direct with the United States a new treaty for the defense regulating the naval strength on the Great Lakes. The negotiations will not go through the British embassy as formerly.

A representative of the Canadian Government will be sent here soon to discuss the treaty negotiations which were begun when Mackenzie King was in Washington last summer.

SURF INLET MINE PAYING DIVIDENDS

VANCOUVER, Oct. 17.—The Belmont Surf Inlet Mining Co. is again paying dividends. It is said the outlook at the mine is such as to make it possible for dividends to continue.

The Surf Inlet Gold Mining Co. of Vancouver holds 20 per cent of the stock in the company and they will have some money to distribute among their shareholders.

THIRTY MILLION POUND OUTPUT ANYOX COPPER

VANCOUVER, Oct. 17.—The Granby Company expect their output of copper this year will reach the thirty million pound mark. The wage increase at Anyox, which went into effect on October 1, amounted to about 50c. a day.

Greece is Asking More Time for Evacuation of Thrace Owing to Poor Transportation Facilities

CONSTANTINOPLE, Oct. 17.—The Greek patriarch has appealed to all the allied powers for an extension of time for evacuation of Thrace. The Turkish leaders declare the Greeks are known to be plotting for the destruction of the Greek part of the city by fire.

General Harrington, the allied leader, denies that any excesses are being practiced by the Greeks. Evacuation is going forward smoothly and the general warns journalists to refrain from playing up small incidents.

ATHENS, Oct. 17.—Latest developments show a strong increase in republican sentiment in Greece and a concerted move toward the abolition of the monarchy.

Greek generals complain that the transportation is inadequate for the movement of troops and the evacuation of Thrace will be impossible within the time limit.

CUT EXPENDITURES TO THE BONE SAYS FINANCE MINISTER

VICTORIA, Oct. 17.—Hon. John Hart, minister of finance, has asked all the cabinet ministers today to cut to the bone their estimates for next year. The move was made, Mr. Hart explained, in an effort to make a substantial cut in the expenditures of the province during next year so that taxes may be kept down.

UNIONISTS MEETING AGAIN ON THURSDAY TO DECIDE ACTION

LONDON, Oct. 17.—The meeting of Unionists called for Thursday will be of great importance as it is almost certain to bring the parliamentary crisis to a head. Until the decision as to whether to break up the present coalition or to stand by Premier Lloyd George is known the situation is not expected to develop materially in any direction.

LABOR DISAPPROVES LLOYD GEORGE SPEECH

Demands Rally to Labor Cause for Socialistic Principle

LONDON, Oct. 17.—The general attitude of labor is disapproval of Lloyd George's speech and a demand for a rally to the labor cause for the establishment of the socialistic principle in Government.

FUNERAL OF LATE W. J. FOSTER TODAY

The funeral of William John Foster, aged 47, who died at the general hospital on Thursday night last following a serious operation, took place from the Haynor Bros. chapel at 2.30 this afternoon at the Fairview cemetery.

The Rev. G. G. Haeker officiated. Deceased was a native of Clinton, Ont., and prior to coming to Prince Rupert was employed at the Wallace shipyards in Vancouver.

Flowers were sent by the Motive Power department of the Canadian National railways, and mates of the Canadian National, and a wreath from the Car department of the Canadian National railways.

LARGE BOATS ARE EXPECTED

American Schooners Left Seattle for Yakutat and Should be Here Soon

About three weeks ago a number of American halibut boats were reported leaving Seattle for the annual autumn fishing at the Yakutat banks and they are now about due. Some of them should have been here ere this if the weather had been good and the fish plentiful. They had gone south to Seattle following the summer fishing, to outfit for the winter.

The Carruthers and Alaska are also due in port and seem to have been delayed.

During the summer the American boats fish along the coast north to Cape Fairweather and south to Cape Spencer and Cap-Addington. Later in the season they go farther north. Last year in November some huge catches were made at the Portlock banks and the boats are expected to do the same this year. The tides at Yakutat are not as bad as on the Albatross banks and at Kodiak Island.

CHARGE CHANGED TO ATTEMPTED MURDER PORT SIMPSON CASE

In the provincial police court this morning, before Stipendiary Magistrate McMullin, Clarence Flewin and Raymond Kevis, of Port Simpson, who were arrested in connection with the assault made on R. Boyd Young at that port on Sept. 11, were remanded for eight days. The original charge of assault with intent to rob has been withdrawn by the police and a charge of attempted murder has been laid.

CHECK PAID TODAY TO AMERICAN GOVERNMENT WAR DEBT INTEREST

WASHINGTON, Oct. 17.—Great Britain today paid to the American government the first instalment of interest on account of the \$1,500,000,000 war loan. The check for \$50,000,000 was delivered to the Federal Reserve bank, New York by J. P. Morgan Company for the account of the British treasury.

MULVEY RETURNS WITH SECURITIES

OTTAWA, Oct. 17.—Bringing back with him approximately \$1,500,000 of securities formerly in the ownership of enemy nationals, Thomas Mulvey, under-secretary of state for Canada and custodian of enemy property, has returned to Ottawa after spending the last few months overseas in connection with business of the clearing house and the settlement of enemy debts.

FASTEST SPEED EVER ATTAINED BY HUMAN BEING

MOUNT GLEMENS, Oct. 17.—Flying over one kilometre course Lieut. Maughan of the United States air force attained a speed of 218.5 miles an hour, the fastest speed at which any human being has ever yet travelled.

TERRACE MAN GETS YEAR FOR ASSAULT

John King Sent Down by Judge Young in County Court Yesterday.

John King, of Terrace, was sentenced to twelve months imprisonment by Judge Young in the County Court yesterday for committing an assault upon Jas. Smith with intent to do grievous bodily harm, at Terrace on Oct. 1.

INVASION OF VLADIVOSTOK THREATENED

TOKYO, Oct. 17.—Despatches from Vladivostok report that the city is in imminent danger of invasion by Soviet troops. Members of the government have boarded a steamer ready to depart. General Dieterichs, commander of the anti-soviet army, is reported to have been defeated and is retreating to the Russo-Chinese border.

WAS STRUCK BY AN AUTOMOBILE

NANAIMO, Oct. 17.—One boy is dead and one is dying and five others are injured more or less seriously following an accident here. The boys, who range from twelve down to four years of age, were hauling wood in a light horse wagon when they were struck by an auto at a street crossing.

John Mercer, who is dead, was six years of age. Daniel Healy, aged twelve, was so badly crushed that doubt is expressed of his chances of recovery. The other boys are J. Patterson, A. Anderson, F. English, G. Young and Billy Edmonds.

The auto was driven by William Horton, a stevedore foreman.

The children carried no lights and it is thought that no blame attached to Horton who appears to have been driving at a moderate speed.

Constructive Address by Hon. A. M. Manson Refuting Charges Levied by Stevens of Vancouver

Perusal of Hon. A. M. Manson's famous "yellow cur" speech proves it to be a most comprehensive and complete rebuttal of the Stevens charges. Here is the complete report as appearing in the Victoria Times just to hand:

Speaking at the annual meeting of the Victoria Liberal Association, Mr. Manson said that while busy at his office in the Parliament Buildings he had heard a whine outside and looked out to see a yellow cur go past.

"We have heard him in Penticton and again in Vancouver—a yellow, yellow cur—that is the only word that describes Mr. H. H. Stevens," Mr. Manson said to the audience of 400 persons, who, tense in their eagerness to hear his reply to the Stevens charges, jammed the Liberal Club rooms and stood out in the corridor and stairway as far as they were within range of his voice.

"I hope I make myself clear," he added slowly. Mr. Manson declared that Mr. Bowser had had the nasty work to do for the Conservative party for the last five years.

"Now I congratulate him," he went on. "He has got a scavenger who goes out into the byways and digs in the filth, and that scavenger is the ex-Minister of Trade and Commerce for Canada."

Made Quarter Million Mr. Manson challenged Mr. Stevens to lay his books open on the table, declaring that when elected member for Vancouver Mr. Stevens was without money.

"May I ask who paid his way to the city of Ottawa after his election?" Mr. Manson went on. "Now I look up Bradstreets and Duns and find him rated as being worth \$250,000."

"Mr. Stevens dare not lay his books on the table, and open them to the searchlight of an auditor."

Mr. Manson said that he, contrary to assertions of Mr. Stevens, was not now a member of the firm of "Manson and Williams," practising law in Prince Rupert, and that he was willing to take his private books and lay them open to show that there was nothing he had received money improperly for during the fourteen years he had been in this province.

"Will Mr. Stevens take his books and lay them on the table?" he continued. "When the end of the day comes we will see whose reputation is clean, mine or H. H. Stevens'. I don't have to apologize for anything in my past."

The Liquor Department Mr. Manson said that to the many branches of the department of the Attorney-General there had been added the control of the liquor department of the B. C. Government.

"The department of liquor is considered a tid-bit, the sweetest little morsel we have around the buildings," he went on. "My, all the advice we get on it. The world is just reeking with advice on the liquor question."

Declaring that the liquor question furnished one of the oldest problems with which governments have had to wrestle ever since Biblical times, Mr. Manson quoted President Wright of the Hotel-keepers of Ontario as saying when prohibition was passed in that province:

"Gentlemen, we have no one to blame but ourselves. We had a privilege; we abused it."

"The Government control act is not easy of administering," Mr. Manson went on. "One of the problems is that there is an inclination on the part of those in the liquor business to a violation (Continued on Page Five)

Many Accidents at Vancouver Yesterday at Various Points

VANCOUVER, Oct. 17.—Accidents occasioned the death of three people and injury to three more in Vancouver yesterday. In addition a small boy was stabbed.

Daniel McLennan shot himself in a local hotel last night. He was fifty years old, a native of Sarnia.

Henry Kosky died as a result of a fractured skull, believed to have been the result of a fall from a bicycle.

Edward Fisher, an employee on the addition to the Government grain elevator here, fell into the grain chute and was crushed by falling lumber.

Esfil Fryberg and P. C. Johnson were injured in two separate auto accidents.

J. Stokes, a gypsy, was arrested charged with stabbing his three year old son who is seriously injured.

JUDGE'S SON TO BE LEGISLATURE CLERK

Carew Martin Chosen for Position It Is Reported at Victoria

VICTORIA, Oct. 17.—Carew Martin, a lawyer of this city and a son of Mr. Justice Martin of the Court of Appeal is likely to be the new clerk of the B.C. Legislature, according to reports at the Parliament Buildings today. He will take the place of John Keen who died early in the year.

Mr. Martin served overseas during the war as an officer in the army and was wounded.

Great Interest In Civic Affairs.

It is some years since there has been as much interest taken locally in civic affairs as seems evident today, and it is yet about three months before the civic election takes place.

Starting an election campaign three months before the election takes place is not usually good policy. This year, however, things are different and it will be wise for the ratepayers of the city to consider well before committing themselves to any candidates or any particular line of action.

Cost Of School Still Mounting.

While ratepayers will be looking somewhat askance at the rapidly mounting size of the school repair bill, they may thank their lucky stars they did not have to follow out the Cox plan of building another wall around the present one as proposed by the Vancouver architect.

Gruesome Custom At Local Funerals.

A subject of constant remark from visitors to the city is the gruesome custom which is still carried on here of allowing the people attending funerals to file around and look at the face of the dead person in the coffin.

We all like to have pleasant remembrances of those who have gone. To look at them after the spirit has passed away and the beauty has departed leaves but a poor impression.

Cut Down Expenses Says Finance Minister.

The Minister of Finance for the province has asked the heads of Government departments to prune their estimates this year so that the expenditures may be kept down and the taxes kept from increasing.

The latest move is to try to get the Provincial Government to take over the cost of operating the schools. This would mean that instead of paying taxes to the city we should have to pay them to the province.

SCHOOL COSTS ARE MOUNTING

To First of Month Over \$26,000 Had Been Paid Out

QUESTIONS ANSWERED

Alderman Montgomery Digs Into School Repair Expenses at Council Meeting

Questions on the Booth School repairs asked at a previous meeting of the council by Alderman Montgomery were answered by City Clerk Woods at the council meeting held last night in the City Hall.

The City Clerk stated that the answers had been given from information obtained from the Treasurer's books, Architect Jeffers, the files in the city clerk's office and from the Municipal and Public Schools Acts.

The Replies
The questions asked by Ald. Montgomery and the replies thereto by the City Clerk are given below.

Q. What is the total expenditure incurred on the repairs to Booth School up to date.

A. \$26,272.39 up to Sept. 30, 1922, with additional accounts, etc. paid during the current month as per details attached.

Q. What is the Architect's salary per month?

A. \$500.00.

Q. What is the amount of expense paid to the Architect per month?
A. July 23rd to September 1, 1922, \$206.10; Sept. 1st to 5, travelling expenses in July \$113.60; June \$138.60; Fee for Registration in the Architectural Institute of B.C. \$50.00; Fee for examining and reporting upon School \$500.00

Q. What is the estimated cost to complete the repairs now being carried out?

A. \$9,000.00 to \$10,000.00, in addition to the \$26,272.39 given in answer to Question 1.

Q. What was the original estimate of such repairs?

A. \$12,000.00 to \$15,000.00 as asked for by the School Board, at Council meeting held June 26, 1922, at which meeting the Council undertook to provide \$15,000.00. At a meeting between the Council and the School Board held August 16, 1922, Mr. Jeffers stated that the whole repairs would be completed for \$18,000.00.

A. The authority given to the Council is set out in Sec. 226 of the "Municipal Act," and in Section 48, 50, and 53, of the "Public Schools Act," which sections I now submit.

Alderman Montgomery. "From the original estimate of \$10,000 we are now up to \$26,000 and I think that it is a serious enough question for this council to take up. The question is are we going to stand for \$26,000."

Ald. Perry asked why, if the city engineer and the Board of Works had seen the reports, the matter had not been brought before the council before.

Trustees Responsible

Acting Mayor Kerr stated that the Board of Works had nothing to do with it and that the School trustees were responsible.

City Engineer Whitaker stated that he had no control over the expenditure. He had reported to the City Council on two occasions, and his reports had been turned down. Speaking of the original estimate Mr. Whitaker said that he had told the council then that the necessary work could not be done for the money and that something more would have to be forthcoming.

Acting Mayor Kerr. "We well know that \$15,000 was not enough. However, the school has got to be fixed so what are you going to do with it? There is a lot of politics mixed up in this Booth School affair."

Work Well Done

Ald. Perry. "I am satisfied that the work being done by Mr. Jeffers is being well done and when it is completed I think there will be no cause for complaint. I think it would be a great idea to have a meeting with the School Board and discuss the matter jointly."

Ald. Montgomery. "I take ex-

ception to the remarks of the acting mayor about politics being mixed up in this matter. There are no politics in this with me. I want to enlighten the council what is being done. As regards Ald. Perry's remarks about a good job I have my own ideas about that, and I think you will have trouble with that building when it is finished."

It was moved by Ald. Kelly and seconded by Ald. Perry that the matter be laid on the table for one week. This motion was carried.

BRIDGE TENDERS ARE HELD OVER TEMPORARILY

The matter of tenders on the Hays Creek bridge came before the city council last night at their regular weekly meeting in the City Hall. The city engineer asked that the matter be laid over on account of the fact that the Dominion Bridge Co. had quoted on a bridge 10 feet wider than the original specifications called for, which had evidently been a mistake.

The matter was laid over until an amended quotation from the Dominion Bridge Co. is received.

WOODEN PIPE FOR CITY WATER MAINS

Recommendation That it be Used Comes From Finance Committee

The question of pipe for necessary replacement of water main on Fourth and Fifth Avenues, now being regraded, again came before the council last night at their regular meeting held in the City Hall.

A report from the Finance Committee recommended the replacing of the present water main system with 8" wooden pipe to be furnished at a cost of 60c per foot complete.

It was moved by Ald. Montgomery, and seconded by Ald. Kelly, that tenders be invited for steel, cast iron, and wooden pipe, and that upon arrival of tenders the matter be given further consideration.

TENDERS RESIGNATION

Alderman Perry Granted Leave of Absence Without Pay Till End of Year

Alderman C. C. Perry officially tendered his resignation as Alderman in the city council at the council meeting held last night in the City Hall in view of his departure for Vancouver Thursday to take over the duties of Indian Agent in Vancouver.

In tendering his resignation Ald. Perry said: "I wish to say that I feel a pang of regret in having to part with you all but duty must come before pleasure."

Ald. Dybhavn moved that the council grant Ald. Perry leave of absence without pay for the balance of his term of office, which would be two months and three weeks. The motion was carried. This does away with the necessity of a by-election.

TAX SALE REPORT

Sum of \$2,029.86 Cash Was Taken and \$317.15

The report of the local treasurer on the 1922 tax sale was read at the council meeting in the City Hall last night. The report showed that the total cost of the sale was \$347.15. Total amount collected to cover cost \$2,029.86, of which amount \$277.17 was paid by purchasers other than citizens of Prince Rupert. Total proceeds of tax sale amounted to \$17,527.19.

Amounts paid to employees were not for work done on the day of the sale but for overtime for work done before and after the sale.

Alderman Collart made the suggestion that all work pertaining to future tax sales should be carried on by the city officials during their regular hours without overtime.

The matter was laid over for a week.

of the law and to treachery."
Internal Treachery
 He declared that there had been been treachery in his own department, not among his personal staff, but by one of the liquor board staff, who took papers from his desk and gave them to Mr. Bowser, who handed them over to Mr. Stevens. They didn't, however, get the whole report, but took part of it and then started out to drag the whole thing in the mire.

"Is that statecraft?" Mr. Manson asked.
 Referring to the charges of Mr. Stevens that there have been no prosecutions of liquor offenders in Prince Rupert, Mr. Manson said:
 "I want to tell him that there isn't the faintest atom of truth in what he says. I want to tell him that Omineca was one of the first ridings to be cleaned up. I have a list of the men prosecuted in the riding. Some of them supported men in the last election. Why is about it? Why not first inquire and open up the police records. I think that his action is more or less below contempt. Does he know that before he ever got on the Provincial Conservative platform that information was being gathered against offenders in Prince Rupert?"

No Illicit Liquor
 "My inspectors' reports tell me that Omineca and Fort George are two ridings in which it is practically impossible today to buy illicit liquor. He speaks of Prince Rupert. Does he not know that on May 3 barely a month after I took the office of Attorney-General, I wrote to the municipal authorities of that city insisting upon the proper enforcement of the Liquor Act and declaring that if they did not do it my department would step in and enforce the act at the expense of the municipality? I wrote that letter and I have had a report of conditions there, and I want to tell Stevens that in May last, before he got upon the Conservative platform in Vancouver, information was laid and prosecutions will be launched."

Mr. Manson went into Mr. Stevens' references to Fred G. Dawson, whom Mr. Stevens charged with getting 1,600 barrels of beer. He declared that Mr. Dawson was not his campaign manager at all, as Mr. Stevens alleged.
 "Mr. Dawson is a man who is the head of the wholesale house of F. G. Dawson Ltd. in Prince Rupert, and has been president of Board of Trade," he went on. "He is one of the finest men who steps in shoe leather in B.C. Mr. Stevens is not worthy to wipe rags across Mr. Dawson's boot."

States Dawson's Position
 Mr. Manson explained that Mr. Dawson's firm was agent for Victoria Phoenix Beer, under a ruling of the Liquor Board which permitted wholesalers to act as agents for export trade. Eminent lawyers even contended that brewers had the right to sell to wholesalers despite the Liquor Act. These agencies were put through the supplies to the liquor vendors in various districts. There were leakages, however, from the beer agencies through-

out the province, as some of them did not do what they undertook with the Liquor Board to do. The result was that he as an Attorney-General gave instructions that these beer agencies were to be discontinued.
 He said the Dawson firm, under the arrangement with the Board, was justified in bringing in supplies of beer and then Mr. Stevens tried to make political capital out of this.

Mr. Manson asserted that Mr. Stevens was mixed and because beer agencies had gone wrong he had picked on this man because he was a Liberal and had been chosen by the Prime Minister of Canada as a member of the Board of the Canadian National Railway.

Beneath Contempt
 "The man is utterly beneath contempt who would endeavor to take the character of a public man away without inquiring into the truth of the statements he alleges," Mr. Manson added, referring to Mr. Stevens' attack on Mr. Dawson.
 Mr. Manson said that Mr. Stevens was supposed to be a good prohibitionist, but although he said he knew these things were going on, he never took the trouble to write him a line about it to rectify matters if they were wrong.

Another thing he said Mr. Stevens did which showed what calibre of a man he was, was to refer to a man now in the cells awaiting trial for murder as "a low down bootlegger."
 "Is that British?" Mr. Manson asked. "Even the poor unfortunate in the cell is entitled to leave the matter to his twelve peers on the jury to decide without having his case prejudiced by a public attack"

Tribute to Mr. Paterson
 Dealing with the Stevens' charge of Liberals becoming millionaires through liquor dealings with the Government, Mr. Manson told how at the last session of the Legislature in dealing with these charges the Government threw open the books of liquor purchases, with the result that nothing more was heard about the charges.

"I have more confidence in James Patterson, the liquor purchasing agent of this Province, than I have in men of the calibre of H. H. Stevens," he added. As to the Stevens' reference to liquor profits in B.C., Mr. Man-

son repeated the assertion given out in official statements, backed with comparative figures some time ago, that the operation of the Liquor Act in this Province would compare favorably with the operation of the act in Quebec.

Refused by Senate
 Next he took up the attack in connection with export houses here and their encouragement of bootlegging to the United States. Mr. Manson told how he had gone to Ottawa and asked the Senate and the House of Commons to give him the necessary power to exterminate the bootlegger, but the move was blocked in the Senate by Mr. Stevens' political friends, Senators Green Plant and Taylor.

"Was Mr. Stevens good enough prohibitionist to go over and ask these senators to support this move?" he asked. "No, the party to which Mr. Stevens belongs is the party responsible for the export trade into United States to-day."

Referring to Mr. Stevens' allegation that the Attorney-General was unfit to hold office if he pleaded ignorance of a case where a Mrs. Kelly, of Prince Rupert, had sued for \$18,000, which she said was her share of the profits on a bootlegging business, but concerning which no prosecution had been brought, Mr. Manson declared he had never heard of the case.

Government's Many Problems
 Mr. Manson also took up general policies of the Government, declaring that one often wondered to what extent the public had a true conception of what the management of public affairs meant, dwelling on the immensity of the natural resources and the duty of developing them and conserving them for future generations, and the responsibilities of ministers and officials in their management.

Among other things he said: "People in the dutiful parts of the Province have just as much right to the attention of the Government as you people sitting around your comfortable firesides in the cities of Victoria and Vancouver."

"With our fish resources you have already paid the penalty in the Fraser for the neglect of conservation for the next generation.
 "So that our natural wealth will not be exterminated, resistance is required against the selfishness of mankind."

"Our forests extend from one side of the Province to the other. In the last five years we have got the lumber and pulp industries revived in B.C. We are placing our lumber all over the world. In the British Navy it is used to be Oregon pine, now it is Douglas fir."

"To-day B.C. is growing as an agricultural Province. Hundreds and hundreds of settlers are coming into Northern B.C. from the Prairie Provinces."

"The last Government sold our lands from Dan to Beersheeba. We have had to buy back at three and four times the price for settlers, the land our friend Mr. Bowser sold to the speculators. Settlers are coming into the North and creameries are being established in many places. Agricultural production in B.C. has jumped so that there was a decrease of 28 per cent. last year in produce imported into this country."

"Are these things worth while? Were these things accomplished by an idle government?"
Muckrakers
 Mr. Manson asserted that Mr. Bowser and Mr. Stevens were too busy grubbing around in the mire and muck to realize these things.

He also said that Mr. Bowser and Mr. Stevens "realize that if this Government has made mistakes, they have been minor mistakes, not graft or scandals."
 "They realize that the legislation of the Government has been sound and administration has been clean and for that reason they find it necessary for them to grub around in the muck and mire."

Picayune Matters
 "Thirteen years of sleeping across the Bay under the Conservatives and no thought for any of the industries of B.C., no thought except that of spend, spend, spend on marble halls, and Italian marble roofs. Not a thought for tomorrow or the next generation. Isn't that the sort of government you would expect from the picayune utterances of such men when they get on the platform. Surely in the Province of B.C. you have got something bigger than the

trivialities you hear from Mr. Bowser.

"Hasn't the time gone by in public life in Canada when we ought to be capable of bigger things and better things than one hears from the mouths of the men who are leading the opposition at the present time."

"There are such works this Government has undertaken as the reclamation of the 32,000 acres at Sumas. When it is through you will have a monument to the foresight of Mr. Barrow. Land which has been subjected to the ravages of the Veddar and Fraser next year will be producing as only silt land can produce under intensive cultivation.

"The children of miners and scattered settlers ought to have even better education than children with the advantages of the cities. Theirs is a harder lot and the state owes it to them."

A Half-Baked Plan
 "As for the university, a monument of extravagance was the thing Mr. Bowser had established for you. The University was what Mr. Bowser also left. It was a half-baked plan, costing for buildings alone \$5,000,000.

"I am a university man myself, but I am not so sure that we have not just a few too many white-collared highly educated persons in B.C. I believe in university education for the man who is capable of being educated, but not for the man who might be better in some other occupation in life.

"We have done absolute marvels in the last five years in the construction of highways in B.C. and in outlying ridings there is much yet to be done."

"The problem of the railway, a heritage handed down to us, was one of those things all patched and torn and condemned. There was no excuse for the handling of the finances of that railway."

"Why does anyone in public life need to say what is untrue. Mr. Stevens and Mr. Bowser say that we spent \$21,000,000 on that road since the Oliver government came in. The fact is that the annual interest charges on what Mr. Bowser spent there eats up most of that \$21,

000,000.

A Challenge
 "Has there been a single time in the last five years of the Legislature when anyone has been able to point a hand and say that there has been waste or improper expenditure?"

"As for taxes, bless my soul, no Government would be happier than if they could say that the taxes would be nil. You people of B.C. have imposed these taxes. You demand these services. If you want these things you must pay for them."

Mr. Manson declared that the Oriental problem was a menace that was getting more real every year. He said that one was amused at the party that sat for eleven years in the seats of the mightily at Ottawa without accomplishing anything and then met in Vancouver and passed the most exacting and definite resolutions, when they were put out in the cold. "They must put their shoulder to the wheel and be practical," he added.

"As long as the Conservative party does as it is doing then the Liberal party will be in power for twenty-five years," he concluded.

The tender of Yarrows Ltd. Victoria, for supplying an oil tank of 13,000 gallons capacity, for the city electric light department, at a cost of \$315,000 delivered at Prince Rupert was accepted by the City council last night.
