ALBERTA VOTES FOR GOVERNMENT CONTROL

LANDSLIDE AT ANYOX CARRIES AWAY BIG WATER MAIN; CAUSES SHUT DOWN

Shut Down at Anyox Caused by Land Slide Residents are Removed

(Special Despatch to Daily News)
ANYOX, Nov. 6.—As a result of the heavy rains which commenced Saturday a landslide occurred here which swept away about fifty feet of the big six foot wooden stave flow pipe between the dam and the power house necessitating the closing down of operations at the mine and smelter for at least a week while repairs are being made.

On Sunday morning, owing to the continued downpour and the fact that the water was rising rapidly behind the almost finished Estwood multiple type dam on which so much depends, orders were given for the removal of all families from the flats section of the town and within a few hours all had been billeted with families at the mine and higher sections of the beach area.

While it is not expected that anything serious will happen, the families were moved purely as a precautionary measure in order to be on the safe side with no possibility of a repetition of the Britannia disaster of a couple of winters ago.

The residents of the flats will remain in the homes to which they have been allotted until the rain stops.

The rain started Saturday morning and between that time and Monday morning ten inches was recorded. It kept a steady downpour during Saturday and Sunday steady up a little yesterday.

NEGOTIATIONS ARE REFUSED IN VANCOUVER

Shipping Federation Says Business of Port Being Handled Satisfactorily

OTTAWA, Nov. 6.—The minister of labor has received a report from F. E. Harrison, the department's fair wage officer at Vancouver, that the shipping federation declined to reinstate all the longshoremen now on strike in that city.

The report stated that the federation would agree to re-employ strikers as fast as possible but that the federation claimed the business of the port was being handled satisfactorily.

The federation also refused to negotiate with the international longshoremen's union.

A reply has been sent by the department agent at Vancouver by Mr. Murdoch intimating that he still stands ready to appoint a board of conciliation if it is found necessary.

ROVER STRUCK LEAKS LITTLE

Is at Duncan Bay and May Come to Prince Rupert to Dock

VICTORIA, Nov. 6.—The C. G. M. steamship Canadian Rover struck bottom while en route from Vancouver to Ocean Falls in a heavy fog when passing up Discovery passage. She proceeded to Duncan Bay where it was discovered that she was leaking slightly. She will go to Prince Rupert for survey.



Government Control of Liquor Traffic Carries in Alberta; has Majority of Approximately 30,000

LONDON, Nov. 6.—Great interest is being taken in the local option voting in Scotland which opened yesterday at Falkirk. There the anti-prohibition or "no change" party obtained an absolute majority in all five wards. Voting in 26 other towns today.

GALGARY, Nov. 6.—In by far the largest vote ever polled in Alberta on the liquor question, prohibition yesterday was beaten decisively.

Seven years ago the province gave a dry majority of 20,000 in a total vote of 95,000 on the abolition of the retail sale of liquor.

In 1920 the matter of importation came up and with a total vote of 106,000 there was a majority against importation of 18,596.

Yesterday's vote will go close to 150,000 and the majority will approach 30,000 when the returns are complete.

There are 52 provincial constituencies and on the incomplete returns this morning there appears to be a majority for government control in 36 of them including four cities, Calgary, Edmonton, Lethbridge and Medicine Hat.

The city of Calgary voted two to one for government control Clause D., which the voters favored by casting their ballots means: "Sale of all liquor by or through Government vendors; beer to be consumed on licensed premises and in private residences; wine and spirits to be purchased in limited quantities under a permit issued by the Government under government control and regulation."

Commenting on the result the Albertan of this city which supported prohibition says: "People were tired of prohibition. They lost patience with it. The reaction has come and for another period at least we must return to the liquor traffic."

In Edmonton with a few scattered polls to be heard from the majority ten for D. over A. (prohibition) was 4,500. In Calgary the majority for D was 8,158.

WANT REMISSION OF GATE RECEIPTS AT AMATEUR SPORT EVENTS

VICTORIA, Nov. 6.—Amateur sport officials yesterday urged Premier Oliver to remit the amusement taxes on gate receipts at amateur games. The premier promised to give consideration to the request.

Good Progress Made on Canadian National Railways is Shown by Financial Statement just Issued

OTTAWA, Nov. 6.—A good showing has been made by the Canadian National Railways for the year so far and the record of gains is kept up right to the end of the month of October. There have been increases all along the line but the operating profits still come from United States lines, the Canadian lines showing a slight loss on operation so far.

The Canadian National Railways turned in a net operating revenue of \$5,011,845 in eight months of the present year ending August 31. Last year for the same period of 1922 the operations resulted in a net deficit of \$1,166,098.

This year there was a deficit of \$1,501,387 on Canadian lines of the system but the operations on the United States lines showed a surplus of \$6,063,233.

During the eight months of 1922 the Canadian lines turned in a deficit of \$4,689,139, while the net revenue on United States lines was only \$3,535,030. During the same period the Canadian Pacific Railway showed a net operating revenue of \$13,336,464 as compared with \$14,861,921 in 1922.

The gross operating revenue on the Canadian Pacific Railways during the eight months of the present year totalled \$112,938,967, an increase over 1922 when there were \$108,232,426. Operating expenses, however, showed a greater increase than revenues. For the eight months period of 1923, they totalled \$99,602,503 as against \$93,370,505 in 1922.

The gross operating revenues on Canadian lines of the Canadian National increased from \$122,488,292 in the eight months period of 1922 to \$133,902,913 in 1923. On United States lines the increase was from \$20,019,454 to \$25,846,906.

The operating expenses on Canadian lines this year totalled \$134,954,301 as against \$127,177,431 last year. On United States lines the operating expenses rose from \$16,496,414 in 1922 to \$19,783,668 in 1923.

The net operating revenue on all Canadian railways during the eight months was \$24,209,284 as against \$16,693,198 in 1922.

MONTREAL, Nov. 6.—The gross earnings of the Canadian National Railways for the week ending October 31, 1923 were \$8,967,537, being an increase of \$1,138,223 or fifteen per cent as compared with last year.

The gross earnings of the Canadian National Railways from January 1 to October 31, 1923, have been \$207,950,221, being an increase of \$18,583,566 compared with the corresponding period of 1922.

The gross revenues were \$286,805,062 and the operating expenses totalled \$263,595,778.

CANADIAN VOLUNTEER ON DRY DOCK TODAY

Local Yard Has Contract For General Machinery Overhaul — Hull is Also to be Inspected

C.G.M.M. steamer Canadian Volunteer was taken on the pontoon at the local dry dock at 10.30 this morning. The vessel will be in dock for about two weeks it is expected, the local yard having the contract for general machinery overhaul. An inspection of the hull following the recent stranding down the coast will also be made. Capt. W. H. Logan, representing Lloyds, and a steamboat inspector being due to arrive from the south tomorrow to conduct it. It is not yet known whether or not the hull repairs will be made here.

EARTHQUAKE CALIFORNIA

Imperial Valley Badly Shaken by Trembler Yesterday Afternoon

CALEXICO, California, Nov. 6.—Shattered windows, falling plaster, and building foundations out of joint, today reminded residents that yesterday's earthquake was the worst the Imperial Valley had experienced in several years. Three tremblers during the afternoon of pronounced violence left the re-reinforced concrete pillars twisted out of shape and a hotel several inches out of place on its foundations.

In the United States immigration station a portion of the ceiling fell and in Mexicali across the international border, brick and adobe walls left standing after the fire last July were toppled by the shock.

TRUE BILL IN ATKINS CASE

More Talesmen Added to List This Afternoon at Assize Court

This afternoon a true bill was brought in by the Grand Jury at the Supreme Court assizes in the case of Rex vs. Tommy Atkins in which the defendant is charged with the theft of a banjo valued at \$120. The trial is still proceeding.

FISH ARRIVALS

Halibut Fares Today Totalling 97,000 Pounds Include Catch of Trawler New England

MEN ENTOMBED IN MINE PROBABLY DEAD

CHARLESTOWN, W. V., Nov. 6.—Twelve bodies have been taken from the shaft of a mine of the Raleigh, Wyoming Coal Co., in which an explosion occurred today and little hope is entertained for thirty men still in the workings.

Investigation Into P.G.E. Charges.

Definite charges have been made against the management of the P.G.E. both in the legislature and outside and the provincial government has at once taken the matter in hand and appointed an independent auditor to investigate. Last year when the matter was mentioned in the legislature, the premier stated that any definite charges would be met but the government could not act upon rumors. There had to be some definite indication that there was something wrong before the government would be justified in putting the country to the expense of an investigation.

It is satisfactory that the charges made by General McRae and others are being met without delay. It is to be hoped and expected that the investigation will proceed immediately and that if there are any wrongdoers they will be punished.

Proud Gray Fleet Still Important.

The peace of the world to a very large extent still depends upon the proud gray fleet of Britain. While it sails the seas injustice and wrong will to a large extent be forced to hide its head. While mistakes are made in any human enterprise, the British fleet has generally stood ready to back the right against the wrong and has proved a powerful civilizing influence.

Free Trade Within Empire.

Premier Baldwin's scheme for free trade within the Empire is a most attractive one. It is described by some to be a seductive plan. At any rate it is following along the lines of the example set by Canada which has established a British preference that has been in force for many years, being first started during the Laurier regime. Laurier was often accused of toadying to Britain for extending the preference.

Should Great Britain and Ireland, Canada, Australia, New Zealand, South Africa, India and the more dependent parts of the Empire all enter into an arrangement for preferential trade relations, it would form a strong financial tie for imperial relations. Many people, however, fear that once the tie of finance is made to supersede the tie of sentiment, the Empire would be in danger.

The progress of the movement will be watched with much interest here for Canada would be vitally affected by any such arrangement as that proposed by Premier Baldwin.

Speed Mania Continues.

The despatches at the week end announced that all former speed records had been broken by a New York aviator who made the wonderful speed of 265 miles an hour. This speed mania is affecting us everywhere. Not only have we speeded up in our business methods, in our social life, in our general travel, but everywhere is seen advancement along these lines. The telegraph, telephone and radio have speeded up communication until it becomes almost instantaneous and travel promises to be expedited to such an extent as to excite wonder. It was only a few years ago when the fastest means of crossing the seas was by windjammer which took weeks or months to sail from one continent to another. Now we are promised a two day service across the Atlantic by airship.

GIVEN CHANCE PROVE CHARGE

Former Provincial Employee Will be Haled Before Public Accounts Committee

FARRIS TAKES HAND

VICTORIA, Nov. 5.—J. Rossiter, former employee of the railway department of the provincial government, who has been making alleged sensational charges in an affidavit in the "Searchlight," in the interest of General A. D. MacLae's Third Party, is to be haled before the Public Accounts Committee of the Legislature to prove some of his charges.

This was given out at the Parliament Buildings.

The Third Party attacks have been made against both the old parties of the Province.

In preparation for the lively time that will develop the public accounts committee is being strengthened by the addition of Mr. Farris, former Attorney-General, who is familiar with all railway affairs.

The battle over the railway question is likely to prove as bitter as that over the liquor.

Preparations are being made for the waging of some big battles this session before the Public Accounts Committee of the Legislature.

Makes Big Play

It is before this committee that a big play is always made by opposition forces to gain campaign material. Mr. Bowser and R. H. Pooley, who are leaders of the Conservative probing forces on the committee, said today that the committee, according to plans they are making would likely prove more lively than it was last year. Mr. Pooley said that he had gathered all sorts of liquor facts, both in Victoria and Vancouver, and on his trip north with Mr. Bowser, and he intends to start something if he can find anything to start.

It was explained at the Parliament Buildings today that rumors of an approaching election are acting as an incentive to fireworks before the committee. The battle will be waged chiefly over liquor board affairs.

CITY AUDITOR IS CRITICIZED

Too Much Emphasis Laid on Matter of Little Importance, Aid. Stephens Avers

Exception was taken by Aid. Stephens at last night's council meeting to a certain suggestion in the report of George Rorie, city auditor, urging again that accounts of the city utilities department should be reconciled with the other city books. Aid. Stephens defended the treasurer's department against the claim that the reconciliation was behind and expressed the opinion that the auditor was unduly harsh with the present staff, particularly when it was remembered that this particular work in past years had always been so far behind. He felt that the criticism of the auditor should be of a constructive instead of a destructive nature and should lead to a better and simpler method of book-keeping. He would like to have figures at the end of the year showing what the reconciliation of these accounts had meant and how much had been saved to the city thereby.

Besides making this suggestion, the auditor's report stated that an audit had been completed up to September 30 and the cash and books had been found to be up to date. The auditor also urged the taking of an inventory of the city's stock at an early date to assist in getting out the annual report.

City Treasurer Matheson felt that, although the matter of reconciliation seemed big in this report, it really did not amount to very much. It was questionable if the cost of making the reconciliation was warranted in the results that were obtained by means of it. It entailed a great deal of clerical work for the elimination of which some method might be devised.

The report was referred to the finance committee with power to act.

HALF BURNED LETTER REACHES DESTINATION

Dynamited and Burned by Train Robbers But Eventually Comes Back to M. M. Stephens

The efficiency of the United States postal department is indicated in the delivery of a letter recently sent from this city by M. M. Stephens & Co. Ltd., local realtors, to one of the firm's clients, Dr. A. A. MacIntyre, a former alderman of this city who is now practising dentistry at Glendale, Oregon. The letter in question went through a mail robbery on the Ashland and Gerber train at Siskiyou, Oregon, on October 11. The car was dynamited and fired and the letter was half burned, the envelope coming through with only the name of Dr. MacIntyre and his street address on it. The name of the city had been burned away as had also been the address on the letter inside. The letter went on to postal headquarters at San Francisco from whence it was forwarded to Dr. MacIntyre. It was returned to the local firm by Dr. MacIntyre as a curio.

OFFICERS OF MUNICIPAL CHAPTER HAVE RESIGNED



SALE OF LOT IS QUESTION

Squabble in City Council Over Right of Ald. Collart to Purchase

RESOLUTION TO RESCIND Much Discussion Before Matter is Laid Over For Legal Advice

Rumblings of an impending mayoralty contest were distinctly audible at last night's council meeting. A resolution submitted by Ald. Munro calling for the cancellation of a tax sale lot transaction earlier in the year in which Ald. Collart was involved as purchaser was taken by the alderman in question, Ald. Stephens and Ald. Macdonald as a personal attack against Ald. Collart and some rather heated words were the result. The resolution, which was finally laid on the table pending legal advice being obtained with respect to it, was as follows:

"Whereas a resolution was passed in the city council on April 9, 1923, as follows:

"Your finance committee recommends that lot 76, block 20, section 2, be sold to Paul Taillandier if found in order for the sum of \$150;

"And whereas the city council has no legal authority to sell the property in this manner and Paul Taillandier has not presented himself to purchase the property;

"I move the above resolution be rescinded."

In order to bring the resolution up for discussion, it was seconded by Ald. Mackenzie.

Fish and Flesh

Ald. Stephens said he would like to ask the Sheriff Holmes of the council what he intended to do with two other lots that were voted upon earlier in the year in a similar manner. He did not see why he should make fish of one and flesh of another.

Ald. Munro replied that the other transactions were probably illegal also, though he did not think the circumstances attending them were similar to this one. This lot had not been purchased by Paul Taillandier, the man who made the offer for it.

"I think that it would be very proper for Ald. Collart to second this resolution as it may get him out of a very serious difficulty which might mean his disqualification and a penalty of \$2,500. I have no doubt that the transaction is not in order and that it must be rescinded. Possibly, it is a good thing for Ald. Collart that it can be rescinded."

For Legal Advice

In suggesting that the resolution be laid over for legal advice, Ald. Macdonald ventured the opinion that it was not meant to help Ald. Collart and that it would possibly have never been presented had Ald. Collart not purchased the lot in question. He did not hold any brief for Ald. Collart but he would continue to give each and every alderman a square deal. Ald. Collart had made an open and square offer for the lot in question after the bidder had failed to call for it.

Ald. Stephens stated that he did not understand at first that a personal attack was being launched. Apparently Ald. Munro was not after Paul Taillandier but someone else. "Ald. Munro should be man enough to come and take his share of the blame for the transaction instead of seeking to draw other people into it. I do not think he raises himself in the opinion of this council or anybody else when he takes the credit for detective work done by ex-Ald. Hamilton Douglas

when he was here last summer. He could have found at least two other errors for a similar nature."

Sympathy For Collart

"There seems to be a lot of sympathy for Ald. Collart from two other members of the council," replied Ald. Munro. "This deal must come out, however, and perhaps not at as opportune a time for Ald. Collart as now. Any taxpayer could enter an action. I did not suggest any detective work on my part and it is not an attack on Ald. Collart personally. The resolution is a result of looking up and comparing the price that was paid for this lot and the offer from Mr. Shrubbsall, which has been turned down for another. The council has done something that is not according to law and it seems to me that it is the duty of every alderman to see that it is rectified."

Ald. Macdonald suggested that a grand stand play was possibly being enacted as a preliminary to the mayoralty campaign. The time to bring such a resolution as this forward would have been when the mistake was first discovered, he felt.

Stephens to Rescue

"Though I am an announced opponent of Ald. Collart for the mayoralty I have enough confidence in his integrity to believe that our fight will be a clean and square one," stated Ald. Stephens, "and I sympathize with him tonight because I look upon this as a despicable act directed by one alderman against another and one that cannot be defended upon the public platform. If the matter is carried into the mayoralty contest I can assure the one who launches it that I will not treat him with the same consideration as I would the aspirant who fights squarely."

"That there are many good mineral lodes in the Atlin country has been proved," said Mr. Pillman, "but one found there has to be very rich to permit of its transportation to smelters on account of the necessity for its frequent handling and the short season of inland navigation. Something like 150 miles of railroad would connect Atlin with tide water on Taku Inlet. Such a road would open a very valuable district and bring it into close business and industrial relations with Juneau."

BARBERS PREPARING TO GET LAW PASSED PUBLIC PROTECTION

VICTORIA, Nov. 6. — British Columbia barbers will start their fight for the passage of a law to make barbering a profession shortly. They will base their argument in favor of such a law on the necessity of keeping all barber shops in a sanitary condition. The average shaving public is very conscious of the fact that a dirty barber shop and an untidy, incompetent barber, is a menace not only to the public health, but to the general stability of the profession, says a statement given out by barbers sponsoring the new law. The intelligent public knows that a law calling for the maximum perfection in sanitation and efficiency of workmanship at the minimum of expense on the part of the barber and with no added expense to the public, will have a tendency to lift this stigma from the profession.

"The proposed requirements and regulations make the public protection the first consideration, assuring the public, in small towns and cities, the same sanitary protection and efficiency of workmanship observed in barber shops of larger cities. For the protection of the profession itself, it will have the same influence over the barber as the Medical Act has over the medical profession."


