FARTHER WEST RAIL OUTLET FAVORED HERE

CANADIAN FREIGHTER COMING HERE TO LOAD SALMON FOR UNITED KINGDOM

Prince Rupert Endorses Peace River Pass Route for Projected Railway

Matter Discussed with Hazelton Delegates at Meeting Yesterday Afternoon in City Hall

The Prince Rupert Board of Trade strongly favors the Peace River Pass for a railway tapping the Peace River country and endorsing it, but as to the route this side the mountains, they will commit themselves. Yesterday afternoon the council of the board met Dr. H. C. Wrinch and several other delegates from Hazelton, including C. H. Sawle, George Beirnes, W. S. Grant and P. Corrigan and talked the matter of railway route with them, examining maps and going into the matter as thoroughly as the information at hand permitted. The visiting delegation wished to have Prince Rupert and Hazelton unite on the Peace River-Hazelton route but the local board refused to commit itself to any particular outlet, confining itself to endorsing the Peace Pass as the most suitable.

ENGLISHMEN INTERESTED

Business Men Propose to Operate Gold Mine Discovered Durino Klondyke Rush

BOXBON, March 5. — Hard-pressed business men of Hull are proposing to search for gold in the Klondyke region. John Riley, now a commercial agent of that city, claims to have discovered while prospecting on the beaten track in Alaska the Klondyke rush. It is proposed to float a company in Vancouver and work the mine, obtaining samples of the ore. The use of an airplane in carrying the samples from Alaska to Vancouver is being considered.

MAN GOES UP MURDER CHARGE

Band Declares She Cut His Throat and He Identified Her in Act

NEW WESTMINSTER, Mar. 5. — Mrs. Maimie Gohel was committed for trial on a charge of attempted murder at their home in the city. Her husband, Paul, testified that his wife cut his throat while he slept but he positively identified her as his assailant. He said she had been unreasonably jealous of him despite the fact that he was not on speaking terms with the persons she attacked.

EAR SHOCKS OF EARTHQUAKE

Quarries in Quebec as Late as Yesterday Morning When Damage Resulted

QUEBEC, Mar. 5. — Earthquakes in the region of Saguenay have not yet ended, according to a message from Tadoussac yesterday afternoon which said: "The Saturday have had six or eight shocks every day. This morning had a very bad one. Chimneys and crockery were damaged. We are very much afraid."

B.C. SILVER LOOKS GOOD

C. A. Banks, Manager, Sends Promising Report to Principals of His Company

Possibility of a second great mine being developed beside the Premier Mine, on a body of ore belonging to the mineralized zone in which the Premier's big gold-silver deposit occurs, is raised by the announced discovery of a large ore body on the B.C. Silver Mine which adjoins the Premier.

C. A. Banks, manager of the property, who passed through the city yesterday on the Prince Rupert en route north, has sent the following letter to shareholders of the company in British Columbia and England:

"I have to inform you that diamond drilling from our No. 3 level has just intersected a very important ore body. The drill passed through 58 feet of ore, which, allowing for the dip of the vein, indicates an ore body of 45 feet in width.

"Ten feet of the drill core averaged \$2280, 12 feet averaged \$30 and 9 feet averaged \$40 per ton. The whole ore body is of commercial grade.

"Further drilling is being pushed ahead, to determine the extent of this ore body." The American Smelting & Refining Company, operators of the Premier Gold Mine, have a minority interest in the B.C. Silver Mine, but the control is in London, under the Selkwe Mining Corporation.

LIEUT. MACLEOD AT HAZELTON TO INSPECT MACHINE THAT POINT

On his way to Hazelton where he will inspect the Railway Employees' Investment and Industrial Association's monoplane Hazelton which it is proposed to put in operation this year carrying freight and passengers to the mining and big game hunting fields in the northern interior, Flight Lieutenant Earl MacLeod of Jericho Beach Station, Royal Canadian Air Force, Vancouver, was a passenger from Hazelton to Hazelton yesterday afternoon. Accompanying him was Mechanic N. C. Terry. Both of these men were here last summer with the aerial fisheries patrol. It has not yet been definitely decided whether such a patrol will again be conducted here this season.

PRINCE RUPERT CLUB NOT TO BE LOWERED

Proposal From City Will Not be Accepted, It Was Decided at Meeting Last Night

At a general meeting of the Prince Rupert Club last night, it was decided not to proceed at this time with the lowering of the club from its elevated position on the knoll on Second Avenue. The city had adopted a proposition whereby it would remove the rock in return for a transfer of frontage from the club. The club has deemed that there is nothing particular to be gained by it in having the building lowered now.

Mr. and Mrs. C. W. Poole, who arrived from Buckley Bay at the first of the week, will sail tomorrow morning on the Prince Rupert for Vancouver.

Air Service Planned for Dease Lake Country in Spring when Several Machines to Operate

VANCOUVER, Mar. 5.—There is to be an air service from tidewater to the gold diggings in the Dease Lake country. An organization headed by Major Donald MacLaren is planning to give this service by means of air boats and will later extend the service to other parts of the north.

The former "war ace" it is understood will have several machines in the service capable of carrying from 1200 to 1500 pounds each of freight. In maintaining it he will be aided by a government subsidy for carrying mail and a guarantee by large operators.

C.G.M.M. Steamer Due Here Tomorrow Morning; Will take on Fish Shipment for England

C.G.M.M. Steamer Canadian Freighter, Capt. Carl Bissell, is due here at 7 o'clock tomorrow morning from Vancouver to load 100 tons of frozen salmon for the United Kingdom from the Canadian Fish & Cold Storage Co. It will take about twenty-four hours to take on the shipment it is understood.

The Canadian Freighter just recently arrived from Vancouver from the Old Country after having made a speedy voyage. The last time the vessel was here she loaded lumber for Japan. Since then she has been transferred to the Pacific Coast-United Kingdom service. She will return from here to Vancouver to complete.

This will be the first direct fish shipment that has ever been from here to the United Kingdom.

WALK OUT BY LABOR

Ex-Premier of Britain and His Followers Quit House of Commons

LONDON, Mar. 5.—The entire Labor delegation in parliament, headed by former Premier Ramsay MacDonald, walked out of the House today when the speaker ordered that David Kirkwood, a Scottish member, leave the chamber after interrupting a speech by Foreign Secretary Chamberlain. The ministerial benches greeted the exodus with cheers.

BANK OF ENGLAND AVANCES RATE OF DISCOUNT TO FIVE

LONDON, Mar. 5.—The Bank of England today raised its discount rate to five per cent. This is confirmation of the bank's action last Friday, when loan charges were raised following advance of the rediscount rate in New York.

Prince Rupert Board of Trade Endorses Proposal to Establish Milk Products Depot in this City

The Council of the Board of Trade, G. W. Nickerson presiding, last night endorsed the movement recently initiated in the Bulkley Valley to have a distributing depot established at Prince Rupert. The matter was explained to them by Dr. H. C. Wrinch, M.L.A. He suggested humorously that Bulkley Valley milk would be much more useful than the beer it was proposed to give here.

A creamery at Telkwa had been suggested but he did not agree with that. The authorities of the agricultural department at Victoria urged, and he was in agreement with them, that the milk should be taken to the point of distribution as was done with the Fraser Valley milk, all of which was sent to Vancouver for distribution.

The people of the Bulkley now agreed that this was the best thing to do and they had taken the matter up with the government with an endeavor to get the creamery policy changed. What he suggested was that the government should open a depot here and operate it for several years until the herds in the interior were established. Then it could be run as a co-operative institution as was done in connection with the Fraser Valley. They wanted to give Prince Rupert cheaper milk and better service.

Dr. Wrinch explained that whereas the average milk consumption was ten ounces a day for each person, normally, the consumption here was only two and a half ounces. The new concern, if established, would endeavor to create a demand. It would not be an expensive project but it would give the farmers the quickest possible returns.

The matter was under consideration by Smithers, and Telkwa was enthusiastic over it. He asked for the endorsement of the Prince Rupert Board if they approved it.

F. G. Dawson moved and Mayor Newton seconded that the move be endorsed and it was carried by acclamation.

NOVA SCOTIA COAL STRIKE

GLACE BAY, March 5. — J. W. McLeod, district president of the United Mine Workers of America, announced this afternoon that cessation of work throughout the Nova Scotia coal fields had been ordered to commence at 11 o'clock tomorrow night.

ALREADY GETTING READY FOR OPENING OF CANNING SEASON

Preparations are already under way for the salmon canning season in this district. The sockeye season will open on June 20 but, in the meantime, it is expected that some of the plants will open to can and mild cure spring salmon.

Crews have arrived at Oceanic, Balmoral and Sunnyside and other canneries will have their first men coming from the south next week.

The crew for Naas Harbor cannery will be here on Sunday night, G. Chambers, the manager, having already been here since last week.

SCALDED SELF BOILING WATER

Flesh Peeled from Feet and Legs and Death Came at Last

DAWSON, Mar. 5.—Bernard Marsch, 64 years of age, who has been a miner since the stampede of 1898 is dead here as a result of an accident two years ago when he fell feet first into boiling water while helping a friend on Hunker Creek thaw ground with hot water. The flesh was boiled off the soles of his feet exposing the bones and peeled off his legs from above the knees. The doctors marvelled that he lived so long.

PEASANTS GET TWO REPORTERS

Recurrence of Murders of Newspaper Correspondents Causes Anxiety

MOSCOW, March 5.—Recurrence of murders of newspaper correspondents by peasants is causing anxiety to the Government. Three peasants were executed yesterday near Odessa for killing the correspondent of a provincial paper. The executions were scarcely over when word was received of another murder near here of a correspondent, whose duty it had been to report local conditions.

PICTURES SENT BY TELEGRAPH

Afternoon Editions of San Francisco Papers Had Illustrations of Inauguration

SAN FRANCISCO, Mar. 5.—Photographs of the Washington ceremonies yesterday morning appeared in the early editions of the afternoon papers here, transmitted by wire over 3,000 miles. Pictures completed here 50 minutes after they were snapped at Washington were as clear as if taken from the camera.

Distributing Depot For Milk Here.

The proposal to establish a milk distributing depot at this city for the farmers of the interior is one which must commend itself to everyone. Prince Rupert is the natural market and it would be a great benefit to the city to increase its milk supply. As explained, for various reasons the consumption of fresh milk here is only one fourth of normal. It would be the aim of the farmers to increase this and not to put existing milk supply houses out of business.

For some cause the Vanderhoof creamery has proved a financial failure. That tends to discourage the establishment of small creameries. The history of the south also is in favor of the establishment of a large receiving depot at the point of distribution. That is the plan adopted in the Old Country.

The only point at issue is as to how much of the preliminary work should be undertaken by the Provincial Government. At present they undertake to establish creameries at country points and after a year hand them over to a local company formed from among the shippers. What is asked is that they take similar action in regard to a distributing depot here but that they operate it longer than a year.

Coolidge Speech Very Interesting.

The address given by President Coolidge on the occasion of his inauguration seems to have been a most interesting one. While all that was received here was a very short summary, it was sufficient to indicate the general trend.

The speech was right in line with former Premier Macdonald of Great Britain in his opposition to competitive armaments and his advocacy of a world court, and a general policy of friendship and goodwill. In many respects, too, the speech was very conservative and sometimes reactionary. It urged continuation of the policy of protective tariffs, expressed opposition to any form of public ownership, and also opposed the taxing of big incomes, such, it is to be presumed, as is done in Canada where there is a sliding scale.

Graduated Tax On Large Incomes.

Great Britain has a graduated tax on large incomes and on very large incomes the state collects a big proportion as its share. It also collects large sums from inheritance taxes, graduated according to the amount. This graduated system is the modern method of restricting incomes and giving the state an opportunity to collect some money without injuring anyone.

People of radical tendencies have advocated the limitation of incomes, giving the state the right to take everything above a certain limit.

Hazelton And Rupert Got Together Yesterday.

Hazelton and Prince Rupert people got together yesterday and talked over railway matters with great benefit to the people of both places. That is the right thing to do. We all would be better if we could meet out of town neighbors oftener. Distance is the main stumbling block. It costs a good deal and takes much time. The result is that we often fail to appreciate what they are doing and the efforts they are making in the development of the country.

ZANNI AFTER TIME RECORD

Argentinean Aviator Coming Here this Year has Some Perilous Hops Ahead

When Capt. Pedro Zanni, the Argentinean aviator, leaves Minto, Japan, on May 1, to complete his round the world flight, it will become an attempt to shatter the round-the-world speed record. When this trip was first contemplated by aviators it was only with the object to make the trip, not a question of speed. But aviation is rapidly advancing, and this is only one indication that it will soon be one of the great commercial transportation enterprises.

In his attempt to shatter the world's flight record Zanni is taking some daring risks, foremost among which are non-stop flights across from Vancouver to San Francisco, from San Francisco to New York, and the most daring and perilous of all the 2,300 mile jump from Newfoundland to Cork, Ireland, an adventure that has not been tried since Harry Hawker made the trip in 1919 in the record time of sixteen hours and twenty-three minutes. Zanni, according to his representative, Mr. Patricio D. Murphy, of the Argentine Legation at Tokyo, who arrived on this coast recently to make arrangements for the flight, and who will visit Prince Rupert shortly, figures that he can make the Atlantic flight in seventeen hours, probably less.

A Gruelling Test

In any event it will be the most gruelling test of the entire flight, inasmuch that it will be a 2,300 mile journey without one place on which to land should there be engine trouble and unfavorable weather conditions. Dense fog banks are not uncommon over the Atlantic while a landing in the sea even if the plane is equipped with pontoons, which change will probably be made, would probably be fatal. The sea is by no means calm, and the expedition might not get off so lucky as did Harry Hawker, who was forced down when almost in sight of the Irish coast.

Has Fokker Aeroplane

Zanni is equipped with a Fokker aeroplane with Napier 350 horse power engines, which has a cruising speed of 110 miles an hour. At Vancouver there is a new machine and a spare engine in case the present plane gets smashed. This machine is also of the same type.

In making the transpacific flight, Zanni will take the same course as the American and British flyers, namely, by way of the Aleutian Islands, making definite stops at Dutch Harbor, Siska, Prince Rupert and conditional stops at other stations that will be placed along the route. From Prince Rupert they will jump to Vancouver, and from that port their journey will be nothing but a series of non-stop trips, first to San Francisco then to New York, then to Newfoundland and from Newfoundland to Cork, Ireland. From Cork Zanni will then proceed to Amsterdam, his starting-off point.

Part of Trip Done

Captain Zanni, accompanied by Lieut. E. Velo and Mechanic F. Beltrame, has already completed 12,000 miles of his trip, doing the journey during the worst time of the year, passing through the tropical regions during the heavy rainy season. It was this that delayed his trans-pacific flight. It was at Hanoi that his plane came to grief when he tried to take off from the airdrome field with the wheels of the plane up to the hubs in water. The plane has taxied the whole length of the field and was unable to rise. When it struck the paddy field it somersaulted and threw its passengers out and damaged the plane. New parts had to be installed. When this was completed and Zanni finally got to Tokio the winter season had set in, thus putting an end to his trans-pacific flight that year.

Ahead of Doisy

Nevertheless as actual flying time goes Zanni is ahead of all other records set by the famous French flyer Pelletier Doisy, the American squadron or the British aviators. He has completed half the trip around the world in 145 hours, the quickest time yet achieved. Zanni left months af-

ter the British expedition and also after Doisy, but he managed to pass the French flier at Calcutta, and despite the fact that he took a longer route than Pelletier, he arrived at Hanoi five hours ahead of the French flier. At that stage of his journey he was only a few hops away from the British fliers when they came to grief on the Pribiloff Islands. Had the accident at Hanoi not occurred there is no doubt that he would have overtaken these fliers at the rate he was going. For the same distance he was also ahead of the American fliers as far as time is concerned.

Ten Years Ago in Prince Rupert

March 5, 1915

The last chapter in what is said to have been one of the most pathetic tragedies ever recorded in the Canadian north-west has come to light. Three young Americans, seeking adventure and a livelihood, arrived at Prince George. Two of them, Walter Sisson and Frank Carlson from Peoria, Ill., were drowned in the Fraser rapids and the third, Richard Bonnie of St. Louis, Mo., was killed in a train accident.

BERLIN, Mar. 5.—Count Luckner, commander of the See Adler, the disguised German cruiser which had such a sensational career as a privateer in the Atlantic and Pacific during the World War, has returned from a lecture tour in Switzerland and is now planning to make a voyage around the world in a sailing ship.

The See Adler left Germany in December of 1916 and seized 13 ships before it finally stranded near Mopha Island, in the South Seas, in August, 1917. Count Luckner and five members of his crew traveled 2,300 miles in an open boat and were finally arrested by the Australian authorities.

BRITISH WOULD HAVE A BOXER

Kind of Man Who Would Succeed if Trained is Described SHOULD BE LEGAL

Whole Time Required to Make a Champion Who Could Win Laurels

(By Canadian Press)
LONDON, March 5.—The ideal type of boxer and the reason that Great Britain is not represented in the group of leading heavy-weight boxers in the world, is described by Lieut. Commander, the Hon. J. M. Kenworthy, R.N., M.P., for Central Hull, in a letter to the press recently.

Commander Kenworthy, who himself is a boxer of note, having been for three years champion heavyweight (officers) of the British Navy, says that it is a matter for grave concern among British sportsmen that all the first class boxers of today are non-British and that for two generations no British boxer able to capture the world's heavyweight championship has been produced.

Raw Material

"We have the raw material among our splendid manhood," the Commander writes, "but, just as there is big money in boxing, so big money is needed to bring out the best talent and to train it for the years necessary for even a good man to enter the first class." Given a youngster of the right type, he must be prepared to make boxing a life time pursuit; and in order to attract the big money required the sport must be put on a much firmer foundation than at present.

For a man to be a champion heavyweight he must not only be big, but of the right build and very strong; thick necked, broad-shouldered, with hands not too large but very firm, and the distance from the end of the wrist to the knuckles must be short. Long-faced men are of no use; a possible champion must be square or round-faced with no very prominent feature. Our future champion must have great speed and above all, quickness of brain. High intelligence is needed and educated men with the required physique have the advantage over uneducated or partly educated men. Men who take up boxing must live cleanly, be temperate and of good and cool temper. Boxers are seldom violent in private life and the man who loses his temper is of no use for the ring.

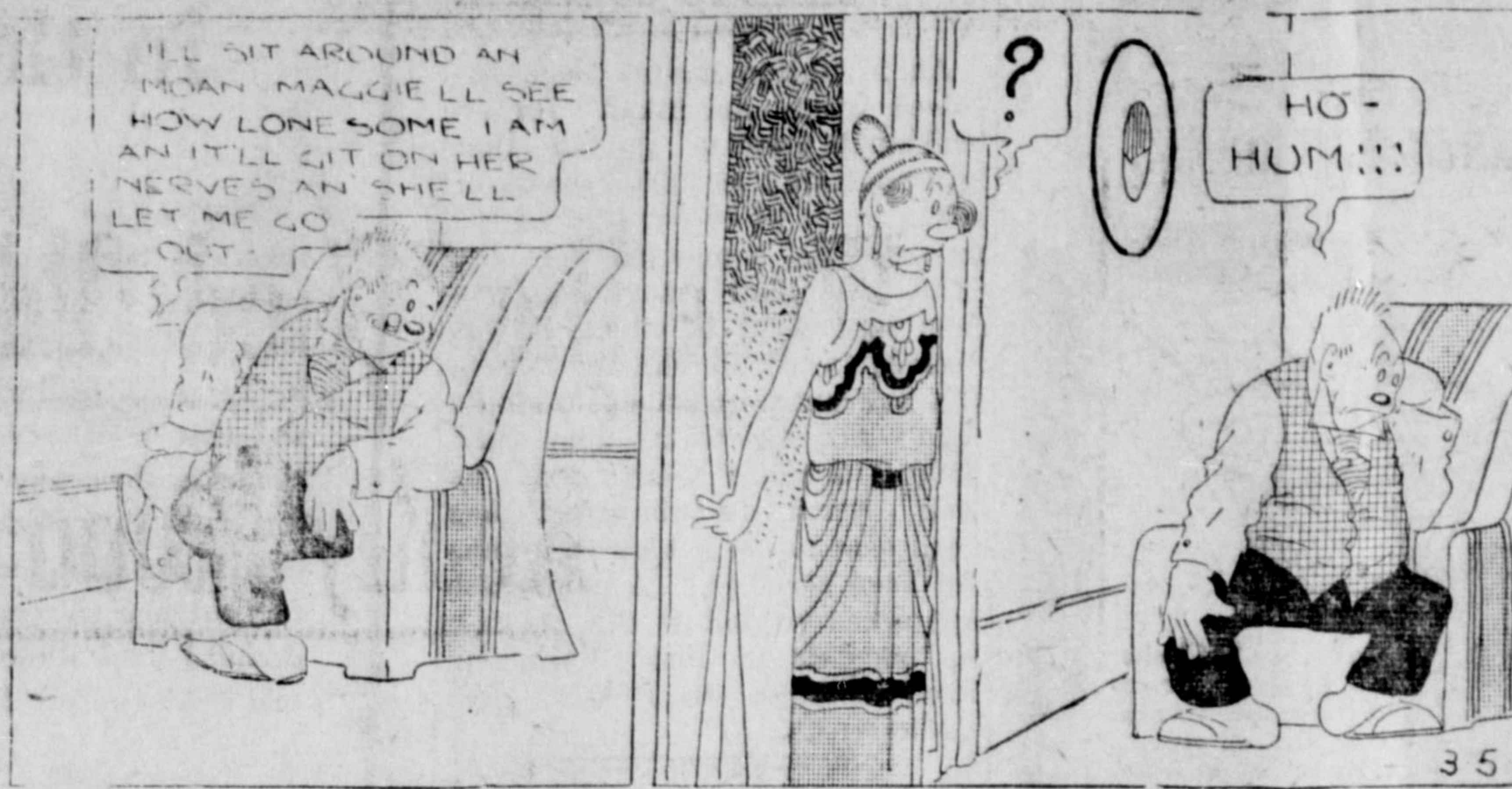
His Training

"Having found our man, he must devote his whole career to boxing; training and boxing every day under the tuition of one of the greatest masters of ring-craft, with a number of first class sparring partners always available. This all costs money and the required amount cannot be obtained while boxing remains illegal. Modern boxing is a typically British sport and our methods have spread and been copied by every sporting nation in the world. There is no more betting on boxing than on other sports and it brings much revenue to the state through the entertainment tax. The sport is no more dangerous than football and is less hazardous than fox-hunting and steeplechasing. It is high time that the anomaly of the illegality of British boxing should be removed. Parliament, I believe, should step in and end it. If this were done and the sport given a little official encouragement, apart from the splendid example set up by the King and the Royal Prince, British boxing would look up and a British heavyweight fit for the championship class would emerge.

Sport Chat

Prize fights and boxing contests were early regarded as contrary to law in England. Various statutes were passed from time to time as far back as the reign of Richard II, prohibiting various games and even football, at one time, was specifically prohibited. The present state of the law as regards boxing in the Old Country is: "In deciding whether a particular boxing contest is illegal or legal, it is necessary to examine the intentions of the combatants. If their real object is to inflict such injuries as to prevent him either from these injuries or exhaus-

tion from carrying on the contest, then the contest is illegal." There are elastic laws to punish all connected with a boxing bout that has been found to be illegal and even the railway companies conveying persons to such a prize fight are liable to a fine of not more than £500 and not less than £200.

Young Stribling, who is described as the most sensational boxer of the decade and who is often mentioned as a contender for the heavyweight boxing crown, is only 29 years old and has been boxing professionally for little over three years but, in that time, he has boxed some of the greatest pugilists in the game such as Mike McTigue, Ad Stone, Paul Berlenbach, Tony Marullo and many others. He says the greatest victory he ever won, however, was a ten round scrap with a basher named Red Herring who, at the start of the battle, handed him a vicious jolt on the nose which shook him to his heels and from which he did not recover until the seventh round. Eventually, Stribling got the decision.

INSPECTOR PARSONS RETURNING TO WEST

Has in Custody Sowash, Alleged Hi-jack Murderer, Whom He Arrested in New Orleans

T. W. S. Parsons, local inspector of provincial police, according to despatches in southern papers, is on his way from New Orleans to Vancouver having in custody Harry F. Sowash who is wanted on a charge of murder in connection with the double killing of Capt. W. T. Gillis and his son, William, who were slain when a supposed hi-jacking raid was made on their launch, Beryl G., last September. Sowash was arrested in New Orleans by Inspector Parsons after having been apprehended by detectives of that city. "Cannon Ball" Baker is already at Vancouver under arrest on a

similar charge having been brought west from New York by Inspector Dunwoodie. Charlie Morris, the third defendant in the same case, is being held in Seattle where he is fighting extradition.

GLOOMY DEAN AND PORTS OF PACIFIC

Inge Says Pacific Trade Will be as Important as That of Atlantic

Dean Inge says that in the future Pacific trade will be as important as Atlantic trade, and that reason nothing can prevent North America from being the centre of the world's commerce, according to a Victoria paper. This prediction has not been gloom which is commonly ascribed to the Dean's utterances. Certainly Canada has no reason to be alarmed over the growth of Pacific trade, even at the expense of the supremacy of the Atlantic. Canada has a long coast line and splendid ports on the Pacific. British Columbia is a province of rich and varied resources, and back of it is one of the granaries of the world. The shipment of wheat through an easy grade in the Rocky Mountains is the beginning of a movement fraught with tremendous consequences, not only for Pacific trade, but for the development of British Columbia and the adjacent prairie country. Canada is just as well equipped for trade on that side of the continent as on the east, and can look forward cheerfully to the fulfillment of the prediction of Dean Inge.

SCOTTISH BISHOP IS OPPOSED TO CONTROL OF BIRTH IN BRITAIN

EDINBURGH, Mar. 5.—Speaking on birth restriction at a meeting of the Edinburgh diocese of the Episcopal church, Bishop Walpole said "that it is quite clear to my mind that Great Britain should follow America and France and prohibit the use of contraceptives in order that our place among the nations may be preserved." The bishop had previously pointed out that conditions now are what they were 50 years ago. Forty per cent of divorces occurred in those families where there were no children, he said, adding that he believed that in only a small proportion of these cases were children impossible. Divorce, he said, hardly ever occurred where there was a "reasonable" family.

Jackie Coogan as a little Belgian boy with baggy trousers, funny little cap, great, clumsy, clattering wooden shoes and patched jacket with large buttons of assorted shapes and sizes—Jackie Coogan as little Nello, the immortal hero of Guida's story, is to be seen here at the week end.

Jackie's medium in this, his second Metro picture, is "A Boy of Flanders," adapted from Guida's story, "A Dog of Flanders," and the adaptation has been made with the greatest skill. The story is reproduced on the screen with a fidelity rarely to be observed and not a single episode of significance, drama, comedy, pathos or thrill is missing. While the climax, in the snow storm that sweeps over Flanders fields and buries the Cathedral steps at Antwerp in a deep cover, is one of the most poignant and appealing that has ever been screened.

Never has Jackie appeared more effectively, and it is safe to say that in "A Boy of Flanders" he touches tragic heights never before revealed in any Jackie Coogan picture, while the comedy touches and humor of which his art is capable, are abundantly provided throughout the entire story.

All the implications found in Guida's too-short story have been developed into the flowering of a great drama, and only in an adjustment of the closing episodes is there the slightest departure from the original—and who could bear to see "A Boy of Flanders" if the hero should die out in the cold and the snow with his dead companion, the noble-hearted dog Petrasche as his only solace? Such an ending would be too harrowing.

As it is, the hearts of all those present are sufficiently wrung and there was a sigh of relief and then the joy of a great delight when—but you must see "A Boy of Flanders" for yourself, it is like fine music—it cannot be described. It is played with strokes that words cannot define nor explain. It is Jackie at his best, and it will add even to the fame that is already his.

Sir Henry Thornton had seen much of the country and it had been an eye opener to him. The difficulty with most of the routes was that they had no expert data to guide them. They did not know whether they were feasible or not. He believed the Peace Pass was feasible and there were numerous outlets.

Mayor Newton backed the proposal to unite on the Peace project and this was done. He suggested that the data presented by Hazelton be incorporated in the booklet they were preparing.

In closing, Dr. Winch thanked the Prince Rupert board for the reception given them and said he was particularly pleased at the sentiments expressed here.

W. S. Sargent thought there would be a better chance for success if they united on one route.

Mr. Nickerson, on behalf of the local board explained that their idea had been to oppose the Brule route. They would like the railway to come as far west as possible before joining the Canadian National. Their proposal and the one it had been decided to follow was to set out the various routes and not back

WILL ATTEMPT WORLD FLIGHT

Major de Pinedo, Italian Chief of Air Staff, Will Hop Off From Rome in May

ROME, March 5.—Major de Pinedo, Chief of the Air Staff, plans to hop off next May from Rome on a flight around the world, which will cover 35,625 miles, the way his route is planned.

The route he follows will include Athens, Egypt, the Red Sea, the southern coast of Asia, Tokio, the Pacific Archipelago and Sydney, Australia. His route from that point has yet to be arranged. This is an entirely new route, and will be of even more interest than former round-the-world flights, as there are some long jumps on the route from Tokio to Sydney, Australia.

The Chief of the Air Staff will be accompanied by a mechanic as yet unnamed, and the machine to be used will be a 400-horse-power machine, with a flight capacity of ten hours.

SCANDAL HITS MANY GERMANS

Barmat Affair is One That is Stirring Whole Life of Country

COUNTER CHARGES

BERLIN, Mar. 5.—Germany is paying considerable attention just now to a financial scandal. It is called the Barmat affair, and is casting its shadow over the political life of the country. Some high officials are already involved, and nobody knows who next will be dragged into the limelight. Public charges are being held in an endeavor to ascertain facts, and the trials evidently lead into more than one political camp.

Four brothers of Russian birth, Julius, Solomon, Herschel and Isaac Barmat, came into Germany a few years ago by way of Holland, vouched for, it is alleged, by the German foreign office and certain prominent politicians. They formed a company to import furs, but gradually branched out into banking, the buying up of paper and artificial silk factories, iron and steel mills, sawmills and pottery works, and various other activities. They prospered exceedingly.

Prussian Bank

Then some one started an investigation of the Prussian State Bank, one of the oldest financial institutions of Germany, as a result of which it was revealed that the bank had liabilities in excess of its capital and reserve, and that it had loaned large sums without proper collateral. A man named Kutisker was a party to these transactions.

Then almost overnight the whole affair was given a new aspect. While Kutisker confessed to his irregularities, it soon developed that there was a concern which had apparently gone in for even wilder financing, the Barmat corporation. Kutisker was presented with an order for his arrest on Christmas Day, and the Barmat brothers received similar warrants as a New Year's greeting, their arrest taking place on the afternoon of December 31.

The affiliations and friendships of the Barmat brothers are coming to light. The trail leads to the doors of prominent Socialists; a Communist deputy and a Clerical-deputy appear to have been involved, and a cabinet minister resigned under the fire of charges in which the Barmats figured.

Being Investigated

Several different investigations already are under way, and the Barmat affair is being made the football of German politics. Charges that the Socialists were on close terms with the Barmats are matched by counter-charges that Nationalist officials were so lax in their credit policy that millions of marks were loaned to them even after the Reichsbank had rigidly shut down on credits, and after rumors were current in exchange circles that not all was well with the Barmats.

The investigations include probing into the deals in furs by the Barmats as quasi-official agents of the government; a searching investigation of the terms under which credits were obtained, and an examination of the multifarious undertakings of the four brothers from Russia.

HOTEL KEEPER FINED FOR NOT GETTING UP LET TRAVELLER IN

Was Sued by Man Who Was Kept Out in Bad Weather Early in Morning

WINDERMERE, Eng., March 5.—The proprietor of a leading hotel in this district will sleep with one eye open for the future, since he was fined \$250 and costs by the county court judge for failing to let a traveller in the hotel for several hours one morning.

The traveller told the court he was stranded through his baggage being lost and tried to obtain admission to the hotel at 5 o'clock in the morning. It was after 7 when he got in and during the wait was exposed to rain and cold. The traveller said that he did not bring action in a vindictive spirit, but wished to register his protest against the proprietors' refusal to entertain travellers and to show him that innkeepers had a duty to the travelling public which they were bound to carry out.

The court upheld his views and fined the proprietor.

The city solicitor has received consent from the lieutenant governor in council to the bylaw recently enacted by the city council providing for reductions in light charges now in effect.
