PRINCE RUPERT IS THE ROUTE FROM PEACE RIVER

WOMEN TO HAVE SAME RIGHTS AS MEN IN CANADIAN DIVORCE COURTS

Prince Rupert to Peace River by Way of Hazelton and Finlay Forks Advocated in Vancouver

The advantages to be gained from building a railway to connect with the Canadian National east of Prince George would be nothing compared with the building to Prince Rupert by way of Hazelton, according to Captain I. E. Haught, writing in Vancouver Star. In his lengthy article the captain urged building through Peace River Pass as being the most feasible and serving the best part of the country.

Summarizing at the close of the article, the writer says: "We would then have a line running almost due east from Prince Rupert through Finlay Forks and thence through the mountains into the very heart of the Peace River interior."

NATIONAL PARK NOW IN ALASKA

Area was Created by Proclamation Issued Today at Washington

WASHINGTON, Feb. 27.—The Glacier Bay National Monument area containing 1820 square miles on the South East coast of Alaska is created in a presidential proclamation issued today.

Since the first records of its discovery written by Captain Meares in 1794 the area has been the centre of interest to geologists. It includes Mounts Fairweather, Lituya and Laptev.

Last year 2,500,000 acres was withdrawn from the public domain pending a decision in regard to the boundaries of the monument. Now the lands not included therein will be thrown open for development.

REBEL TURKS WANT CALIPH

Present Government of Turkey is Opposed to Religion

CONSTANTINOPLE, Feb. 27.—The Turkish government is undertaking military operations against Kurdish insurgents led by Sheikh Sami.

A circular issued in Kurdistan to the rebels reads: "Your Caliph awaits you. No Mohammedanism is possible without the Caliphate. The present government is opposed to religion."

Will Meet Alberta Hockey Champions in Allan Cup Series

ROSSLAND, B.C., Feb. 27.—Rossland last night won the senior amateur hockey championship of B.C., again defeating the Monarchs of Vancouver by a score of 4 to 2 and thus winning the round by 7 to 2.

Rossland will now meet the Alberta champions in the Allan Cup elimination series.

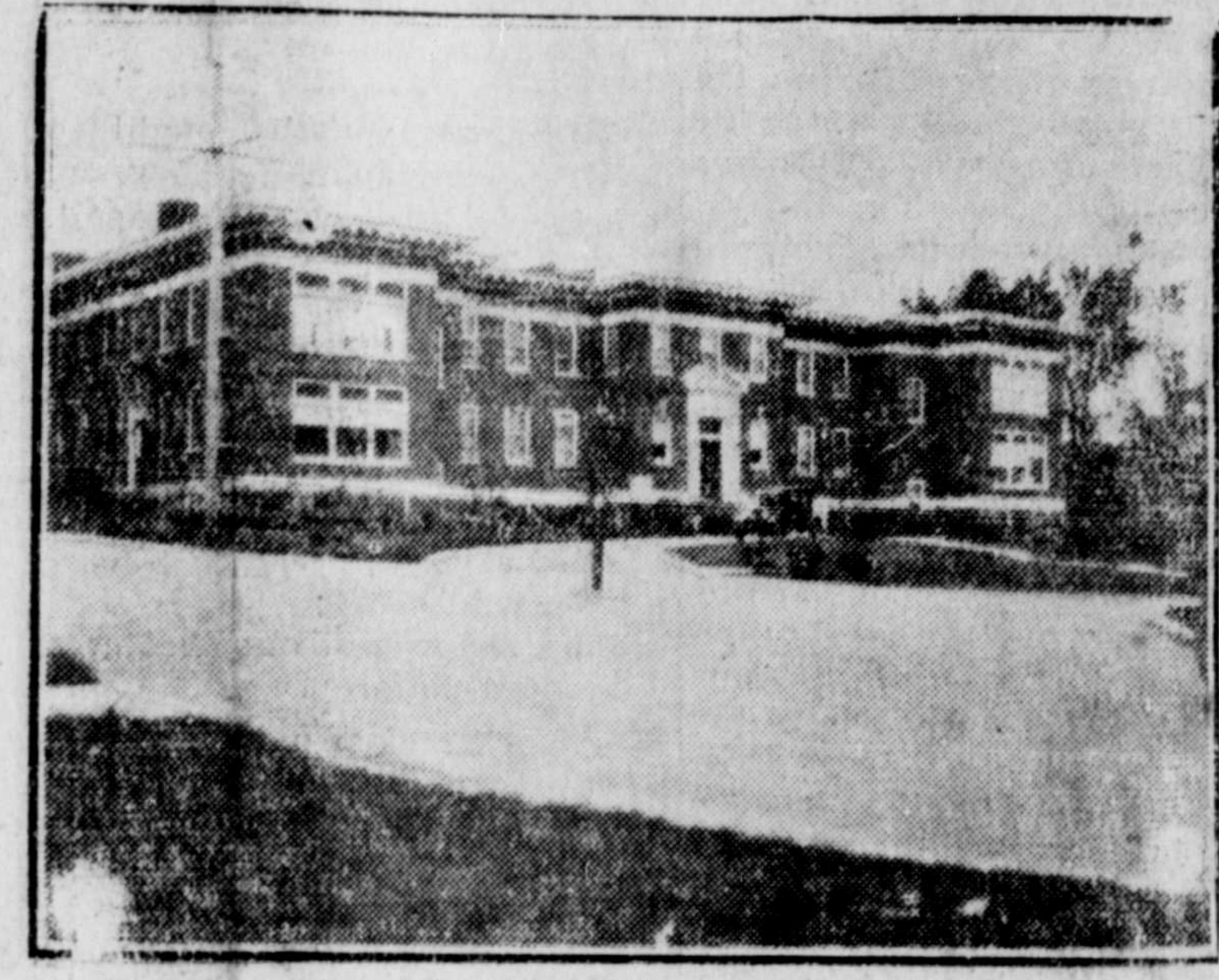
MAJOR GODFREY IS MARRIED IN EAST

Halibut Market Still Demoralized; Quantities of Fish Arriving Keep Prices Low and Some Go South

The demoralized condition of the halibut market continues today and it seems likely to be in a bad condition for a few days yet. Prices are all shot to pieces and buyers are reluctant to bid as they do not know whether they will be able to dispose of the fish after they have it.

Yesterday 236,000 pounds went south, made up as follows: Alton, 70,000 pounds; Akutan, 42,000; Pioneer, 50,000; Rainier, 50,000; Chancellor, 13,000; Thelma H., 14,000. They were followed this morning by the Scandia with 115,000, and the Mariner with 30,000 refusing to accept 7c and 3c, cleared for Vancouver.

Two vessels, the Lituya with 30,000 and the Senator with 31,000 had no offers and have not yet sold. The Resolute with 68,000 and the Republic with 85,000 were offered 7c and 3c for Ketchikan delivery by the Allin Fisheries and it is understood accepted if this afternoon. Boats are already arriving for tomorrow's sales and it looks as if the supply would be as large as today. Today's sales were:

WOULD HAVE YANK BOATS

Nova Scotia Finds Mistake in Excluding American Fishing Vessels

(Special to Daily News)

OTTAWA, Feb. 27.—Nova Scotia wants American fishing vessels to call at her ports. Last year they were excluded when what is known as the *modus vivendi* ended. Since that time the boats have been missed and a caucus of Liberal members from that province adopted a resolution favoring the re-establishment of the *modus vivendi*.

It is understood the government is likely to act on the request and allow vessels to call for ice, bait or supplies.

DOUBLES EXPENDITURE CARE OF PLAYGROUNDS

Divorce Rights of Men and Women to be made Equal says Commons

OTTAWA, Feb. 27.—The first vote of the session was recorded last night when a bill sponsored by J. T. Shaw, independent member for West Calgary, to establish equality between husbands and wives insofar as grounds for divorce are concerned, received its second reading by a majority of forty. The vote stood 109 to 69.

The Premier and leaders of the opposition and Progressive Party united in support of the bill, which had the approval of the great majority of the members of the Conservative and Progressive parties. Opposition came chiefly from Liberals.

Although the measure was designed solely for the purpose of placing man and woman on an equality so far as divorce was concerned the field of discussion broadened until the whole question of divorce was gone over.

Shaw, in moving the second reading, explained that in the four western provinces women were handicapped in seeking divorce by the fact that they must prove not only adultery but also desertion and cruelty, while in the case of a divorce petition by a man only adultery is required to be proved to secure a divorce from the woman.

LOOK ONLY TO PARLIAMENT

Premier, Oliver Indicates Where Railway Rates Relief Must Come From

IS NOT SURPRISED

PENTICTON, Feb. 27.—"It was just what I expected," said Premier Oliver on his arrival here, when apprised of the decision of the Privy Council in granting the appeal against the decision of the Railway Commission and confirming the Crows Nest Pass railway rates. "British Columbia will now have to rely upon Parliament for relief and there is no reason to be downhearted," he said.

THIEPVAL MAY SET OUT ZANNI'S ROUTE

Staunch Little Canadian Vessel May Have Another Voyage Like That of Last Spring

H. M. C. S. Thiepval, which made a hazardous voyage last spring to the Aleutian peninsula and the Kurile Islands to set out supplies for the British round-the-world flight attempt, may make another such journey this spring on behalf of Major Pedro Zanni, the Argentinean world flyer. Patrio Murphy, Zanni's advance agent, will make the trip as Col. Broome did last year and Prince Rupert will be one of the first stops. Murphy is at present in the south making arrangements for a convoy ship preparatory to setting out on his long supply trip. The Argentinean flyer has been offered the dumps which were set out and not used along MacLaren's route.

PREPARATIONS FOR BIG RUSH

WASHINGTON, Feb. 27.—Permission to build a series of hydro-electric units at Steel River and its tributaries in Alaska has been applied for by a San Francisco firm. It is planned to locate the plants 30 miles southeast of Juneau.

Learn Lesson From Present Situation.

The present demoralization of the halibut market owing to the rushing on to the market of immense quantities of fish without any preliminary preparation should prove a lesson and a guide as to what is likely to be repeated another year unless steps are taken to prevent it. For months there has been no halibut except the frozen variety and then within three days a million pounds comes to this port and the buyers do not know what to do with it, especially as there is much more due within the next few days.

It is understood that the cold storage plants on the coast still have some of last year's catch on hand and they hesitate to fill up their storage rooms this early in the season to hold until next winter. The Canadian market is not buying fresh fish until spring.

The fishermen through their organization, it seems to us, should consult with the buyers and make some arrangements to go out in rotation and possibly pool the prices or in some manner endeavor to overcome a situation which injures the industry.

No Such Thing As A Canadian.

There is no such thing as a Canadian in the eyes of the law when registering a child. The parents have to give its racial origin. Canada is not old enough to have developed a race.

There are in this country cases where an Irishman of French descent has married a Scottish woman whose mother was German. They have gone to the registry office and have been slightly puzzled to know what race to call the child. Yet they were debarred from calling it Canadian.

It seems to us about time that the word "Canadian" ought to be good enough for anyone and no questions asked beyond that. If the person registering is not Canadian, then it is all right to ferret out the ancestry. Canadians here should insist that they have no other nationality. We do not want French-Canadians, English-Canadians, Scotch-Canadians, Dutch-Canadians. All we want is Canadians without any prefix.

Dream Of Great Leader Comes True.

Sixty years ago, there was in England a teacher of religion who had a vision of a better, brighter, happier, more spiritual world. He thought of a world in which there was more justice, more kindness, more sympathy, more compassion; less drunkenness, less cruelty, less trouble, less pain—a peaceful, prosperous world.

This teacher of religion was Rev. William Booth, a minister of the Methodist communion in England, afterward famous as William Booth, the General and head of the Salvation Army.

Rev. William Booth was quite familiar with the conditions of life in certain portions of the great cities of England sixty years ago. Born in Nottingham, he had grown to manhood in a crowded trade centre, and he had lived and worked for years among the poor of East London. He understood and appreciated the temporal and spiritual conditions in which many of the British people spent their lives. He knew the want and destitution of many homes. But it was not their poverty that troubled him most. What troubled him most deeply was spiritual poverty.

In connection with this spiritual work, William Booth conceived that many adjuncts would be required. He saw that there would be required, employment bureaus, manufacturing plants where temporary employment could be had, farmhouses for disabled people, food depots for the hungry, salvage stores, hospitals, homes for children, homes for the aged. He regarded the spiritual work as the essential element, with all else following of necessity. William Booth had the dream that this might be accomplished. It would require great effort on the part of many devoted men and women, and it would require large sums of money, but he believed that it could and would be done.

Sixty years have now passed, and although the great work of the Salvation Army is still in its infancy, the accomplishments are already far beyond all that William Booth dreamed in the earlier years. Sixty years ago William Booth stood alone in the world. Even the Christian Mission had not been organized. All that there was of this modern movement was locked up in the heart of this single individual. Sixty years have now passed and instead of one lone evangelist, there are in the spiritual and social work of the organization more than 20,000 officers, who speak more than fifty languages and who carry forward this spiritual and relief work in eighty countries. To recruit their ranks there are 1,600 young people in army colleges, in more than twenty countries, training for the same great service. The ideas of the founder have been retained. The army is still the friend of the unfortunate, and to millions of the poor the best message of the Christian faith is brought.

ANYOX LEAGUE ACTIVE BODY

Annual Report of Secretary Submitted at Meeting Showed Excellent Results

EIGHTY THOUSAND TURNOVER

Sum of \$3,500 in Bank With Which to Start New Year is Reported

ANYOX, Feb. 27.—The annual meeting of the Community League was held in Recreation Hall on Wednesday evening, February 25. The attendance was fair, the fact that there were no kids to register having something to do with the small turnout; but those who were present were enthusiastic enough. The president, Dr. Harper, occupied the chair until the report of the secretary was read when he retired and George Warwick was selected by the meeting.

The secretary's report outlined the various activities of the league for 1924, told of what revenue was produced in all branches as well as what the different departments had cost. A balance sheet as at December 31, 1924, was handed to the members attending as well as a copy of the newly printed constitution and bylaws, which the last annual meeting had authorized the council to prepare. Apart from the information on the balance sheet and showing the financial standing of the league, total expenditures on all accounts for the year had amounted to \$80,000, while receipts from all sources were slightly in excess of \$81,000.

Expenditures

In the general activities covering athletics, gymnasium, library, entertainments, etc., the league had spent over \$11,000, while receipts from these sources had been about \$6,000. The balance-sheet would show cash assets in the bank of \$3,500, as against a balance of \$2,300 in 1923. At that time there had been paid out on deferred expense account some \$300, which gave actually \$2,600, while at December, 1924, there was over \$700 to the credit of the league in deferred charges, which made the amount really to the league's credit at present \$4,200.

There had been one particularly heavy expense in 1924, the re-making of the tennis courts, which had cost slightly over \$2,500, while the expenses in replacing fire losses were also heavy.

During the coming year it was hoped to get revenue the same as in 1924, and they should make both ends meet and a little better by judicious management. The swings on the children's playgrounds would have to be renewed and there would be expenditures to make at the ball grounds, while a summer camp would possibly be established at Alice Arm where the camps built by the Granby Company a year ago for lumbering purposes may be available.

With the financial statement was an inventory of goods listed at a fair price. It showed a valuation of \$17,700, as against \$15,600 a year ago. A full ten per cent had been written off all buildings for depreciation.

Excellent Service

In concluding the report, the secretary called attention to the excellent service rendered the community by the retiring council. The meeting then tendered a vote of thanks to the retiring chairman and council, and Chairman Warwick then said some nice things about the secretary and his work, which the meeting endorsed.

In connection with nominations for the Community League Council, nominations were received at the meeting for Beach representation on the Hospital Board. The representative for 1924, John McCallum, was re-elected, without opposition.

Here and There

Mineral production in Canada for 1924 is estimated at \$208,194,000, as compared with \$214,079,331 in the preceding year, according to a preliminary statement issued by the Department of Mines. Metallic minerals accounted for \$96,034,000 of the total, followed by fuels and other non-metallics with \$73,830,000, and structural materials and clay products with \$33,330,000.

The Port of Montreal created a new world record in 1924 for the amount of grain handled by any one port in any one year, namely, 165,139,396 bushels, while from January 1 to November 30 she handled 94,366,508 bushels more than her nearest competitor and 17,332,709 bushels more than the seven next busiest ports combined.

Described as the finest coastal vessel in the world, the "Princess Kathleen," recently launched by Lady Mount Stephen, widow of the late Lord Mount Stephen, a former president of the Canadian Pacific Railway, left Glasgow on January 15 on her ten thousand mile journey through the Panama canal to join the Canadian Pacific's fleet of coastal steamships plying the seaboard of British Columbia.

A historic pageant of some proportions is being planned by the Calgary exhibition board for this year, its object being to commemorate the fiftieth anniversary of the founding of the city by the old North-West Mounted Police in 1875. In the period which has since elapsed, Calgary has grown to be an extremely busy, modern city, having a population of 75,000. A stampede similar to those held in Calgary in previous years is also planned for this summer.

The itinerary of the "All Blacks," New Zealand's wonderful rugby team, hitherto unbeaten, in their tour of Canada, was announced by the Canadian Pacific recently. Landing at St. John, N.B., on January 31, from the company's steamship "Montclair," the team will proceed across the Dominion via Canadian Pacific lines. They will make short stays at Montreal, on February 1; Toronto, February 2; Niagara Falls, February 3; Calgary, February 6; Banff, February 7-9; Vancouver, February 10-21, and sail from San Francisco on the 25th. Calgary is giving them a ball and dance at the Palliser Hotel, they will take part in the Banff winter carnival, and will play teams from Vancouver and Victoria while on the coast.

Very heavy summer travel is anticipated by the Canadian Pacific Railway during 1925, especially to conventions on the Pacific coast of Canada and the United States. C. B. Foster, passenger traffic manager of the company, announced recently. Canadian and American railroads expect 150,000 persons to attend these conventions, some of which will be very large. At least thirty westward bound special trains, and as many eastward bound, will be provided by the Canadian Pacific to handle the delegates, Mr. Foster stated, and Banff and Lake Louise expect great seasons, as so many of the travellers will stop off at those famous mountain resorts. There will also be a very heavy movement to conventions in eastern Canada and the eastern United States.

Union steamer Venture, Capt. A. Johnstone, arrived from Vancouver and waypoints at 9:15 last night sailing later for Anyox and the Naas River. Going north on the vessel from here were the Prince Rupert High School basketball teams who are to play a series of games at the smelter own.

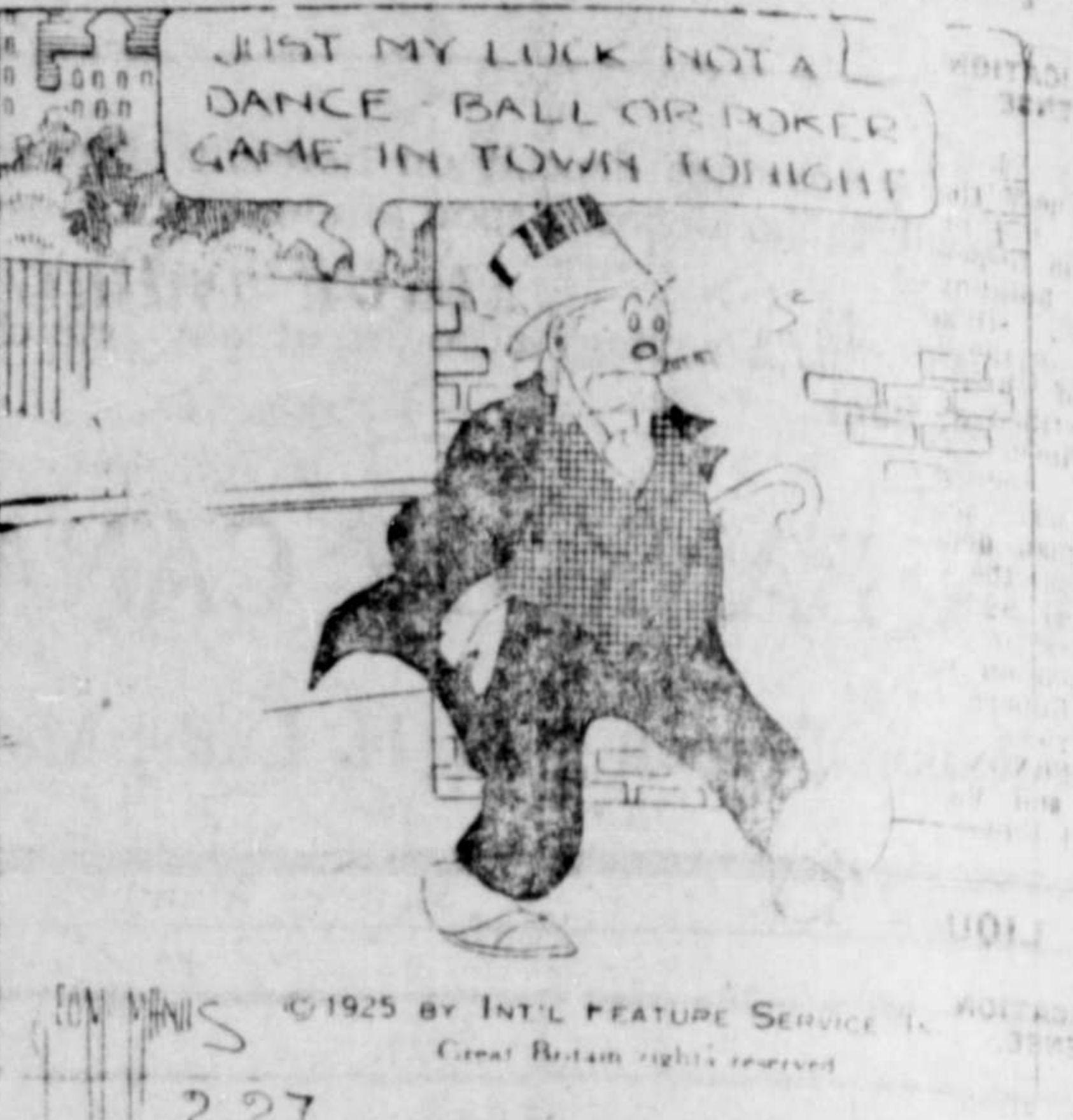

Chicago Prospects

The road to that place is at present in bad condition and Saanich people object to paying the cost of rebuilding it. Victoria is willing to pay part of the cost and the Provincial Government is being importuned to do a share. Failing all other methods, the tollgate is suggested.

SOCIETY WOMAN IS NOW BANKER IN LARGE INSTITUTION

Unfortunate in Marriage She Turns to Finance as Profession

NEW YORK, Feb. 27.—The remarkable rise in finance of Mrs. William Laimbeer is the chief topic of discussion by New York society. From a society woman who had never done a stroke of work as a wage earner until twelve years ago, she had advanced to a position in the National City Bank of New York where she will be Head of the Women's Banking Department in charge of all business done by the bank with women.

Mrs. Laimbeer assumed a business career after her husband, a Wall Street broker, was killed in an automobile accident on Long Island and the responsibility of caring for her three children was thrust upon her. She began in a position a little above that of a clerkship and steadily advanced to the rank of executive in the first billion dollar commercial bank in the U.S.

A popular debutante as Natalie Schenk, daughter of Mr. and Mrs. Spotswood D. Schenk, of New York and Newport, Mrs. Laimbeer had many suitors, but her first marriage was with Captain Charles Glen Collins, who served with the British army in the Sudan and Boer Wars. They were married in Monterey, Calif., and spent their honeymoon in Honolulu. They separated later and Mrs. Collins obtained a divorce. A child was born by this marriage.

Captain Collins later had difficulty with the law. He last figured in newspaper dispatches in 1923 when he was acquitted of charges of a gem swindle in Bombay, India.
Mrs. Laimbeer is the first woman to become an officer of the National City Bank. Her rise has broken century-old tradition of a conservative bank.
