EDITORIAL

HOSTILITY OF EDMONTON'S MAYOR TO PRINCE RUPERT

Word has been received here that Mayor Blatchford of Edmonton appeared before the Board of Railway Commissioners and asked that the railway freight rate from Edmonton and points east be made greater than the rate to Vancouver.

Mayor Blatchford, we are informed also interviewed the officials of the Canadian National Railway and urged the same thing on them.

In neither case did Mayor Blatchford meet with success. The idea seemed to be prevalent that he was acting from purely selfish motives and trying to knock a port that was a possible rival to the one in which he happened to be interested.

We wonder if Mayor Blatchford was representing the City of Edmonton, when he appeared before the railway commission and the railway officials. Was he acting in his own interests or in the interests of the city he represents? Does Mayor Blatchford really represent the official opinion of the City of Edmonton when he tries to restrict the business of that city to one Pacific port? It looks to us as if he was trying to run with the hare and hunt with the hounds.

When grain begins to flow from the City of Edmonton to the port of Prince Rupert, as it surely will in spite of Mayor Blatchford, the City of Edmonton should be able to form closer business associations with this port. We should be able to buy from Edmonton more than we do at present. Prince Rupert people and the people of the interior districts between here and that city should begin to take more interest in the prairie city and visit there oftener. Our business association will draw us together. It will become then the mayor of that city to go out of his way to try to injure us. It does not seem to us to be good-business for the Alberta capital to show opposition to one of the Pacific ports from which it might benefit largely.

BRIAND FAILS FORM CABINET

Definitely Refuses to Take Premiership and Paul Doumer Is Called

PARIS, Nov. 24. — A. Briand, who has been seven times premier of France, today definitely declined to form a cabinet to succeed that of Painleve. The Socialists refused to co-operate with him.

Senator Paul Doumer, former finance minister, has been summoned to Elysee Palace by the president and it is understood he will be offered the position if he will take it.

TWO AVIATORS KILLED WHEN MACHINE DROPS 500 FEET TO GROUND

HONOLULU, Nov. 24. — Two army aviators were killed here yesterday when the twin engines of the machine both stopped, the plane falling 500 feet to the ground.

General Election in Alberta Likely Next Summer; Premier Greenfield Goes Back to Farm

EDMONTON, Nov. 24.—Following his resignation yesterday ex-premier Greenfield, who for several years had been at the head of the former government in Alberta, stated that he was through with politics and that he was going back to his farm.

Premier Brownlee, who has taken Mr. Greenfield's place, announced that six by-elections were pending and it was not likely they would be held as it was quite possible a general election would be held within eight months.

No by-elections are expected in connection with cabinet reorganization as portfolios will be held by present members of the government. The general election is likely to take place during the interval between seeding and harvest next summer.

UNITED CHURCH WINS NANAIMO

Decision Handed Down by Judge of Supreme Court Favors Them There

NOVEMBER, Nov. 23.—Handing down a decision in the supreme court yesterday in the case of the St. Andrew's Presbyterian Church of Nanaimo, which was taken in the civil courts following a dispute regarding the legality of the vote on the Church Union question, Mr. Justice Denis Murphy held that properly qualified voters had not been allowed to exercise their rights. As the number of these voters exceeded to the majority which voted against Union, the property will be automatically handed over to the United Church.

CASE AGAINST WM. HAYNER WITHDRAWN

Evidence Showed That Car Was Removed by Accused in Good Faith

The charge against William Hayner of removing an automobile which was in the custody of the sheriff was withdrawn in the city police court this morning. The evidence went to show that Mr. Hayner was not actually involved in the removal of the car by any other means than in good faith. Not knowing of any attachment, he paid \$500 for the vehicle and simply went to get the property he had bought.

COMMITTED FOR TRIAL ON CHARGE OF THEFT

Sam Winstrom Brought Back From Anyox and Will Appear Before Judge Young for Election

Committed for trial by Stipendiary Magistrate R. M. McGusty at Anyox on a charge of theft of personal effects from Oscar Flint of Alice Arm, Sam Winstrom was brought back to the city this morning by Provincial Constable F. Broughton of Abbotsford. Accused, who was arrested at Abbotsford, will appear before Judge Young in the County Court for election.

Father I. Belle of Rome, superior of the fathers of the Roman Catholic Church in Prince Rupert district, left on last night's train for Fraser Lake where he will visit the industrial school for natives. He was accompanied from the city by Father Cocola of Fraser Lake.

SIX CASES ON ASSIZE DOCKET

Two Civil Actions, One Appeal and Three Divorce Cases Coming up Next Week

Two civil actions, an application for the setting aside of a magistrate's decision and three divorce suits will comprise the docket at the session of the Supreme Court Assizes opening here on December 2. There will be no criminal cases before the court and, for that reason, no juries have been empanelled.

One of the civil cases is a claim made by Hugh Gillis, a fisherman, against the Prince Rupert Hotel for damages in the sum of \$3,600. Gillis makes this claim as a result of a fall in the beer parlor of the hotel when he states that he broke three ribs and sustained other injuries. He claims that he mistook the door of the lavatory and, opening an unbarred door, fell 18 feet down a shaft into the basement of the hotel. L. W. Palmore has the case for the plaintiff while the defendant will be represented by Milton Gonzales.

The second civil action is that of Robert H. Bourke vs. the Canada Product Ltd. The plaintiff, who is a contractor of springwater, Saskatchewan, claims the sum of \$8,534 for damages as a result of the cancellation of a logging contract and a further sum of \$818 as a balance due on logs cut. The defendant company operates a sawmill at Usk. Williams, Manson & Gonzales have the case for the plaintiff and Palmore & Fulton for the defendant.

Palmore & Fulton will make certiorari application for the setting aside of a conviction and fine of \$300 imposed by Magistrate McLymont against Clara Brown of this city on a charge of unlawfully selling liquor. The grounds are that a plea of guilty was entered on behalf of the appellant without her knowledge by her counsel at that time, W. E. Fisher.

Yet Corbin has to get along, just as hundreds of other places in British Columbia have to get along, without a road. The difference between Corbin and other communities is that Corbin has a spokesman who urges its inclusion in the places to be reached by automobile.

PORTLAND WINS OPENING GAME HOCKEY SERIES

VANCOUVER, Nov. 23.—In the opening game of the western hockey league season played in the arena here last night, the Portland Rosebuds took the Vancouver Maroons into camp by a margin of one goal, the score being three to two in favor of the Portland team.

The visitors led off well, scoring two goals during the first period. In the second period Vancouver caught up with their rivals and the third period started with everything set for a fight to a finish. There was a good deal of excitement when the visitors scored the final goal which gave them a lead which they held until the end.

SOVIET RUSSIA STANDS ALOOF

Will Not Enter League of Nations or Any Other Similar Organization

MOSCOW, Nov. 24. — Soviet Russia intends to continue to stand aloof from the league of nations and similar organizations, acting foreign minister Litvinoff declared yesterday. He said the Locarno security treaty would not alter the Soviet foreign policy.

HELD UP BANK MESSENGERS

Robbers Get Away With \$50,000 After Shooting Policeman in Chicago

CHICAGO, Nov. 24. — Five robbers held up the bank messenger and guards, shot and seriously injured a policeman, evaded a fight and escaped with approximately \$50,000 this morning.

COLONEL PECK WAS CHOSEN TRUSTEE OF VETERANS CANTEEN

VICTORIA, Nov. 24.—The War Veterans who are members of the Legislature yesterday chose Col. Peck and Brigadier-General Odium to be trustees of British Columbia's share of the Canadian canteen fund. The two will choose a third member to form a board which will function under the federal statute passed this year.

TWO YEAR OLD SON OF MR. AND MRS. ED. HUDSON DIED MONDAY

The death occurred in the Prince Rupert General Hospital at 10 o'clock yesterday morning of Harry, the two year old son of Mr. and Mrs. Ed. Hudson of Ninth Avenue and Conrad Street. Funeral will take place tomorrow afternoon from Hayner Bros. Chapel at Fairview Cemetery, Rev. Walter Allen officiating.

Bristol Bay Cannery Scandals Once More Aired by Grand Jury at Valdez in Report just Issued

CORDOVA, Nov. 24.—Charges that paroled prisoners, "the scum of the earth," polyglot criminals, were employed in the canneries of the Alaska Peninsula in the vicinity of Bering Sea were contained in the report of the grand jury at Valdez.

The jury stated that cannery employees commit the greater part of the violent crimes of the territory and annually make half the business for the grand jury.

Rigid examination of employees for the purpose of barring narcotic addicts, degenerates and criminals is advocated in the report, which criticized the Bristol Bay commissioners for placing bail bonds so low that some felony defendants did not appear to answer the charges.

WHEAT PRICE TOOK JUMP AT WINNIPEG GRAIN EXCHANGE

WINNIPEG, Nov. 24.—The price of wheat took another jump on the grain exchange here today, the advance varying from 2 1/2 to 6 cents a bushel. The increase was due to strong Liverpool cables.

HEARST MUSIC COMPANY HEAD AGAIN ARRESTED

Charged by Provincial Police of Manitoba With Theft of \$385,000

WINNIPEG, Nov. 24.—Joseph Hearst, former head of the Hearst Music Company, was arrested last night by the provincial police on a charge of theft of \$385,000.

Hearst was out on bail awaiting trial on other charges connected with the failure of the company.

Everyone Busy On Grain Movement.

This is the time for everyone to be busy in connection with the proposed movement of grain through this port. The presence of the elevator changes the outlook here altogether. It will be the means of providing freights for vessels which otherwise could not operate.

There seem to us to be two methods open. One is to induce Japanese ships to come here and operate in connection with the Canadian National and the other for the Canadian National to operate their own ships from here. One or the other will have to be done and it would seem to be the path of wisdom for the C.N.R. to put on their own vessels.

It is good to learn from F. G. Dawson that the company has been discussing plans for the operating of vessels from this port. Doubtless they have done so before this, but the absence of freights has made it almost an impossible venture. Now that the elevator is here and there is every probability that we shall have the business, the National should be the ones to get it.

With the local grain committee active, with the railway co-operating and with all the citizens pushing every pound toward getting business this way, Prince Rupert should soon be on the commerce map. Hitherto we have been trading. Now we aim to engage in commerce and get a place on the map of the world.

Need Of Capital In Any City.

Every city, especially every young city is in need of capital to start industries and develop resources. For that reason capital should be encouraged. On the other hand it is not good policy to give away all the rights of the people in favor of capital. There is a happy medium. If we give away too much now, we have to pay up afterwards. If on the other hand we adopt the policy of the past and refuse to aid big industries and to encourage them to come we are making a big mistake. Capital will not go to a place where it is likely to be abused. It must have an assurance of fair play.

It is all very well for people to rave over the encroachments of the big interests. They are often overbearing and have to be kept in their place. These same big interests can make or break a community. To have them here is worth everything to the place. To exclude them is fatal.

Only Their Home; No Lives Lost.

Sometimes we read of a house being burned, as we did yesterday. No lives were lost, simply the home destroyed. There is no thrill about a family losing a home but there is a thrill when people are burned to death.

And yet few of us can realize what it must mean to lose a home. If we apply it to ourselves and think of what it would be like if all our intimate possessions were gone and we had no means to replace them.

Many people lose their homes and are too proud to seek or take assistance from others. The result is they never recover what is lost. In any event the lost things are irrecoverable. We cannot replace the gifts from friends, the curios, the various articles that make the home different from others. It is tragedy to lose the home and for that reason the greatest care should be taken at all times to protect it.

OBJECTION TO CLOSING DOWN WORK ON ROAD

City Council Passes Resolution and Will Communicate With Member for District

The city council in the form of a resolution moved by Ald. Casey and seconded by Ald. Perry last night decided to register its formal objection at the action of the provincial government in closing down work on the Kaiea Island highway. The resolution instructed the city clerk to communicate with Hon. T. D. Pattullo, member for Prince Rupert drawing attention to the fact that the city had completed its portion of the work and that, on the same day as the city had finished, government work had also ceased with the government portion of the road still impassable for traffic.

Leading up to the resolution, Ald. Casey stated that the provincial government had stumped the city into doing its portion so the development of the highway might be hastened. The city had kept faith and had done its work to the last letter with the result that a road had now been produced which was a distinct credit to the city. On the other hand, the day the city finished the government had pulled its men off the work. Quite long enough had the city been made a monkey in an agreement with the provincial government and the railway company. They had set out what the city should do and the city had done it while they themselves, despite the agreements, did just as they saw fit. He thought that it was time the city draw to the attention of the provincial government in the manner in which it had fallen down on this work.

Should Keep Faith

Ald. Casey also touched the matter of unemployment and said that the town was already filling up with men looking for jobs. In the past the city had endeavored to furnish work for the unemployed and it would probably have to do so again this year. It was the duty, he felt, of the provincial government to carry on the work keeping faith with the city as well as the unemployed.

Ald. Larsen recounted how the minister of lands last spring had asked the city council to proceed with its work at once so the government could use the connection to get its supplies on the job. Mr. Pattullo had also informed the city at that time that there was plenty of money available to carry the road to Gallo-way Rapids and that there would be no delay in completing it. He thought that the council was quite justified in passing the motion submitted. He was of the opinion that not one tenth of the money allotted for the work had been expended.

"Perhaps it went towards paying for the over-expenditure on the University buildings," remarked Ald. Casey as the motion was put and unanimously carried.

ELECTRIC LIGHT AND PHONES PAY SURPLUS

Profits During October Were \$1,641.75 and \$677.23 Respectively According to Superintendent's Report

The operation of the electric light department during the month of October resulted in a net surplus of \$1,641.75 while the profit of the telephone department during the same period was \$677.23 according to reports submitted to the city council last night by the superintendent of utilities.

OPTION FOR BONDS IS NOT ACCEPTED BY CITY COUNCIL

Tentative Offer Turned Down and Bids Will be Called When City Ready

The Royal Financial Corporation of Vancouver had a letter before the city council last night asking the city if it would care to give a 15-day option at 97 or an issue of 5 1/2 per cent ten-year debentures. The company declined to make a firm offer at this figure and suggested that, if given time, it might be able to use the bonds.

Ald. Casey said that the offer had been dealt with by the finance committee and it had been deemed that it would be an unsound policy to give an option when a definite offer was not made. Further it might have a tendency to discount the bonds if the company was not successful in disposing of them at the figure named. In addition to that, the council might lay itself open to criticism if it accepted an offer without calling for bids. In view of the facts, the finance committee was of the opinion that it would be best to hold the bonds until the time was ripe to call for tenders for the issue.

Ald. McMordie concurred with the remarks of Ald. Casey. Though the offer seemed to him to be a fair one, he was of the opinion that the only safe course was to call for bids.

It was moved by Ald. Casey and seconded by Ald. McMordie that the option be not given. The motion was carried, the mayor stating that the city treasurer also concurred with his proposal.

Reminded him of a story, he said, and told how a tough old emerald had passed on and the village zossips were trying to find something good to say for him. Finally one old crony got on it.

"Foy," he said, "he was a hard smoker." That's how the government appealed to the gallant Cy, who expressed his unbounded admiration at the manner in which they could carry on with a placid and untroubled exterior in the face of the criticism of the people of the province.

He said they reminded him of the hardened sinner who had lost all hope of redemption but gets on a cheerful grin and decides to see it through.

Colonel Cy tempered his exaltation with a broad smile and the government continued urbanely.

Premier's Humor

Hon. John Oliver occasionally gives the House glimpses of human nature, as seen through the eyes of a prime minister. The House was discussing a dyking bill Tuesday, and one of the members was stating that the land would not pay the charges against it and give the farmers a balance.

"You youngsters play the same tricks we old cowpunchers did," he remarked mildly as he climbed around the bronk and left the prey of cowboys, with their lower jaws hanging loose from astonishment.

MUST GO OUT AFTER TRADE

A. Melville Dollar Says While Some are Thinking it Over Others are Getting Business

FUTURE OF PACIFIC

Immense Growth in Past Few Years and Increase is Still Going on

"Our businessmen must realize that business abroad can only be secured and maintained by personal contact," said A. Melville Dollar at the Winnipeg Conference recently. "Bear in mind always," he continued "that while we are thinking it over the other fellow is getting the business. Just as Great Britain is developing the Pacific trade and gradually climbing up to top place, just so must we in Canada and particularly you manufacturers and businessmen of the east, grasp the opportunity now."

Captain Dollar told of the immense growth of trade on the Pacific and quoted the business with Japan and India as examples. Pacific ports were among the largest in the world. While New York had the largest tonnage of shipping Hong Kong came second, with only two million tons less and Shanghai tied for sixth place with Liverpool. The history of shipping on the Pacific ocean would indicate that the future centre of the world shipping will change from the Atlantic to the Pacific just as in the past it changed from the Mediterranean to the Atlantic.

Mr. Dollar then traced the growth of the port of Vancouver showing how it had gradually developed. Incidentally he told of the growth of the wheat business. In 1924 there was a shipment of 1,750,000 bushels. The next year in round figures it was 14,000,000 bushels. This increased in 1923 to 24,000,000 bushels and in 1924 to 53,000,000, and very soon they expect it to reach 100,000,000 bushels. These figures were not for crop years but calendar years. He said he believed the Pacific route was an economically sound proposition from the national viewpoint of Canada.
