## QUEER TURN GIVEN LIQUOR PROSECUTIONS WILL BE BIGGER MINES THAN PREMIER IN STEWART DISTRICT SAYS ROLSTON

### Sensation Develops in Liquor Infraction Trial in Magistrate's Court

Adjournment taken for week to bring Inspector Miller Here and Attorney General also is coming

Sensation developed in the trial of the Consolidated Exporters Corporation Ltd. on charges of violation of the Government Liquor Act when the defence yesterday afternoon demanded an adjournment for one week so that it might place George Miller, chief inspector of the Liquor Control Board, on the stand to testify that irregularities in connection with the recording of liquor exports from the defendant's warehouse had been committed with his knowledge and approval. Heated debate waxed between Milton Gonzales, counsel for the defence, and L. W. Patmore, crown prosecutor. The latter suggested that Inspector Miller had connived with the Consolidated Exporters Corporation to aid it with its defence and declared that Mr. Gonzales was attempting to work the government and the liquor board in every way possible in order to stop the prosecutions. Mr. Patmore also observed that the attorney general was expected in the city next Wednesday and that it would give him pleasure to invite him to be present at the trial in order to hear the cross-examination of Mr. Miller. The request of the defence for one week's adjournment was granted. In the course of his debate with Mr. Patmore, Mr. Gonzales announced that the first case in which the Consolidated Exporters Corporation had been convicted of illegally selling liquor and fined \$2,500 would be appealed.

### STEVENS HELD UP THE WORK AT DRYDOCK

Questions Asked by Him in Parliament at Ottawa Led to Stoppage of Work Here

The delay in the conversion of the ships of the Canadian Government Merchant Marine from coal to oil burners at the drydock plant here seems to have resulted from questions asked in the House of Commons last week by H. H. Stevens of Vancouver as follows:

- 1.—Is the Government aware that the Canadian Government Merchant Marine have ordered the conversion of four ships operating on the Pacific coast into oil burners?
- 2.—In authorizing or approving of the abandonment of coal as fuel for these ships has the Government taken into consideration the injury to the Vancouver Island coal industry?
- 3.—Has the Government or the Canadian Government Merchant Marine any assurance that fuel oil prices will not advance in the future. If so, in such assurance in the form of definite contracts?
- 4.—From whom and at what price is the fuel oil purchased for the use of the Canadian Government Merchant ships operating on the Pacific coast?
- 5.—In accordance with the pledge given by Mr. King that the "coal industry of the Pacific coast would be investigated and careful consideration given to its claims," has any such investigation been made? If so, when was the report made, and by whom?

### ONE MORE FLIGHT FOR THE SPANISH AVIATORS

RIO JANEIRO, Feb. 5.—The transatlantic Spanish seaplane, piloted by Commander Franco, arrived here late yesterday afternoon from Pernambuco. The remaining lap to Buenos Aires is about 1380 miles.

### BIG MAJORITY FOR GOVERNMENT IN BRITISH COMMONS

LONDON, Feb. 5.—The House of Commons today voted confidence in the Government's unemployment dole policy, defeating the labor amendment to the address in reply to the King's speech by a vote of 229 to 112. The dole system is likely to be discontinued another year.

### MANY JAPANESE ARE AFFECTED BY ORDER

Estimated at Between 400 and 500 Will be Ousted From Fisheries

VICTORIA, Feb. 5.—Between 400 and 500 Japanese formerly employed in the fishing industry of British Columbia will be forced out of this business during the present year as a result of the latest reduction in Oriental fishing licenses ordered by the Federal Government. This estimate of the number of Orientals affected by the exclusion policy was made by officials of the Federal Government on this coast.

### BODY FOUND ACROSS HARBOR

Fisherman Discovered it on Beach Near McNicholl Creek Yesterday Afternoon

Ed. Torkeldson, fisherman, notified the city police station about 3 o'clock yesterday afternoon that he had discovered the body of a man across the harbor on the beach behind the small island that lies near the mouth of McNicholl Creek. The provincial police proceeded to the scene to investigate and this morning brought the body to the city.

Up till early this afternoon, identification had not been established as nobody had been reported missing from the city and the clothes at that time had not been searched for documents. The face is unrecognizable and the body is partially decomposed, having apparently been exposed and dead for the past month. The man was about 6 feet in height and, as far as the police can judge, about 50 years of age. The clothes consisted of a dark grey serge suit and black boots.

### Cost Million Dollars to Clear Streets in New York of Snow; Transportation was Paralyzed

NEW YORK, Feb. 5.—Northeastern New York state was struggling today to dig itself out of the most severe snowstorm of the winter, which was the direct cause of 32 deaths in various parts of the Eastern States. As a result of the storm and cold five persons died in New York City through exposure and 20,000 men are employed trying to keep the main streets of the city open at a cost of a million dollars. The air mail train service and shipping in the regions affected have been paralyzed. Boston was hit hard.

### Will be Better Mines Than Premier in Stewart District Declares Rolston in Address

There are three or four properties at least in the Portland Canal district that give promise in the near future of being as good as the famous Premier mine if not better, declared H. W. M. Rolston, editor of the Portland Canal News and stock broker of Stewart, B.C., and Vancouver, in addressing the Rotary Club yesterday afternoon. "I prophesy the time when the Premier will not be the major operation in the district," Mr. Rolston continued. "I refer particularly to the Dunwell, the B.C. Silver and the Big Missouri, the first being developed by British Columbia and the Big Missouri by American money. During the winter Mr. Rolston said, eighteen properties had been operating in addition to the Premier. The Dunwell was about to install a hundred ton mill only four and a half miles from Stewart. Last year there were under active development 45 properties, and these were not in any particular section but all over the district. All were immediately at the door of Prince Rupert. Mr. Rolston referred to the wonderful advancement that had been made all over the province in the past twenty years. Let them look forward twenty years and the possibilities were enormous. Were we not justified in being optimistic? The Portland Canal district was only a small portion of what the world will some day know as one of the greatest mineral belts on the continent. The eastern mineral contact had only been scratched at a few places as yet. Around Stewart they had a district running 20 miles up the Bear River, 20 miles up the Salmon and 20 miles down Portland Canal that was tributary to Stewart. While the Premier had produced a large amount of mineral other mines he felt sure would yet produce more. "The greatest difficulty we find," said Mr. Rolston, "is to combat the scepticism of the world. We have developed the district so far with practically no help from the outside. We have had to do our own boasting but I am glad to say that today the work is bearing fruit."

### HIGH RECORD LOG SCALING

Official Returns Show 1925 Was Largest Yet Made in Province of B.C.

VICTORIA, Feb. 5.—While there was a reduction of more than 30,000,000 board feet of logs exported from British Columbia last year compared with 1924, the quantity of logs scaled in the province established a new high record, the figures being 2,614,266,527 feet compared with 2,549,700,000 board feet the previous year. Grains in the cut were made in the Vancouver and Kamloops districts while Prince Rupert, in common with other districts in the province, showed a decrease, largely due to the closing down of the Massett Timber Company's plant and the reduction of operations at Swanson Bay.

### INVESTIGATE STEVENS CHARGE

Committee to be Appointed Today to Find Out About Alleged Smuggling

OTTAWA, Feb. 5.—A committee will be announced this afternoon to investigate the smuggling charges made by H. H. Stevens in the House of Commons. It is understood the personnel will be Hon. H. H. Stevens, Hon. R. B. Bennett, C. W. Bell, Conservatives; D. M. Kennedy, Progressive; J. C. Elliott of West Middlesex, B. L. Hatfield of Vancouver, Paul Mercier of St. Henry, and D. Donaghy of North Vancouver, Liberals.

### AMUNDSEN'S MAUD GOES TO VANCOUVER

SEATTLE, Feb. 5.—Sold to the Hudson's Bay Co. in liquidation of the debts of Raold Amundsen, the famous exploration ship Maud left here late yesterday for Vancouver in tow of the Winona. LONDON, Feb. 5.—Many of London's aristocracy are busy converting disused stables and attics in Mayfair into stylish maisonettes for their own use and the Duke and Duchess of York indirectly are responsible.

Since these members of the King's family settled in Mayfair there has been a stampede of those who wish to live near enough to bask in the Royal smiles. There is a great shortage of houses in this section, and those available mostly are enormous, old fashioned mansions, costly to lease and expensive to maintain. Hence the conversion of stables.

Mayfair has, of course, long been the home of the elite. It is to London what Park Avenue and Fifth Avenue are to New York.

In the old days, there were many mansions with small buildings in which the blooded horses and the fine carriages of the aristocracy were housed. Since the automobile has come into such common use, however, the glossy steeds and the gorgeously uniformed lackeys have largely joined the other picturesque relics of the hey day of blue blood. Now there are few mansions in Mayfair, these days which do not house distinguished families.

### RICH SILVER TO BE TESTED

Machinery Being Taken into Fur Country of North from Edmonton

FINANCED IN EAST.

EDMONTON, Feb. 5.—The mysterious silver lode in the Barren Lands, eastward of Fort Fitzgerald, has been finally located and staked. For years it has been sought by prospectors; once it was found and lost again. Now it's exact location is fixed and machinery is being sent north by horse sleds over the Athabasca river ice to test it out.

At this writing the only two men who are aware of its exact position—Wynn of Fitzgerald and Dunn of Calgary—are speeding north by dog team, and they will be followed by the drilling apparatus. This is the first time in the history of the north that such heavy machinery has been freighted into the fur country by other means than the river boats; the opinion of local mining men being that the find must be "pretty good" to warrant such hurried methods.

Obtain Special Sleds

Ten special flat sleds to carry the machinery are being made here by Captain John Matheson of the Northern Boat Building company, and the contract for taking the drilling apparatus into the Barrens has been awarded to Ryan Brothers, who operates the winter connecting link between Fort McMurray and Fort Fitzgerald.

Little is known of the promoters of the venture except that it is apparently financed by Eastern capital. Four years ago the first silver samples were brought out of the wild country to the east of Fitzgerald. These were given a rough assay by government engineers en route to the Mackenzie country, and at that time the specimens were rated as being worth \$700 a ton. It is generally conceded that if the lode is up to the quality of the samples that the richest silver field in Canada—if not the whole world—has been discovered.

The first adjournment the defence was asking for, after having willingly agreed to many adjournments asked for by the crown during the past two and a half months. No extra expense would be involved for the crown since Mr. Gonzales had advised the defence that he was going to appeal the first conviction and they had stated that they would remain here until such time as the appeal was heard. The crown was charging the defence with something that it had told it to do—a most inequitable charge—Mr. Gonzales concluded.

Mr. Patmore stated that the only objection he had to the adjournment was that the defence had known the nature of the charges as far back as December when they were laid and should have already had plenty of time to have brought Mr. Miller here. Mr. Patmore further stated that he had advised the defence that it was his (Mr. Patmore's) intention to proceed with the cases

until sufficient fines had been imposed to make it a definite warning to the company in future. He could not see where the situation had since changed.

### Wrong Instructions

An ex-official of the Liquor Control Board, Mr. Patmore continued, had already sworn that he already had authorized the company to do the things that it had done. What more could the defence get out of Mr. Miller? In any case, Mr. Miller could have been called by the defence a month ago. Speaking to Mr. Gonzales' statement that no extra expense would be involved for the crown in the adjournment, Mr. Patmore pointed out that an appeal could not be proceeded with until next month and it was not his intention to keep the detectives here for all the intervening time.

Mr. Patmore further pointed out that, in spite of the fact that Mr. Walsh had sworn he had instructed the company in the irregular methods it had followed, Mr. Pyle, the defence witness, had stated that he had not been so instructed by the Liquor Board but that they had been mistakes during a rush of business. How could the defence call Mr. Miller to prove something that the defence's own witness had denied?  
Mr. Gonzales insisted that Mr. Miller had known of these irregularities and he intended to prove that he did. He thought, in view of the many adjournments that the crown had had, that the defence was also entitled to one.

### Miller Under Fire

The magistrate then referred to a letter from Mr. Miller that had been placed in evidence by the defence acknowledging that there had been certain irregularities in the past that should be discontinued and stating that, otherwise, the Act had been well lived up to by the company. Did that letter not go far enough as far as Mr. Miller was concerned?  
Mr. Gonzales replied that the letter did not go far enough. He had been informed that Mr. Miller had approved of the company's books.

Mr. Patmore took the view that Mr. Miller had not been in a position to know. "You may judge what is wanted by this adjournment. Already Mr. Miller has done things in connection with this trial that he has had no right to do such as turning a letter of this kind over to the defence," continued Mr. Patmore, "and I may tell you that Mr. Miller is going to be reported to the attorney general for what he has done."  
"I don't care what the attorney general does," continued Mr. Gonzales, "I am here to fight for the Consolidated."  
Referring to "camouflaged shipments," Mr. Patmore again stated that he did not intend to have the defence calling witnesses to deny what its own witnesses had admitted. "Suppose Mr. Miller is called and he admits that he allowed irregularities. It will not affect the case because our charge is that shipments to various boats were falsely entered under one boat. Mr. Pyle had already admitted as much. I know my learned friend is trying to work the government

and the liquor board in every way possible in order to stop these prosecutions."  
Mr. Gonzales resented the suggestion.  
The magistrate declared that it did not look good on Mr. Miller's part that a covering letter should come from him at this time, December 24. "Were these charges the cause of the letter?" he asked.  
Mr. Gonzales maintained that they could not have been for the contents of the letter were not in favor of the defendant.  
Mr. Patmore took the view that the charges were the cause of the letter. The detectives had gone south with all the evidence several weeks before the letter had been written. They had taken the charges up with Mr. Miller and a week or two later the letter was written by Mr. Miller after he had received the information and knew the cases that were to come before the court. Mr. Miller said in the letter that the defendant had complied with six sub-sections of the Liquor Act whereas, in the face of the charges that he himself had seen, those sub-sections had not been complied with.

Mr. Patmore said that the inference could easily be drawn.  
After Mr. Gonzales had again asked for the adjournment, Mr. Patmore said he would consent to it if Mr. Gonzales would give his undertaking that Mr. Pyle would be called in every case where Mr. Miller was called.

The magistrate granted the remand. Mr. Miller, he felt, would be able to give a good deal of valuable information, and apart from that, the crown had already had several remands and he believed that it was at least fair to grant one to the defence.  
Arrangements were thereupon made to wire Mr. Miller so as to expedite the proceeding of the trial. Mr. Gonzales had previously stated that it would be necessary to subpoena him as he had declined to appear voluntarily.

"As far as the Liquor Board and Mr. Miller are concerned I would like to make it plain that I am hostile," remarked Mr. Gonzales.

"And I am just itching for a chance to get Miller in the witness box," said Mr. Patmore agreeably.

"Then it looks like an interesting session ahead," observed His Worship.

### Attorney General, Too

"The attorney general will be here too on Wednesday I expect," said Mr. Patmore. "It will be a pleasure for me to invite him to this court to hear the cross-examination."

Mr. Gonzales said he would be pleased to have the attorney general present.

Mr. Gonzales asked if the crown would still require the witness Walsh, who was anxious to get away, to remain or if it would be prepared to accept his evidence as previously given. Mr. Patmore replied that it was his intention to cross examine Mr. Walsh.

Court then adjourned, the case to be proceeded with next Wednesday afternoon at 2:30.

# ASK REDUCTION OF PASSENGER FARES IN WEST

VICTORIA, Feb. 5.—Reductions in the present passenger fares on Canadian railways over lines in British Columbia probably will form one of this Province's chief demands when it applies to the Railway Board shortly for a general cut in transportation costs. This was indicated by G. G. McGeer, K.C., government rate counsel, when he arrived here for conferences with members of the Government in preparation for Railway Board hearings expected to take place in March or April.

"Our case will cover every phase of the freight rate situation as well as express rates," Mr. McGeer declared. "We have under consideration now, as well, an application for lower passenger rates."

The Government rate counsel declared that all transportation rates in British Columbia were excessive in comparison with rates on similar commodities in other parts of Canada. "The Mountain Rate Scale affects all rates in effect here," he said. "It is against this Mountain Scale that we have been fighting. We are applying for general rate reductions all along the line."

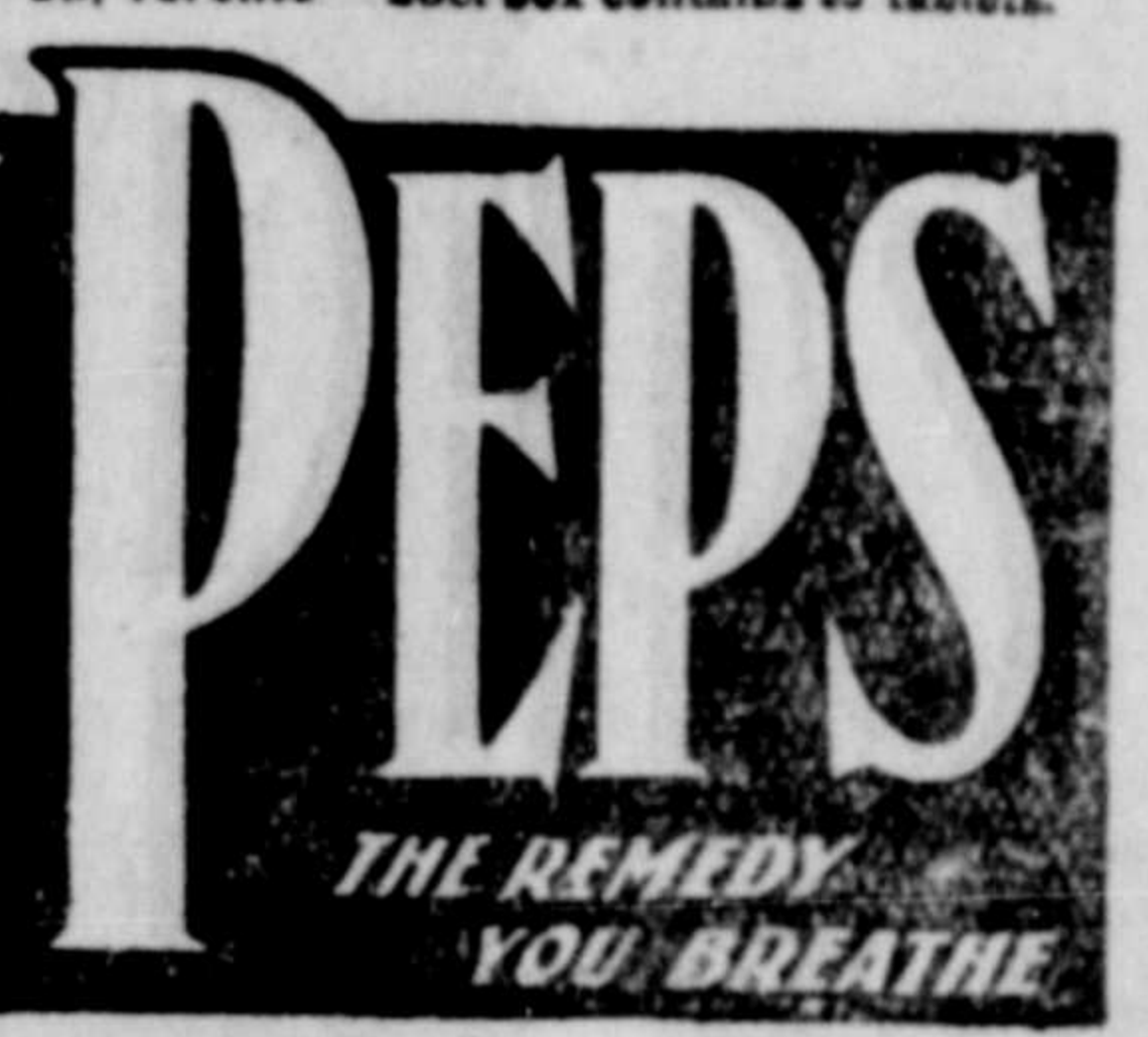

### IMPORTING QUAIL TO HELP FARMERS

TOPEKA, Kan., Feb. 5.—Kansas has found a way to import farm labor without running afoul of the immigration authorities. The state has just imported 5,000 quail from Mexico to help out the Kansas farmers. They are expected to eat up 125,000 insects during next summer, and, with their brood of young "bobwhite" to destroy at least a quarter of a billion weed seeds by autumn. The Mexican quail is slightly smaller than the native bobwhite of Kansas, but the state game warden is assured that the two will interbreed. He estimates conservatively that the purchase of 5,000 birds will bring Kansas 25,000 young quail next summer.
