# CASE OF CANNIBALISM ON HIGH SEAS

## ANOTHER SMITHERS MINE SOLD TO AMERICAN INTERESTS

### Japanese Whose Bodies Were Found on Fishing Smack Ate Eight Other Members of Crew

Clear case of cannibalism on board where the bones of victims are found by doctors of Port Townsend

PORT TOWNSEND, Nov. 2.—Dead of starvation despite the evidence that they had devoured the bodies of seven or eight of their shipmates, the last two to survive of the crew of the Japanese fishing boat Kiyi Yei Maru, 100 tons, arrived yesterday aboard a pilotless vessel after drifting with sea currents more than 4,000 miles from the coast of Japan.

Physicians from the United States quarantine station here said there was no question that cannibalism had been practiced by the last survivors. The bones of seven or eight human beings were found aboard.

### PLAN SCHOOLS THIS DISTRICT

Both Anglicans and United Church Negotiating With Indian Department

In connection with the Church Army conference now being held in this city, it developed today that both the Anglican and United Churches are negotiating with the department of Indian affairs for the establishment of industrial schools in this district.

The Anglicans would like to have them either at Prince Rupert or Metlakatla but if one of the schools is established on the coast the other will probably be in the interior.

The Anglicans are also planning a school for native workers such as the one held in Saskatchewan which later developed into the University of Saskatchewan.

### CHANGES MADE ON P.G.E. LINE

Deficit Cut Down Very Materially and Improvements and Betterments Made

Reduction in the operating expenses of the Pacific Great Eastern Railway to the extent of \$46,000 in the last nine months, substantial reductions in the management and supervision expenses; cutting down the deficit materially on the North Shore branch; carrying out a comprehensive program of improvements and betterments in brief is the result of the work of the new board of directors in the last nine months. When the new board of directors assumed control a little more than a year ago, the operation loss for the fiscal year then ending was \$274,971.

### Agenda for Interprovincial Conference is Completed by Federal Cabinet at Ottawa

OTTAWA, November 2.—The cabinet council has completed its agenda for the interprovincial conference which it is understood will include the following:

Senate reform and amendments to the British North America Act.

Determining the respective rights of the provinces and the federal government over water rights.

Blue sky legislation and the possible enactment of a federal law to set out more clearly the powers of companies incorporated under Dominion and provincial letters of incorporation.

Increased subsidies to the provinces.

Premier J. D. MacLean and Hon. A. M. Manson, the British Columbia representatives at the conference, have arrived here and have been in conference with Premier Mackenzie King and other ministers in regard to the agenda.

### STRANGLER CASE IS ON

Alleged Murderer of Two Winnipeg Women is Facing Jury Today

WINNIPEG, Nov. 2.—The trial of the alleged strangler who made such a sensation throughout the continent in summer has commenced here. The man is Earle Nelson who is charged with the murder last June of a Winnipeg woman, Mrs. Emily Patterson, and girl by the name of Lola Cowan.

Selection of the jury was completed this morning and the case is proceeding.

So great was the crush of those wishing to attend the trial that a few women sustained scratches and bruises when the court room doors opened this morning.

### TAXATION CASE IS SETTLED IN FAVOR OF THIS PROVINCE

Surplus of Co-Operative Associations Must Pay Its Share of Income Tax

NEW WESTMINSTER, Nov. 2.—A decision affecting all co-operative organizations with reference to provincial taxation and affecting provincial government revenue of half a million dollars, was handed down by Judge F. W. Howay, when he dismissed the appeal of the Fraser Valley and Surrey Farmers' Co-operative Associations against its provincial income tax assessment.

The appeal was on that part of the financial surplus which the Associations claimed was a refund of overcharges to its members. The amount involved in the case was \$7,855.

### PROPOSES TO SHIP COTTONWOOD LOGS BY PRINCE RUPERT

George Little of Terrace returned to the interior yesterday after a brief visit to the city for the purpose of interviewing local railway officials with a view to possibly arranging for the shipment by rail to Prince Rupert and thence south by water of a million feet of cottonwood timber to the mill at New Westminster of the Laminated Materials Ltd. The logs are at present boomed at Devil's Island in the Skeena River near Terrace. Some of such logs have already been rafted down the river to Phelan and there picked up by tugs but there has been some loss in that proceeding which rail shipment would eliminate if suitable arrangements for it could be made.

### SEVENTY CARS OF GRAIN IN DURING PAST 24 HOURS

### Important Mining Property on Hudson Bay Mountain is Bonded by Philadelphian

SMITHERS, November 2.—A long time working bond has been taken by Philadelphia interests on the Victory Group of mineral claims on Hudson Bay Mountain owned by Donald Simpson an old-timer in this district. The price of the property is \$150,000, and so far \$1,000 has been paid down in cash, the remainder being spread over a number of years.

The deal was consummated Saturday, the purchaser being John J. O'Brien of Philadelphia, who announces that active development work is to commence immediately in order first to prove up the showings from the present workings.

There are five claims in the group which is located one mile north of the Henderson group from which the Duthig interests have been shipping ore regularly for several years. It is a well known property having been staked a number of years ago and development work done in a small way each year by the owner.

Owing to the location of this group and the showings so far, mining men in the district look upon its development as a very important step and one that is very likely to lead to big results.

### PRESENTATION TO SHIP'S CAPTAIN

Capt. F. Tate, Master of First Grain Boat of Season, Honored by Local Board of Trade

### PLEASED WITH PORT

Capt. F. Tate, master of the British freighter Fishpool, first vessel of the season to load wheat at the Alberta Wheat Pool's Prince Rupert elevator, was presented on behalf of the Prince Rupert Board of Trade yesterday afternoon in the Prince Rupert Club with a suitably engraved fountain pen as a souvenir of the occasion. The ceremony was of an informal nature and the gift was made by W. O. Fulton, president of the Board of Trade, who spoke briefly pointing out some of the desirable features of Prince Rupert as a port and suggesting that, if Captain Tate had any complaints or suggestions to make, he lay them before the Board of Trade.

In response, Capt. Tate had a few kind words to say in appreciation of the presentation and the spirit in which it had been made. He expressed his high pleasure at the treatment the ship and its personnel had received in Prince Rupert from officials and others. He stated that he had found the merchants reasonable and accommodating and he was generally pleased. The friendliness and hospitality of the people of Prince Rupert was another gratifying feature to himself and his officers and men. Chief Engineer Frier of the Fishpool also made a few remarks.

### TWO ATTEMPTS GAIN LIBERTY

NATIVE VISITORS WELCOME

While the official welcome to the large number of native visitors has been expressed by the heads of the church to which they belong, we feel that we should publicly express appreciation of their making this city their headquarters for several days and for the music they provide here under somewhat adverse weather conditions.

The natives of all this north country come here every year at fair time when everyone is so busy no person has time to give much attention to any but their own affairs. At this time of year things are different. Conditions are somewhat normal and we are glad to have the opportunity of telling the Indians from the villages around that Prince Rupert is always glad to see them here and to hear their music.

DOMINION GOVERNMENT AND HIGHWAYS

The Premier at their conference at Ottawa will have much to discuss but it is hoped that the question of federal contribution to trunk roads will be among the subjects taken up. If the Dominion helps, Prince Rupert is likely to get her highway to the outside much earlier than otherwise would be the case. The road is needed badly and federal aid would be welcomed here.

BUILDING PERMITS HIGH

Building permits for Prince Rupert were high last month and yet there are several not yet in, such as the rebuilding of the two docks on the waterfront. If there is some technical reason why these are not included it seems as if a way should be found for getting them so that we may get credit for everything done here. We want to look prosperous as well as feel prosperous.

The buildings at Seal Cove mill must include only the work of the carpenters and in addition there will be the mill work and machinery fitting which will amount to a large sum. The winter promises to be one of the busiest Prince Rupert has had for several years past.

MINING NEAR SMITHERS

One of the industries that is making Smithers important is the mining that is being carried on in the district. Hudson Bay Mountain has all sorts of possibilities and with one good shipping mine there, it is possible that the industry may develop to a very great extent.

Today we tell of the bonding of another property by American interests, Canadians being apparently afraid to spend their money in opening up mines in Northern British Columbia to any large extent. If this move is successful we shall again hear how Americans are coming in and making use of our natural resources.

We hope Mr. O'Brien is successful in his Hudson Bay Mountain ventures and makes a fortune there. Mr. Duthie is doing pretty well at his mine and he, too, is an American. The more good American money comes into the country, the better, especially when those who live here hold back.

WHEN NOT TO TELL PATIENT THE WORST

King's Physician Advises Young Doctors Against Pronouncing Death Sentence

LONDON, November 2.—(By Canadian Press)—Sir Humphry Rolleston, Regius Professor of Physic at Cambridge University and Physician in Ordinary to the King, addressing students at the opening of the winter season at St. George's Hospital, London, explained that it was not always wise to tell a patient the worst about his or her case. He also explained how a perfect bedside manner could be acquired by a doctor.

Sir Humphry said: "Honesty and truth are essential, but what may at the time the whole truth should not always, in the light of human fallibility and his best interests, be communicated to the patient. A death sentence given bluntly on what may prove to have been insufficient grounds benefits neither the patient nor the doctor."

On the subject of the perfect bedside manner Sir Humphry said it was the result of so getting inside the patient's minds as to think their thoughts, feel their feelings, and thus understand their mentality and anxieties so thoroughly that the medical man was obviously their friend, with their interests so entirely at heart that nothing else counted.

BANQUET FOR DOCTOR KENNY

Knights of Columbus and Elks Honor Member who has Headed Both Organizations

Some thirty members of the local Knights of Columbus and Elks organizations gathered last night in the Commodore Cafe at a farewell banquet in honor of Dr. F. P. Kenny on the eve of his departure for new fields in the south. Many expressions of regret at his and Mrs. Kenny's leaving were voiced but the hope was generally expressed that their return to the city would be not in the too far distant future. Dr. Kenny, though resident in the city for only four-and-a-half years, has been at the head of both organizations which honored him and, in token of esteem and appreciation, farewell mementoes were presented to him on behalf of the Knights of Columbus and Benevolent and Protective Order of Elks, under the joint auspices of which the function was held.

J. J. Muldoon, Grand Knight of the Knights of Columbus, presided and, after a splendid repast for which the restaurant management later came in for congratulation had been done full justice to, he inaugurated the list of speeches by fittingly referring to the generous manner in which Dr. Kenny had given of his time and energies to the work of the Knights of Columbus and Elks as well as other activities in the interest of community welfare. Good wishes and Godspeed would be unanimously extended to himself and Mrs. Kenny, who had been prominent in social and particularly musical circles, and it was the hope of all that future success and prosperity would be theirs in large store.

Dr. Kenny might be getting too big for Prince Rupert or farther removed fields might seem greener to him but Alex Macdonald, Past Grand Knight of the Knights of Columbus, who was the next speaker, felt that it was not unlikely that the brother who was now departing, after he had reached his objective, would return to the irresistible charms of Prince Rupert. In any case, that was the wish of all who were now farewelling him. On behalf of the Knights of Columbus, Mr. Macdonald presented a beautiful golden charm of the order to Dr. Kenny.

W. E. Williscroft, exalted ruler of the Elks, also paid his tribute of esteem to Dr. Kenny. His decision to leave was generally regretted but the speaker suggested that others had similarly left Prince Rupert only to return in a short time. It would not be surprising to him if Dr. Kenny eventually did the same. On behalf of the Elks, Mr. Williscroft presented to Dr. Kenny a handsome ivory handled pocket knife with a totem pole on one side and a suitable inscription on the other as well as an address. The gathering sang "For He's a Jolly Good Fellow" and gave three hearty cheers.

Dr. Kenny, in an appropriately worded response, expressed the deep appreciation not only of the gifts that had been presented to him but also for the tribute which was marked by such a function being held in his honor. In the light of the fact that when he had come to Prince Rupert four-and-a-half years ago he only knew two people in the city, the present proceedings seemed to him much like a dream. As for the time he had spent in the work of the two organizations, there was not a moment of it which he regretted. The harmony to be observed between the Knights of Columbus and Elks was a matter of great gratification to him though it was only as it should be. When he said that he regretted to leave Prince Rupert, it was a genuine statement because he had been privileged to make many lasting friendships here. The sojourn of himself and Mrs. Kenny in the city had ever been a pleasant one and the only thing that took him away now was the feeling of duty to himself and his family that he should grasp the opportunity to advance himself in his profession at a time when circumstances and ambition actuated his so doing. Nor was it beyond the realm of possibility that they might yet return to Prince Rupert to permanently locate. Dr. Kenny acknowledged feelingly the great service that had been rendered him some months ago by the Elks when he had been stricken while at the Premier mine. He desired in the same connection to publicly express his thanks to Ben Self who had, with some personal sacrifice, accompanied him to Vancouver on that occasion.

Ben Self had little to add to the tribute paid to Dr. Kenny by other speakers. As to any service that he had given, it was only what anyone would have done under such circumstances. A visiting Knight of Columbus and Elk, P. E. Pepsonault of Winnipeg, was called upon for a few words. He did not know Dr. Kenny personally but, from what he had heard, the local lodges were losing an indeed valuable member. Stating that he had not long come from New York to Western Canada, Mr. Pepsonault declared that the hospitality he had enjoyed in Prince Rupert on his few visits here had been unexcelled anywhere. He painted a brief but rosy picture of the future prospects of the port.

John Dore spoke briefly to add to the feelings that had been expressed for Dr. Kenny.

LOSING REAL FRIEND In the departure of Dr. Kenny, L. Murray Fuller realized that he was losing a real friend and close associate in the work of the Elks' Lodge. It was a matter of personal regret to him.

J. J. Gillis declared that Dr. Kenny possessed qualities that were bound to

advance him far in his profession. One of these qualities was his feeling for others and sympathy. Mr. Gillis also had a good word to say for the service that had been rendered by the restaurant management in putting on the banquet.

The proceedings closed with the singing of "God Save the King" after which those present proceeded to extend their personal farewells to Dr. Kenny.

Dr. and Mrs. Kenny and son will sail tonight on the Princess Alice for the south. It is Dr. Kenny's plan to proceed to California and, during the next few months, qualify himself for the state examinations of California, Oregon and Washington. That completed, he will decide on a permanent future location. In the meantime, Mrs. Kenny and son will proceed to Ontario for a visit with relatives.

JURY MAY VIEW MURDER SCENE

Counsel for Crown Says He Will Ask Trial Judge For Such an Order

VANCOUVER, Nov. 2.—In the application to Mr. Justice Morrison yesterday for a change of venue from Prince Rupert for Joseph Sankey, J. E. Bird, counsel for accused, maintained that a trial at Prince Rupert would be prejudicial to Sankey. He urged that a Prince Rupert paper had published an incorrect report of an alleged statement made by Sankey to the police. "Why didn't you take proceedings against the newspaper?" inquired the judge. "If I did that I would have to do it every week," replied counsel.

In particular, Bird objected to the reference in the Prince Rupert Daily News to Sankey as "Indian murderer of Miss Moretta Chisholm." For the Crown A. M. Johnson, K.C., argued that there had been shown nothing more than the possibility of prejudice and that not sufficient to justify a change of venue. In addition he announced that he proposed to ask the trial judge to order a view of Port Essington, the locality of the tragedy. If the newspapers published anything prejudicial to a fair trial they laid themselves open to contempt of court proceedings, said Mr. Justice Morrison.

ENGLISH VIEW OF BIG FIGHT

London Times Critic Writes After Viewing Film Which is Shown in London

CRITICIZES REFEREE

Intimates That Dempsey Had Raw Deal in Contest Owing to Bias Against Him

Writing in the London Times of the big fight between Tunney and Dempsey a critic after viewing the picture of the contest says:

Broadly speaking, the film is an exceptionally good one because it is so clear and—as shown privately to a number of press representatives, at any rate—admirably timed as well. Though the record of most of that now notorious seventh round is magnificently clear, the actual time taken by Tunney to regain his feet is slurred over in the most astounding manner. No one who did not see the fight itself would have grasped fully the important fact that Dempsey's ill-luck in the incident was enough to have discouraged the greatest-hearted man that ever drew on a boxing-glove. In the first place, it is clear that in the seventh round—as indeed, in the six previous ones—Dempsey is boxing in his own way quite as cleverly and much more fairly than Tunney. Dempsey is alternating his animal-like springs into close quarters with a swaying from and slipping of many of Tunney's best and hardest punches. To anyone who understands the true inwardness of the Dempsey style of fighting, he is boxing with his head this time as well as with his hands and feet. He does, in fact, draw his man at last and get in, first, the blow that knocks all defence out of Tunney and then, with almost incredible precision and rapidity, three more blows, all but one, which is a glancing one, blows that would jar.

TUNNEY DOWN

Down Tunney goes into a sitting position, his left hand still clutching the lower rope. And, up to a point, the film is a clear enough revelation of the true situation. It is obvious, for one thing, that Tunney's claim that he could have risen and resumed fighting

In four seconds is a preposterous one. He is for long after that brief respite a man whose mind is in a haze. He is, in fact, dazed, and, although an interruption of the film deprives one of any chance to check the referee's interrupted and apparently leisurely count, there can be little doubt that, after ten seconds in the same position, Tunney still is struggling hard to regain his full wits.

IN THE WRONG CORNER

Dempsey, after a momentary attempt to stand over his fallen opponent, gives way to the referee in a docile and disciplined manner and—here the absurdity of the rule involved is unhappily left unrevealed—retires to a distant corner. But not the right one! There he stands—so the eye-witnesses but not the film tell us—quietly, with his arms stretched and resting on the ropes. Seconds and seconds elapse, and the referee orders him to move to a neutral corner! However, after an amazing rest, and a still more amazing piece of luck and refereeing, Tunney does get up and spends the rest of the round racing round the ring, with Dempsey after him. Once, when giving up the chase, Dempsey actually motions to the "undazed" Tunney to come and have a fight.

Then, to make the first knockdown and the 15 to 20 seconds' rest all the more memorable, there comes a second knockdown and no respite at all in the eighth round. On this occasion it is Dempsey who is caught and sent to the boards by a beautiful counterblow

Up Dempsey gets, and the referee's lapse is quickly covered. MATTER OF TACTICS So much for the notorious seventh round and the scarcely less notorious eighth. It may be granted at once, too, that Tunney recovers well and outflights a palpably disheartened opponent in the two remaining rounds. Let it be granted also that Tunney all the time looks a beautifully built, magnificently cool, and really capable boxer. His left is first-class and his right shoots over with a swiftness that should emphasize the fact that Dempsey, when he chooses, can box as well as fight like a champion, for the number of misses is considerable. What does reduce the value of Tunney's success, and particularly his advantage on points in the first five rounds—Dempsey does not fairly get into his stride until the sixth—is the fact that Tunney's holding with the right every time that his opponent rushes him is so outrageous that no English referee would have tolerated it for more than a round. Tunney, though, as one must admit, always a fine boxer, even resorts to arm locking that makes the referee's proof of Dempsey for using the rabbit punch appear almost ludicrous.

## DUKE'S SON IS BARRED OXFORD

Has Duty of Arranging Coronation Ceremonies For Any New King

LONDON, Nov. 2.—Having failed to pass "responsoria," the entrance tests, the 19-year old premier peer of England, the Duke of Norfolk, cannot enter into residence this term at Christ Church, Oxford. The failure debars him till next term. Norfolk has hitherto been educated privately. It is expected that after an Oxford course he will go for a time into business in the city, to gain experience likely to prove of value in controlling the management of his estates—which embrace 50,000 acres—and his other considerable properties.

The Duke is the 16th of the line of the House of Howard. The Dukedom of Norfolk dates back to 1483, and a perfect host of other high titles and "fiefs are attached to it. Undoubtedly the Duke's chief office, in relation to the Duke of the Coronation, is that of Hereditary Earl Marshall and Chief Butler of England. This involves the organization and control of all matters in regard to a Coronation. The late Duke arranged the Coronation both of King Edward and of King George. It is curious to reflect that the arrangement of so great a ceremony, when the Sovereign swears to uphold the Protestant religion, is performed as an hereditary right, by the head of one of the most devout Catholic families in the Kingdom.

### TRAGIC HISTORY

No ennobled family of England has a more tragic history than the House of Howard. You may learn something of the earlier Dukes of Norfolk from Shakespeare. The head of more than one Duke of Norfolk has fallen upon Tower Green. The present Duke's father for years endured poignant suffering. His beautiful young wife died soon after the birth of their only child. This boy was born blind, deaf and with mental faculties hopelessly impaired. The whole armory of the Church upon earth and the medical science of the world were in vain. The piteously stricken Earl of Arundel lingered until he was 21.

Soon after his death his father, who was then well advanced in life, married the daughter of Baron Herries, holder of a title almost exactly as old as that of the Duke of Norfolk himself. They had three children, including the present peer. The Duchess eventually succeeded also to her father's title and the present Duke will therefore some day add the Barony of Herries to his present many noble titles.

### ARE WOMEN DRIVERS MORE RISK THAN MEN?

This Question is Revived in England by Action of an Insurance Company

LONDON, November 2.—The question whether women are more dangerous drivers than men has been much discussed lately. It is interesting to find that several of the leading insurance companies are inclined to penalize women as far as accident insurance policies are concerned.

The Manchester Guardian relates that a man whose daughter had just bought a motor-cycle decided to take out an accident policy for her, as she had only taken out a third-party policy for her machine. After she had filled in the usual form he took it to a certain well-known company and paid the premium. When the policy arrived a few weeks later it was found that several clauses giving the company extra protection had been added. As the girl in question was an experienced motorist who had never had an accident a protest was made. The answer was: "They are really very good terms. We try to avoid insuring against accidents if we possibly can, and if our representative had not made a mistake in thinking that the policy was for a man on your bringing it in we probably should not have accepted it at all."
