## FEDERAL GOVERNMENT BORROWINGS

### ANYOX STRIKERS ACQUITTED OF UNLAWFUL ASSEMBLY

#### Jury, After Over One Hour's Deliberation, Finds Men Guiltless

Smelter Town Rioting Trial Comes to Conclusion at Supreme Court Assizes Here Late Tuesday Afternoon With Verdict Absolving Accused

After deliberating for one hour and twenty minutes, the jury at the Supreme Court Assizes in the trial in which Kenneth Montgomery, Matt Jurgeovich, Giovanna Sando, Angus McIver and Joseph Sarich were charged with unlawful assembly and rioting in connection with the miners' strike at Anyox on February 3 last returned a verdict acquitting all five accused. Mr. Justice Denis Murphy, on receiving the verdict, immediately ordered the discharge of the five men.

#### STENSTROM IS MOVED

#### Ferry Service Being Resumed

OAKLAND, Cal., May 10—Inter-urban ferry service across San Francisco Bay was resumed yesterday from the one remaining slip of the Key Route terminals which were virtually destroyed in a \$3,000,000 fire Saturday night. Early rebuilding of the terminals is planned. The cause of the conflagration has not yet been definitely determined.

#### FIRE CASE PROCEEDING

E. C. Dawson Appears at Supreme Court Assizes Here on Another Charge of Arson

#### Case Reviewed

Alleged to Have Burned Down Building Containing Men's Store and Living Quarters

Another trial in which Ernest Claude Dawson of Smithers is charged with arson is proceeding today at the session of the Supreme Court Assizes here before Mr. Justice Denis Murphy. In this case Dawson is alleged on September 25, 1930, to have set fire to a store and dwelling house owned by Benjamin Franklin Messner and occupied by himself with a men's furnishings store on the first floor and living quarters above. L. S. McGill is acting as crown prosecutor while J. T. Harvey is defence counsel.

#### COOTE BILL DEFEATED

Progressive Measure on Interest Defeated in House of Commons Last Night

OTTAWA, May 10: (Canadian Press)—The Coote bill to set the maximum interest rate at five per cent was defeated in the House of Commons last night by a vote of 65 to 34. Liberals and Progressives supporting the measure and Conservatives being opposed.

#### CENSORING IS STRICT

Government in Cuba Not Letting Anything Out—Campaign Against U. S. Influence

SANTIAGO, Cuba, May 10:—The newspaper Diaro de Cuba has published an article informing its readers that "it regrets," owing to censorship, that it cannot print anything concerning events in the republic during the last few days. The campaign to keep United States influence out of Cuba has gained momentum by the posting of placards demanding opposition to American intervention in the Cuban political tangle.

#### JAPS MAY ADVANCE

Chinese Warned to Cease Attacking Positions of Invaders in North China

SHANGHAI, May 10—Japanese troops will resume their North China advance as far as Tientsin if necessary unless Chinese forces cease attacking Japanese positions, the Japanese consul general has warned.

John W. Allen, superintendent engineer for the Dominion Fisheries, in the course of one of his periodical trips up the coast, arrived from Vancouver at Ocean Falls on the Prince George last night and expects to be here by departmental boat by Tuesday or Wednesday of next week.

#### WAR NOW OFFICIAL

Declaration is Made Today by Paraguay Against Bolivia—Fighting Some Time

ASCUNCION, Paraguay, May 10: (Canadian Press)—Paraguay today formally declared war against Bolivia. The two countries have been engaged in undeclared warfare in the Gran Chaco border area since last June. The declaration of war was received with popular acclaim here.

#### HASLETT AS CANDIDATE

Ocean Falls Liberals Confident of Securing Nomination in Mackenzie

Women's and men's Liberal Associations at Ocean Falls have unanimously chosen Matt Haslett, mill foreman, as their choice for candidate in Mackenzie riding at the forthcoming provincial election and Bert Phillips, armed with 21 proxies and instructed to support Mr. Haslett, will leave Ocean Falls Friday night of this week for Powell River to attend the nominating convention for the riding on May 13. Henry Castillon, William Parker and W. Murray, all of Vancouver, are also candidates for the Liberal nomination in Mackenzie but Ocean Falls supporters are confident that Mr. Haslett will be able to carry the convention.

#### FAVOR OF WATERWAY

President Roosevelt Reported as Advocating Congressional Ratification

WASHINGTON, D.C., May 10: President Franklin D. Roosevelt has been quoted by a congressional delegation from the Middle West as favoring ratification of the St. Lawrence waterway treaty with Canada at this session of Congress.

AKRON, Ohio, May 10—As a result of the business revival in the United States, a large local tire manufacturing concern yesterday announced that 500 more men will be taken on this week in the effort to catch up with the automobile industry.

Rhodes, minister of finance, gave notice that he will seek authority to borrow up to \$750,000,000 but this would not necessarily mean that borrowings would be carried out to that extent. The Dominion has maturing debts this year of \$279,971,850 and it is anticipated that a refunding portion of new loans will be issued at four percent with the expectation that the selling price will mean a yield of slightly over that rate. The borrowings will probably be all in Canada with the exception of \$60,000,000 payable in New York which will, doubtless, again be borrowed in that market because of the discount on Canadian funds. Should the minister sell new bonds even at a discount which would cost the country four and a half percent interest, there would be an annual saving of \$1,699,718 on a Victory Bond issue which now carries five and a half percent. In addition the Victory bonds were tax free while the new ones will be taxable.

#### DAVIE IS FOR BOWSER

Resigned as Speaker Declaring Himself Opposed to Some Tolmie Policies

VICTORIA, May 10:—Speaker C. F. Davie M.L.A. Cowichan-Newcastle, today announced his resignation as Speaker of the British Columbia Legislature, declaring his disagreement with several of the federal government's policies and saying that he will support the non-partisan group headed by W. J. Bowser K.C., former Conservative premier.

#### MEN ARE DEPORTED

Mounted Police Party Taking Nineteen Away Today

Sergeant W. C. Grennan and Constables Reginald A. Taggart, Douglas A. Betts, H. J. Adams and W. J. Rurnin, Royal Canadian Mounted Police officers, arrived in the city on the Prince George this morning from Vancouver to form an escort for nineteen men who are being deported from this city and who will be taken this afternoon on the Princess Norah to Vancouver and thence to Winnipeg enroute to the Atlantic Coast to be sent to Europe. The nineteen men were among strikers at Anyox during the winter and are being deported as public charges.

#### RAIL BILL IS PASSED

House of Commons Passes Government Measure by Vote of 84 to 47

OTTAWA, May 10:—The government railway bill passed its final stage in the House of Commons yesterday by a vote of 84 to 47 and goes back to the Senate for review. Amendments were made in the House of Commons.

#### BOOSTING WHEAT

CHATHAM, Ont., May 10:—Dealers here are offering 80 cents a bushel for wheat and predict the price will jump to 90c before the 1933 crop is available.

#### HAD FIGHT IN WOODS

QUESNEL, May 10: (Canadian Press)—One man is in hospital here painfully cut and bruised and with several ribs broken and another is in jail as a result of a battle in the woods in which weapons were a gun barrel and a gun stock. John Leochuk is in the lock-up charged with inflicting "grievous bodily harm." His neighbor, John Isak, is so badly beaten about the face, head and body that he will be many days recuperating. The quarrel is reported to have been the culmination of an old feud.

#### STRIKE IS STILL ON

Four Thousand Gillnetters on Columbia River Are Remaining Idle

ASTORIA, May 10: (Canadian Press)—A meeting called in the futile attempt to end a strike which has kept four thousand gillnetters off the Columbia River since commercial fishing season opened May 1 broke up yesterday in failure. The packers raised their offer from 6c to 6 1/2c per pound for chinook salmon and made other concessions but the fishermen still demanded eight cents and made other demands.

#### SILVER AND COPPER ON NEW YORK MART

NEW YORK, May 10: (Canadian Press)—Bar silver closed at 34 1/4c on the local metal market today, being down 3/8c from yesterday's close. Copper, electrolytic spot and future, closed at 63 1/4c, the same as yesterday.

**Jury, After Over One Hour's Deliberation, Finds Men Guiltless**

they did not exceed a certain time, they might go on. There was no unlawful assembly there but merely a peaceable and orderly gathering. At no stage of the proceedings had the men anticipated or wished trouble. An unfortunate occurrence had brought them into court unfortunate but innocent accused. Mr. Grant submitted that the charges were built up upon the flimsiest of evidence and that the men had not been arrested for participating in a riot but for having been leaders in the strike. They had acted "as men and not as cowards or criminals" and he asked for their acquittal.

**Mr. McGill**  
 The fact of whether or not the strikers had just grounds for complaint, Mr. McGill contended, did not enter into the case. The question was: were their actions of February 3 justified? He submitted that the attitude of Sarich at least was not that of a person trying to give a true picture of the occurrence. If the men were not looking for trouble, why were so many of them carrying weapons and wearing safety helmets? The only reasonable conclusion was that they were deliberately looking for trouble. Sarich, McIver, Montgomery and others, as leaders of the armed mob, therefore, being responsible for the actions arising whether they were at the bridge or beach. Either a demonstration of armed force was considered necessary or the intention was to make trouble, neither of which was lawful.

Did it seem reasonable, after all, that the police, outnumbered as they were by a mob of armed men, should wish to provoke a clash? It had been actually shown that Sanvido had kicked a police officer while he was down. Jurgevic had endeavored to prevent men at the beach from going to work. There was a definite attempt to throw two men off the bridge and, as it was, four officers had sustained injuries. The police, if they used violence, had done so to protect themselves. As soon as they had been able to rescue their comrades from the crowd, they had withdrawn, seeing that they were unable to control the crowd.

As far as the incident at the beach was concerned, if it was intended merely as a peaceful demonstration of solidarity for persuasive purposes, it was not a breach but, if it became a tumultuous disturbance by noise, shouting, blocking the road or intimidation, it might be illegal even if no one were hurt. There was evidence which might convince the jury that the gathering at the beach constituted a riot. It was up to the jury to consider whether the five men individually were aware that the gathering in which they participated or encouraged might become a riot and there was no direct evidence to this effect.

The jury retired at 4:25 and returned to the courtroom at 5:45 with its verdict of acquittal.

**His Lordship**  
 Explaining the law, His Lordship defined a riot as an unlawful assembly which had begun to disturb the peace tumultuously. To constitute an unlawful assembly, it was necessary to prove that there were three or more persons conducting

**EVIDENCE IS HEARD**

Citizens of Smithers Give Testimony in Connection With Trial Of E. C. Dawson

Charles Reid gave information at the E. C. Dawson arson trial at Supreme Court here this morning in regard to financial matters of accused. He said he had been manager of the Royal Bank of Canada at Smithers for 15 years and knew accused a good deal of that time. At the time of the fire he had \$14.06 to his credit at the bank. Accepted drafts were nearly due amounting to \$516.94 and drafts that had been returned amounted to \$598.17. A large number of drafts had been returned unaccepted prior to that month. A number of accused's checks had been returned on account of insufficient funds. Subsequent to the fire he had become a bankrupt.

Oliver Fjested told of refusing accused a loan of \$1,000 shortly before the fire. R. L. Gale, whose office adjoins the building that was burned down, told of the insurance. Prior to September of that year there was \$3,000 on the stock and fixtures. On September 20, just before the fire, he issued a policy for \$5,500. He did this at the request of accused's father.

C. L. Warner stated he was in Dawson's store between 11 and 12 the night prior to the fire. Dawson was oiling the floor and witness remarked: "My God, Ernie, there's lots of oil on the floor."

Mrs. Jenkins of Prince Rupert said she lived in Smithers at the time of the fire. She was returning home the morning of the fire about 1 o'clock and saw Dawson in the store, apparently placing boxes on the shelves.

H. D. Johnston, locomotive engineer, told of going to work about five minutes to five the morning of the fire. He smelled smoke and eventually noticed fire burning on the floor inside the building. He roused Dawson who shouted for him to turn in the alarm. L. B. Warner came along and he showed Warner where the fire was burning and helped with the hose, after which he went to his work.

Warner gave particulars of the work of fighting the fire which appeared to have broken out at several points in the building. Finally he and Percy Davidson were driven downstairs and outside by flames and smoke and the building was ultimately consumed.

Percy Davidson, Smithers fire chief, also described the work of fire fighting. In addition he told of having seen accused at 2:30 on the morning of the fire removing a large carton box from the store to a car which was backed against the front of the store. Davidson was still on the stand when the court adjourned for luncheon.

During the forming of the jury for this case Louis Amadio, H. F. Glassey, Thomas Ballinger, J. F. Filion, Gillis Couture, G. S. Fleming, Fred MacLeod and John Gabriel were stood aside by the crown while W. H. Goodsell, John Curvich, Ernest Campbell, Max Heilbroner and Arthur Brooksbank were challenged by the defence.

All jurors except those engaged in the hearing of this case were excused until 2:15 this afternoon.

In briefly reviewing the evidence which it was proposed by the crown to adduce, L. S. McGill, crown counsel, stated that accused was carrying on the business of a men's furnishings store at Smithers on the ground floor of the building owned by Messner, having his living quarters above. In the month of September, 1930, he was having financial difficulties in his business and a few days before the fire, arrangements had been made to put on considerable additional insurance. During the night preceding the fire accused had been seen in and about the store at different times when the store would ordinarily be closed for business. About 5 a.m. on the morning of September 25 the fire alarm sounded and the store and residence were found to be on fire. Although the alarm brought a considerable number of people who fought to put the flames out, they were unable to do so as, even in the early stages, fire was burning at several different points in the building. Subsequently, accused collected insurance. Evidence would be adduced to show, Mr. McGill stated, that, during the night, John DeVoin, a brother-in-law of accused, had heard Dawson make certain remarks which would show that he (accused) had deliberately burned down the building in order to collect the insurance.

**First Witness**

The first witness was B. F. Messner, owner of the building. Dawson, witness said, had taken a five-year lease on the building in 1927 at a monthly rental of \$60. In September, 1930 he was one month behind in his rent. There was \$2500 insurance on the building which had cost a little better than \$6000. Accused had informed witness that he was desirous of selling out and had parties interested in buying the building as well as the business. Some months after the fire, at the time of which witness was not in Smithers but out on his mining property, the one month's rent less 25% was paid over by accused's lawyer who had the assignment of an insurance policy. Witness described in some detail the nature of the construction of the building, its size, etc. It measured 27 feet, six inches by 48 feet and was on frame construction. Walls and ceiling in the store were of pressed metal. There were two brick chimneys, one going through both floors and the other being on a bracket upstairs. There was a rubberoid roof and asbestos was used in certain parts of the building which had been erected in compliance with the village fire regulations. There were also timber fire steps and four air vents in the ground floor.

Under cross-examination, witness said that the store was usually very tidy, back of the showcases usually being rubbished up while the store room to the rear was usually dirty and untidy with a collection of rubbish including oily clothes, etc.

At 6 p.m. the trial was adjourned until 10:30 this morning.

## FINE STOCK BROUGHT IN

Central Interior Gets 523 Heifers and 70 Pure-Bred Bulls

PRINCE GEORGE, May 10:—Five hundred and twenty-three heifers, brought in under the Free Freight Policy during the past 18 months, have been distributed throughout the district extending from McBride to Smithers. It is conservatively estimated that there will be between three and four hundred calves from this stock during the present season.

The Dominion government, through their Bull Loaning Policy, have distributed over seventy pure bred bulls throughout the same area. The introduction of this good quality breeding stock will tend to improve the quality of the commercial cattle offered to the market. It will also facilitate marketing by having the type of stock required for sale, and prove a real asset to the farmer and to the district in which he lives.

The successful winter feeding demonstration conducted by W. H. R. Low of Telkwa a year ago has resulted in a number of the Central Interior stockmen grain feeding their stock during the winter months. This program of handling beef stock tends to provide a profitable market for the rough feeds, top price for their animals and a minimum of shrink in shipping. It also tends to maintain an orderly system of marketing by distributing shipments of good beef to consuming centres throughout the year.

This portion of British Columbia lends itself readily to a system of mixed farming and the production of high quality products. Dairying, the raising of beef, pork and poultry products, may be carried on successfully on the well managed farm, and provide the settlers with a comfortable living.

For the benefit of the house I wish to state that wheat can be shipped to the Pacific coast more cheaply to Prince Rupert than to any other port on the Pacific coast. I have taken this matter up with the minister and he has given due consideration to seeing that at the next renewal of the lease with the wheat pool a certain amount of wheat shall go through that elevator at Prince Rupert each year. I must, however, challenge his statement that it is unfortunate the elevator is there. I repeat, that it is cheaper to send wheat to Prince Rupert owing to the grade on the Grand Trunk Pacific railway than it is to any other port on the Pacific coast. We have a harbor in Prince Rupert second to none on the Pacific coast from South America right up to Alaska. The minister knows that, and I hope he realizes that as a representative of British Columbia in the federal cabinet he does not represent only one portion of British Columbia but the whole province."
